## Marshall to share in \$150,000 trust fund

Marshall University has been notified that it will share in a trust fund valued at approximately \$150,000, established by the late Mrs. Lillian Morrison Pyle, a member of a prominent Huntington mercantile family.

In her will, Mrs. Pyle called for the creation of the C. M. Morrison Family Memorial Trust Fund in memory of her parents, C. M. and Marie Morrison, and her brothers, Darrell D. and Donald B. Morrison.

The Marshall University Foundation is one of five beneficiaries who will share the proceeds from the trust fund which is composed primarily of income producing government bonds.

A 1930 graduate of Marshall, Mrs. Pyle had been active in alumni activities for many years prior to her death in March, 1977.

In the early 1900s, her father, C. M. Morrison, opened a drygoods store, C. M. Morrison and Co., which he ran for many years at 20th Street and Eighth Avenue. Later Mrs. Pyle's brother, Donald B. Morrison, established the C. M. Morrison and Son stores, one in Guyandotte and one at West Fourteenth Street.

"We have already received our first check for \$1,000 from the trust fund which will be applied to the 'University's Greatest Needs' account," said Dr. Bernard Queen, MU Foundation head and director of development.

The trust fund is expected to yield a similar amount annually for the university, according to Paul T. Farrell, assistant trust officer at the First Huntington National Bank. Arrangements for the memorial fund were handled by the bank and O. Jennings Rife, attorney for Mrs. Pyle's estate.

"Mrs. Pyle's gift came as a very pleasant surprise to the Foundation and we are extremely grateful that her interest in Marshall led to this bequest," Queen added.

## Campus gallery is site of faculty art exhibition

An exhibit of art work by members of the Marshall University Art Department is under way in the MU Student Art Gallery, located in Smith Hall.

The exhibit will continue through February 15, and may be viewed weekdays from noon to 4 p.m., according to Mrs. June Kilgore, MU associate professor of art and departmental chairman.

The show includes a wide variety of art forms, including photographs, textiles, paintings, drawings, illustrations, prints, ceramics and sculpture.

Faculty members represented in the show in addition to Mrs. Kilgore are Earline Allen, William F. Brown, Frederick Burkett, Michael Cornfeld, Alice Ertresvaag, Robert P. Hutton, and Beverly Twitchell, all assistant professors of art.

## Award-winning 'Cabaret' to be spring production

The award winning musical "Cabaret" will be presented by Marshall University Theater and the Music Department as their annual spring production, Dr. Elaine A. Novak, professor of speech and University Theater director, has announced.

"Cabaret" won eight Tony Awards, including one for Best Musical, when it opened on Broadway in 1966. Based on the 1951 Broadway hit play "I Am a Camera," which starred Julie Harris, "Cabaret" is set in Berlin around 1929-30, just as Hitler was rising to power.

Directing the production, which opens a five-day run on April 25, will be Dr. Novak, general director, and J.D. Folsom, MU assistant professor of music, musical director. Bruce Greenwood, Marshall's technical director, will be in charge of set design and technical effects.

## Calendar for Fall 1979 discussed by committee

The Academic Planning and Standards Committee met on Dec. 7 and 12 to discuss the following major items:

1. The University Planning Council's Draft Statement of Marshall University's Role and Scope, 1979-84, was distributed and minor revisions were suggested.

2. The Fall, 1979, Calendar was discussed with regard to eliminating study days. It became clear during the discussion that most universities have no such provision for study time during exam week and that both faculty and students abuse Marshall's schedule as it is now established. Some faculty, in violation of the **Greenbook**, give their final exams during the last week of classes or at other unscheduled times. Large numbers of students do not use the study days for studying. The library is not used, and the rate of vandalism is reported to increase in the dorms at this time.

Despite these problems and possible abuses, the Committee recommended retaining the study day. It also suggested realigning the Calendar to eliminate the one class day during exam week by making Friday of the previous week the last class day for all except Monday evening classes. The study day would then fall on a Wednesday in the middle of a full week of exams.

3. Because of lack of time, further discussion of the C/NC option was postponed until the next regularly scheduled meeting on Jan. 18.

4. On Dec. 12 the Committee reviewed and approved a proposal to establish a Master of Science in Accounting degree.

## Death claims Stewart Allen, former campus administrator

Word has been received of the death last month in Texas of Dr. J. Stewart Allen, who served as vice president for academic affairs at Marshall from September, 1965 to July, 1967.

Allen, 57, was dean of the College of Humanities at Sam Houston State University, Huntsville, Texas, at the time of his death. A former executive director of the Association of Texas Colleges and Universities, Allen had been confined to Huntsville and Houston hospitals since suffering an apparent heart attack in October.

He is survived by his wife, Norma McKinney Allen (225 Willowbend, Huntsville, Texas 77340), and his two daughters.
