Marshall's Department of Chemistry recently received a \$1,500 grant-in-aid from the Spectroscopy Society of Pittsburgh. The funds are to be used for the purchase of undergraduate laboratory equipment. Dr. R. M. Chakrabarty, MU professor of chemistry, represented the department at the awards ceremony on Dec. 14 in Pittsburgh.

Catlettsburg, Ky., has been named to the position, effective Jan. 16. He succeeds John R. Jamieson, who resigned several months ago.

Faculty and other members of the university community are invited to attend the open house, Deel said. "This will give students, faculty and staff an opportunity to meet Mr. Cox, as well as several other new members of the Computer Center staff," Deel noted.

Cox has been systems engineer with Ashland Oil, Inc. He has held several data processing positions with the firm since 1972.

A veteran of five years of service as a U.S. Army officer, he holds an A.B. degree in political science and an M.S. degree in computer science from West Virginia University. He worked as a computer programmer while a graduate student at WVU.

Grad Council reports fall semester actions

Graduate Council action during the first semester:

The Council has spent time implementing the change made last spring which requires Council action on associate graduate faculty renewal requests. A special effort has been made to remind departments that appropriate action must be taken for each person teaching graduate courses.

The president has approved another change in the Greenbook provisions relating to graduate faculty. The Council had recommended to him the deletion of those provisions which required a review every five years of faculty holding full graduate faculty status. This year, 154 faculty would have been subject to the review if the deletion had not occurred.

Departments requesting course changes and additions during the first semester included mathematics, biological science, physics and physical science, anatomy, computer sciences, physiology, history, art and psychology.
