Scholarship honors Houvouras brothers

A scholarship honoring four brothers who immigrated to America from Greece in the late 1800s and early 1900s has been endowed at Marshall University by members of their family.

The Houvouras Scholarship Fund was established in memory of Nick, Andy, Pete and Tom Houvouras, according to Dr. Keith L. Scott, Marshall vice president for institutional advancement.

Each of the Houvouras brothers was 16 years of age when he journeyed from Sparta to America, seeking a better way of life. The oldest brother, Nick, arrived in the United States in 1895. He was followed by Andy in 1899, Pete in 1904 and Tom in 1908. All of the brothers settled in Huntington though Pete eventually moved to Springfield, Ohio.

Nick, a real estate investor, was elected in 1918 to the West Virginia House of Delegates and later served as a Cabell County justice of the peace in the early 1950s.

Andy and Tom worked in the restaurant business for more than 50 years. They were active in civic affairs and ardent supporters of the Marshall athletic programs.

Retired Huntington businessman Andrew J. Houvouras Jr. and his wife, Pat, and his cousin, Dr. E. Ted Houvouras of Lexington, Mass., funded the \$40,000 endowment. Andrew Jr. is the son of Andy and Louise Houvouras. Ted is the son of Nick and Sophia Houvouras.

Andrew Houvouras Jr., a 1937 graduate of St. Joseph's High School in Huntington and a 1942 Marshall chemistry graduate, was a founder and co-owner of Huntington Plating, Inc. He now is retired.

Ted Houvouras, the valedictorian of the Huntington High School class of 1941, graduated summa cum laude from West Virginia University. He earned his master's degree and his Ph.D. degree in chemical engineering from the University of Illinois. He worked with the E.I. DuPont de Nemours & Co. prior to retiring.

The scholarship is not an athletic or an academic scholarship, according to Andrew Houvouras Jr. "It is based on financial need for a young man or woman who truly hungers for an education."

Marshall President Dale F. Nitzschke commented on the scholarship: "It is most appropriate that the Houvouras family has established a scholarship to honor their forebears who sought opportunities in a new land. Their gift will provide opportunities to Marshall students for generations to come."

Dr. Scott said the gift will be invested and the interest will be used for the scholarship.

Gilbert, chairman of the board of Gilbert Imported Hardwoods, Inc. and subsidiaries, and Nathaniel "Nate" Ruffin of Huntington, regional director of personnel for Gannett East and the Huntington Herald-Dispatch.



They succeed David N. Harris of Nate Ruffin Huntington and Mrs. Sandra Wilkerson of St. Albans, whose terms on the board have expired.

"We're very pleased that individuals of the caliber of Nate Ruffin and Buck Harless have agreed to serve on Marshall's Institutional Board of Advisors," Nitzschke said. "The Board of Advisors has a key role in building Marshall's future and I'm certain both of these men will make strong contributions to the work of the board-and the success of Marshall University."

Dr. Vickers has been listed in "Who's Who in American Colleges and Universities" and has been the recipient of a Distinguished Service Award from the College of Agriculture and Home Economics at Ohio State University.

was not with the 1970 football team on its ill-fated trip to East Carolina University. The team's plane crashed near Tri-State Airport on the return journey, killing all 75 people aboard. Ruffin has had a prominent part in memorializing his teammates in the years since 1970.

He received his B.A. degree from Marshall in 1973 and worked with ACF Industries, Inc. in Huntington from 1973 to 1985. He was personnel administrator with ACF for seven years prior to joining the Herald-Dispatch in 1985.

He serves as chairman of the board of directors of the Tri-State Chapter of the National Management Association and is a member of the American Society of Personnel Administrators, the Huntington Charter Review Board, the Huntington Civic Center's board of directors, Scott Community Center's board of directors, the United Way Personnel Committee and the National Newspaper Personnel Relations Association.

He also is chairman of the City of Huntington Affirmative Action Advisory Board and is a former member of the Marshall University Alumni Association's board of directors. He was coordinator of activities observing the Martin Luther King Jr. Day holiday in Huntington during its first two years.

Holidays

Holidays: Ms. Rickman distributed a letter from Lynne Mayer, director of plan-ning, to Board of Regents Vice Chancellor Edward Grose, regarding the forthcoming changes in the BOR's holiday policy. Effective July 1, 1988, all state universities and colleges will schedule on a fiscal year calendar. Since Marshall has scheduled on an academic calendar, there will has a transition paried from 1/1/87 to 6/30/88. A total

calendar, there will be a transition period from 1/1/87 to 6/30/88. A total of 19 holidays will be observed during this period. Thereafter, a total of 13 holidays will be permitted each fiscal year. Layoff Program:

Because of the budget cuts for the next fiscal year, there is speculation concerning possible layoffs of support staff. Ms. Rickman reported that MU President Dale F. Nitzschke discussed this possibility with his cabinet and requested that Paul Michaud, Queen Foreman and representatives of classified staff meet to prepare a draft of proper procedures to be followed in the event layoffs occur.

Specific guidelines will be set up and programs will be offered for those requiring assistance.

Election Update:

A lengthy discussion was held concerning the election for Staff Council membership. Ms. Rickman distributed copies of a petition which had been circulated calling for the election to be declared void and another election held because of claimed irregularities.

Ms. Rickman said that only the president could declare the election void and approve a second election. After discussion, a motion to table the issue until a meeting with the president could be held was passed. Other Business:

Ken Reffeitt reported on the latest meeting of the BOR Advisory Council of Classified Staff and circulated a synopsis of the meeting. Nina Barrett, chairwoman of the Membership Committee, reported

that the Financial Affairs representative status has changed from an at-large division to a group division.

At the time the new system was established, Financial Affairs had 42 people. They now have 66 people. Since the cutoff is 50, beginning with the 1988 election, Financial Affairs must elect a professional person since they now have 16 professionals (enough for a group). Financial Affairs is now entitled to two office personnel representatives and one professional representative.

Jane Vickers pointed out that Ann Henson of the Health Science Library is without representation. Ms. Henson was in the division of Academic Affairs, but was subsequently moved to the School of Medicine. Since she holds a technical position she has no representation.

In discussing the events that transpired regarding Ms. Henson's reclassification, Ms. Barrett agreed that the Membership Committee was in error. Ms. Henson will be asked to write a letter to the committee requesting that she be put in a group where she will have representation. Upon receipt of the letter, the Membership Committee will meet and resolve the matter.

The meeting was adjourned at 2:45 p.m.

The Giordano Technique, a specific jazz form, is used throughout the world and is known for surprise movements and regal positioning of the head and torso.

Ms. Giordano, a faculty member of the Gus Giordano Dance Center in Chicago, has toured internationally and been a guest teacher in France and Montreal.

She has performed in several Public Broadcasting specials and has appeared on network television.
