#### John Mead awarded NEH summer stipend

Dr. John H. Mead, associate professor of music at Marshall University, has been offered a \$2,500 summer research grant by the National Endowment for the Humanities (NEH), according to Dr. Paul D. Stewart, Graduate School dean.

Mead submitted a proposal to the NEH for research involving the study of logs and journals of 19th Century sailing ships to discover verse and songs in order to update and expand a compilation of whaling songs prepared by Gale Huntington.

Huntington's research, published in 1964, is the only work of this nature that has been done, according to Mead, currently on a leave of absence from Marshall studying in

London.

"This is quite an honor for Marshall," Stewart said. "Dr. Mead's summer stipend may be the first that NEH has given to a Marshall faculty member. Only about one out of every eight proposals submitted to NEH are funded," he added.

# FCOC to provide student health care

Steps have been taken to integrate Marshall University's Student Health Service with Family Care Outpatient Clinic (FCOC), a teaching affiliate of the MU School of Medicine, according to Dr. Olen E. Jones Jr., MU executive vice president.

FCOC will assume the responsibility for student medical services on July 1 with emergency services expected to be continued to be provided under an agreement with Cabell Huntington Hospital.

"We believe this move will provide more comprehensive medical services for our students," Jones said.

### Report of regents faculty advisory council

At its March meeting the Faculty Advisory Council of the West Virginia Board of Regents considered the following items

1. The Chancellor touched on the following matters in his

report to the Council:

(1) The budget picture continues to look bleak. However, for what it is worth, the House subcommittee on Higher Education has worked hard and is under-

(2) House Bill 1156 (passed on March 14), which relates to composition, terms and qualifications of members of the Board of Regents, grants voting privileges to the chairpersons of the Faculty Advisory Council and the Advisory Council of Students. It becomes effective 90 days after passage.

(3) The Academic Affairs Committee of the BOR, aided by the Chancellor's staff, is preparing a procedure for program review. The report of the Committee will be ready by May and the review will begin probably in the fall. The major focus will be on relatively new programs (3-5 years old) and on teacher education.

The Plan for Progress needs updating. The Chancellor favors a deductive approach, i.e., re-evaluate statewide goals and aspirations and then fit the state's institu-

2. The Council voted to present to the Council of Presidents for discussion at our joint meeting with them in April the following revision of paragraph 2 in Policy Bulletin No. 40 (Delegation of Certain Personnel Authority and Responsibility to Presidents):

"Each President is expected to consult appropriately within the campus community on personnel decisions and

seriously take into account all such inputs."

Please see remarks (\*) at the end of this report.

3. The committee comparing faculty salaries in West Virginia with those in border states has hit snags. Ohio refuses to provide data. Pennsylvania sent the wrong data and is now footdragging. However, the committee has not given up.

Included among agenda items for the joint meeting with the Council of Presidents are the following: 1) guidelines for salary increments, 2) summer school funding, and

\*I need your guidance on the question of whether to seek further revision of PB40 at this time. My inclination is to postpone further tampering with it for a time. The present policy bulletin (approved by the BOR last May) represented a substantial improvement over the one it replaced (dated August 13, 1974). This latest draft does not, in my opinion, represent a substantial change. Moreover, I think we would run the risk of being labeled quibblers if we were to propose this change in paragraph 2 to the BOR and nothing more. Authority regarding tenure is the only remaining issue of vital importance to faculty that needs dealing with, in my view, and timing could be of critical importance in the dealing. I do not see now as being a desirable time to seek a confrontation with the Board on tenure. I hope a large number of you will take a close look at PB40 in the GREENBOOK and then pass your views on to me by memo or phone.
