MU receives funds for special education

A \$60,000 grant has been awarded to Marshall University's Special Education Program by the U.S. Office of Education, Dr. Daryll Bauer, MU associate professor and program director, announced.

The grant reflects a \$9,000 increase over the federal support the program received last year, according to Bauer. "We find this aspect especially gratifying, since federal funding in this area is on a decrease generally," he said.

The funds will be used for staff development and student aid,

Earlier this summer, Marshall's Special Education Program received a \$5,000 West Virginia State Department of Education grant for a summer project involving children with learning disabilities.

This grant was the first of its kind awarded by the state to a project in the learning disabilities area, Bauer said.

The project, coordinated by Dr. Barbara Guyer, MU assistant professor of special edcuation, provided individualized instruction in language skills and mathematics for some 40 children with diagnosed learning disabilities.

The five-week, free program drew children from Cabell, Wayne and Mason counties in West Virginia, Lawrence County, Ohio, and Boyd County, Ky.

Board requests 1975 claims be filed


The Public Employees Insurance Board has requested the following information be shared with all employees:

"According to policy provision (Handbook page 46), written proof of claim must be submitted to the Equitable Claims Office within 90 days after the date of loss for which a claim is being filed. This does not mean that a claim which is not submitted within 90 days will not be denied. As you may know, we have continued to process these claims and will continue to do so with the following exception:

All claims for the period April 1, 1975, through Dec. 31, 1975, must be submitted to the Equitable Claims Office no later than Aug. 31, 1977. After that date no claims for the period April through December 1975 will be processed unless it is proven impossible to submit the claim before that date."

Textbook discount plan effective Aug. 1

Students attending Marshall University this fall will receive a 5 per cent discount on textbooks purchased through the University Bookstore, Dr. Richard G. Fisher, vice presidentdean for student affairs, has announced. The discounts will go into effect Monday, Aug. 1.

Fisher said the discount program was being initiated as a result of discussions among Student Body President Rick Ramell, Student Vice President Ginger Farmer, MU Vice President for Administration Karl J. Egnatoff and himself.

Fisher said he and the student leaders have scheduled discussions with various administrative officials to explore new programs and services which might be adopted for the benefit of the students. Announcement of another new service is expected within a week, Fisher said.

Egnatoff and Fisher said the program of textbook discounts will be evaluated during the fall and spring terms and continuation of the discounts will be considered next spring.
