Singh named chairman

Dr. Dayal Singh, professor of finance and business law at Marshall University, has been named chairman of the university's Finance and Business Law Department, according to Dr. Robert P. Alexander, dean of the College of Business.

Singh received his bachelor of law degree from Rangoon (Burma) University and his master's degree and doctoral degree in business administration from Indiana University.

Prior to joining the Marshall faculty in 1974, Singh served as an assistant professor at Texas Southern University and an associate professor at California State University, Chico.

Computer security to be seminar topic

"Computer Security" will be the topic of a business seminar on Thursday, Oct. 18, from 6 to 9:30 p.m. in the Marshall University Research and Economic Develop-

ment Center, 1050 Fourth Avenue.

According to Elias Majdalani, assistant professor of Computer and Information Sciences at Marshall University and presenter of the Computer Security Seminar, many computer systems may be at risk from users who inadvertently fail to install and manage the system

adequately.

The seminar is designed to provide guidelines to assist business owners and managers in developing their own security program or improving existing computer control measures. A free anti-virus computer disk will be distributed to all seminar participants. The seminar registration fee is \$120 per person. Marshall University students will be given a reduced rate.

The program is being sponsored by the Marshall University College of Business, the Small Business Development Center and the Governor's Office of Com-

munity and Industrial Development.

Recognized throughout the United States, Dr. Brothers is a columnist, author, business consultant, mother and news commentator for ABC-TV in New York and CBS-

TV in Los Angeles.

She also creates and performs in films and seminars designed for corporate training programs and writes a daily column which is published in more than 350 newspapers. Her books have been translated into 26 languages.

For the past eight years she has been listed in the Gallup Poll of "most admired women" and the Greenwich College Research Center has listed her among the 10

women most admired by college students.

Her presentation at Marshall is being sponsored by the university's Campus Entertainment Unlimited Office.

Academic merit will be determined by grade point average and Graduate Record Examination scores. Students must list their GRE scores in order to be eligible for consideration.

Up to three hours of waivers for graduate course work

will be awarded to qualified applicants.

Students interested in being considered for a Board of Trustees tuition waiver based on financial need criteria should contact the Graduate School to obtain the Proper application procedures.

Students who previously held waivers must reapply to

be considered for spring semester waivers.

Approved waivers can be picked up beginning Friday, Nov. 30.

Any awarded waivers not claimed by Dec. 14 will be assigned to other qualified applicants.
