## Employes to pick up checks next week

Payday will be a little different next week.

Joseph C. Peters, vice president for business affairs, said representatives of the Legislative Auditor's Office currently are on campus, conducting a regular audit. As part of the auditing process, each employee on the regular Marshall University payroll will be handed his next paycheck by one of the auditors. Hourly employees will not be affected at this time.

Here is the schedule:

On Wednesday, April 14, the auditors will be in the Maintenance Building from 7 p.m. to 7:30 p.m. to pass out checks to members of the night shift of the Building and Grounds staff.

On Thursday, April 15, from 7:30 a.m. to 8:30 a.m., the auditors again will be in the Maintenance Building to hand out checks to the Buildings and Grounds day shift personnel.

Also on Thursday, April 15, from 9 a.m. to 4 p.m., the auditors will be in Room 2W22 of Memorial Student Center to distribute checks to the remainder of the university's employees. Three tables will be set up under an alphabetical system to facilitate the distribution.

Each employee will be asked to sign a statement verifying that it is his or her check being picked up.

Those who do not pick up their checks during the scheduled period will be able to receive them later in the auditors' office in the Payroll Division, Old Main 207.

#### SEASONAL NOTE

The following is the Marshall University policy on political activities as stated in the 1975-76 Greenbook:

It is consistant with the interests of the university that members of the staff be permitted to participate in the political and governmental activities of the community, under conditions which assure that the university will not become directly involved in any political activities or suffer from undue diversion of the interests of its employees. Therefore, the following considerations govern political activity;

No employee may use or attempt to use his official authority or position in the university directly or indirectly:

1. To affect the nomination or election of any candidate for any political office.

2. To affect the voting or political affiliation of any other employee of the university or any student.

3. To cause any other university employee or student to contribute time and money, whether as payment, loan or gift, to support a political organization or cause.

University employees may not engage in political activity while on university property, while on duty for the university, or while traveling on behalf of the university. "Political activity" is defined as active participation in political management or in political campaigns or knowlingly attempting to use official position or influence to promote the success or defeat of a political party or candidate in an election.

Dr. John L. Martin, former chairman of the Department of Modern Languages, died Tuesday after a brief illness.

Funeral services were held today (Friday) at 1 p.m. at Klingel-Carpenter Mortuary. Burial was to be in Woodmere Memorial Park.

A member of the Marshall Spanish faculty since 1935, Dr. Martin retired as departmental chairman July 31, 1975, a position he held since 1967.

Born in Huntington in 1911, Dr. Martin earned his bachelor degree from Marshall, his masters from the University of Kentucky and the doctorate from the University of Pittsburgh.

A member of the Beverly Hills United Methodist Church, he was listed in the directory of American Society and Who's Who in America.

He is survived by his wife, Mary Lee Drown Martin, 21
