## Employee insurance seminars scheduled

A representative from the West Virginia Public Employees Insurance Board will conduct four special seminars at Marshall on Tuesday, Sept. 7, in Old Main Auditorium, according to Roger Hesson, director of employee benefits.

The seminars are scheduled to be presented at 10 a.m., 11 a.m., 1 p.m., and again at 2 p.m., Hesson said.

The seminars were set up for informational purposes, he added. The representative will explain and answer questions on the new optional group life and accidental death and dismemberment insurance for state employees.

The president's Orientation Dinner for new faculty is scheduled to begin at 6:30 p.m. with a social period in the Alumni Lounge of the Student Center. Dinner will follow at 7 p.m. in the Special Dining Room. Senior administrators will be introduced and Dr. Hayes will speak briefly.

### **Grade posting prohibited**

To comply with the regulations of the "Privacy Act of 1974" (Public Law 93-579 of the U.S. Congress), faculty members are required not to post grades of students. The Act prohibits disclosure of any records "from which information is retrieved by the name of the individual or by some identifying number, symbol, or other identifying particular assigned to the individual.

The optional insurance will become effective Oct. 1 in amounts of \$5,000, \$10,000 or \$20,000. The monthly premiums are based on the age of the employee.

All active employees who are presently insured for our Basic Group Insurance Plan are eligible to participate in the plan on Oct. 1, Hesson said.

University employees are urged to attend one of the four sessions.

## Foundations contribute funds to medical efforts

"It's a fantastic day for Marshall. . ."

That was the reaction from Marshall President Robert B. Hayes Monday, Aug. 16, after two major foundations announded gifts totaling \$350,000 to Family Care Outpatient Center, an affiliate of Marshall's School of Medicine.

Paul R. Jenkins, executive vice president of the Claude Worthington Benedum Foundation, announced a \$250,000 grant has been approved by that organization. Following his announcement, Harold E. Burdick, president and publisher of the Huntington Publishing Co. newspapers, reported a \$100,000 contribution from the Frank E. Gannett Newspaper Foundation. The Huntington newspapers are members of the Gannett Co., Inc., which publishes more than 50 newspapers throughout the country.

The Benedum contribution is the largest single gift in Marshall's history, Hayes noted, and the Gannett donation brings to \$280,000 the amount given to Marshall by that foundation over the past three years.

The announcements preceded an address by U.S. Senator Jennings Randolph, D-W.Va., at a combined luncheon meeting of the Huntington Kiwanis and Rotary clubs held in Marshall's Memorial Student Center. Also attending were representatives of other community service clubs, as well as a number of interested individuals.

Senator Randolph spoke on "Health Care Resources for Tomorrow," touching upon the role of the Marshall Medical School in providing for the state's medical manpower needs. The senator long has been identified as one of the key supporters in the establishment of the Marshall Medical School. He also is a member of the Board of Trustees of the Benedum Foundation.

The announcements by the Benedum and Gannett foundations bring to \$650,000 the amount raised in the effort to develop Family Care Outpatient Center as an integral element of the Marshall Medical School. Earlier, Ashland Oil, Inc., and Huntington Alloys, Inc., each announced \$150,000 contributions to the project.

Both Benedum and Gannett have given generous support to a number of worthwhile projects in the state and the region, Hayes noted.

## Local bank offers AAUP salary plan

The First Huntington National Bank will handle the American Association of University Professors (AAUP) Salary Redistribution Plan again this year.

It will be the only bank offering this service to the Marshall

faculty.

The AAUP Salary Redistribution Plan distributes the income of nine-month faculty members over a 12-month period. This is done by depositing a designated amount of your pay in your Regular Checking Account and depositing the remainder into a Regular Savings Account in your name.

### New forms necessary

Departments and offices mailing out materials under the U.S. Postal Service's bulk mailing rate are asked to obtain NEW 3602 forms (bulk mailing permit) from the university mail room.

If mailings are made with the old forms, you face the possibility of having the materials returned by the Post Office, according to Linda Hysell, mail room clerk.

The amount accumulated in the savings account is credited back to your Checking Account during the summer months in three equal installments on June 15, July 15 and Aug. 15.

In addition to receiving interest on your Regular Savings Account at the prevailing rate (currently 5% compounded daily), you also will have the activity service charges waived on your Checking Account.

If you wish to begin with the Aug. 31 paycheck, fill out the required authorization forms available in the Payroll Office. It is important that you complete these authorizations by Aug. 24, and return them to Roger Hesson in the Payroll Office. It is possible, however, to enroll in the plan at a later date if you wish.

# Charles Dickerson named associate dean

Charles Edward Dickerson II has been named associate dean of students at Marshall University.

The appointment was effective Aug. 16.

Dickerson, a 33-year-old native of Pennsylvania, comes to Marshall from Dartmouth College, where he served as assistant vice president for student affairs.

Dickerson will be responsible primarily for Marshall's minority student program, will work with student organizations and assist with the student information program, the dean said.

He earned his A.B. degree from Lincoln University and did graduate work in African Studies at Boston University before receiving his Master's degree from the University of Rochester.

Dickerson is a doctoral degree candidate at the University of Rochester.

Before joining the Dartmouth staff in 1973, where he also was a history lecturer, Dickerson was assistant professor of history for three years at Lincoln University.

While a student at the University of Rochester, Dickerson founded and served as vice chairman of the College Admissions Preparatory Program (CAPP). CAPP is a University of Rochester Community private corporation to academically prepare minority student for college.
