Insurance enrollment 'open'

For those employees who did not enroll, or who did not enroll their dependents, during the original period of eligibility for enrollment last year, the Public Employees Insurance Board is offering the month of January, 1974, as an open enrollment period.

The announcement was made by Joseph C. Peters, vice president for business affairs.

Employees who choose to avail themselves of the opportunity to enroll themselves, or their dependents,

during this month may do so without a medical examination, provided they have not previously been denied coverage for medical reasons under the Public Employees Insurance plan.

For those who enroll this month, the insurance coverage will become effective February 1, 1974.

Library given \$10,000 volume

Marshall University's James E. Morrow Library has been presented a volume worth approximately \$10,000 by a man who once stacked books in the library to earn money for his college expenses.

The gift, a Shakespeare Fourth Folio printed in London in 1685, was presented by G. Worthington Hipple, who also waited tables in the school cafeteria to supplement his football scholarship at Marshall more than 40 years ago.

Announcement of the gift was made by Marshall President John G. Barker. The university has insured the volume for \$10,000.

Dr. Kenneth T. Slack, director of libraries, said the book will be housed in the library's Shakespeare Room after a suitable display case has been obtained. Meanwhile, it is being kept in a locked safe. Dr. Slack said the university will arrange an official presentation ceremony at a later date when Hipple will be able to attend.

Hipple, who lives in McLean, Va., is a well-known lecturer and market consultant. He currently is retained as a consultant to the Fedders Corporation. He is the twin brother of actor Hugh Marlowe.

Hipple came to Marshall in 1932 as a football player after making the All-City team at end for Chicago's Senn High School. He said he came here at the suggestion of Juan Fors, who had joined the Marshall faculty after teaching the previous year in Chicago. Mr. Fors, who died in early 1972, remained at Marshall for 35 years and served as professor and chairman of the Spanish Department.

Hipple remained less than a year however, moving on to play for the Northwestern University football team the following season. He said he transferred to Northwestern because it was close to his home in Chicago and because of economic conditions during that Depression era.

A collector of rare books for many years, he obtained the Shakespeare Fourth Folio in 1957 from a New York book dealer.

The volume is entitled "Mr. William Shakespeare's

Comedies, Histories, And Tragedies...Unto which is added Seven Plays never before printed in folio." It measures slightly over nine inches by 14 inches.

Dr. Slack expressed delight with the new acquisition. "This folio will join the Globe Theater model as the outstanding features of our Shakespeare Room," he noted. "It also will provide a new dimension and additional prestige to a library which rapidly is becoming a source of pride to the university."

Mrs. Gebhart named assistant registrar

Mrs. Patricia L. Gebhart of Athens, Ohio, has been appointed assistant registrar at Marshall University, Registrar Robert H. Eddins announced. She succeeds J. Jeffrey Robison who resigned last summer to accept a similar position at Ohio State University.

Mrs. Gebhart's appointment was effective Jan. 1.

She received her B.F.A. degree in music education from Ohio University in 1968 and her M.Ed. degree in student personnel services from the same university last summer. She has served as a graduate assistant and pre-college counselor at Ohio U.

Mrs. Gebhart was a member of Mortar Board, senior women's honorary, while a student at Ohio University, and served as president of Phi Mu social sorority. She also was a member of the music and education honorary organizations.

Health premiums are deductible

Robert H. Slack, acting executive secretary of the West Virginia Public Employees Insurance Board, has issued guidelines for reporting health insurance premiums for income tax purposes. This affects Marshall personnel enrolled in the Public Employees Insurance plan who itemize deductions in filing their income tax returns.

The guidelines:

The amount of premium paid for health insurance from January through June 1973 may be broken down as follows:

Employee under age 65 with single coverage - \$5.67 per month

Employee and spouse under 65 with family coverage - \$13.49 per month

Employee under 65 and spouse over 65 with family coverage - \$7.47 per month

Employee over 65 with single coverage - \$1.80 per month Employee and spouse over 65 with family coverage - \$3.60 per month

Employee over 65 and spouse under 65 with family coverage - \$9.62 per month.

Corman assigned med school task

Dr. Charles D. Corman, associate dean of the College of Arts and Sciences, has been given a full-time assignment by President John G. Barker to spearhead the preparation of Marshall's application for a medical school which would be established in cooperation with the Veterans Administration.

In his new assignment, Dr. Corman will work with Dr. William K. Easley, vice president for academic affairs; the Marshall Medical School Advisory Committee; federal and state officials, and others concerned with the development of a medical school here.

Marshall is considered one of the leading contenders to beselected as the site of one of several medical schools authorized by Congress. The schools will be located in communities which have both a state university and a Veterans Administration Hospital. The schools will be supported largely with federal funds in their first years of existence.

The amount of premium for life insurance may be broken down as follows:

January through June 1973 - \$.34 per \$1,000 of life insurance paid by the employer

\$.15 per \$1,000 of life insurance paid by the employee; July through September 1973 - \$.32 per \$1,000 of life insurance paid by the employer, and

\$.14 per \$1,000 of life insurance paid by the employee; October through December 1973 - \$.29 per \$1,000 of life insurance paid by the employer, and

\$.13 per \$1,000 of life insurance paid by the employee.
