Forward MU funds allocated

President John G. Barker last week announced plans for the allocation of more than \$160,000 in cash gifts to the Forward Marshall fund-raising campaign.

The three-year campaign was launched last July 24 and thus far has realized \$438,000 in cash and pledges. Last week's announcement of allocations involves only the cash gifts of \$162,797 which have been received.

Other allocations will be announced in the succeeding two years as pledges are redeemed and additional cash gifts are received.

This year's allocations are as follows:

Scholarships for students-\$39,465.

Distinguished lectureships--\$23,021.

College of Business and Applied Science improvements-\$68,080.

Oral History of Appalachia project-\$14,635.

Area-wide workshop in economics education--\$3,500.

"Where the needs are greatest" fund-\$14,096.

Dr. Barker said he was "extremely pleased" with the response area residents, Marshall alumni and business firms have given the Forward Marshall campaign. The three-year goal is \$495,000. "I'm convinced we'll exceed the goal by a substantial margin," Dr. Barker said.

Recital planned tonight

Loemker, Mrs. Buskirk honored

A student loan fund honoring two retired members of the Marshall University faculty and staff is being established through the efforts of a prominent Texas educator, Marshall President John G. Barker announced.

The fund is being established by Dr. Alfred R. Neumann, chancellor of the new University of Houston at Clear Lake City. Dr. Neumann is a 1940 graduate of Marshall.

It is being named in honor of Dr. Kenneth K. Loemker, retired professor of psychology, and Mrs. Lillian H. Buskirk, retired associate dean of students.

In sending a cash gift to initiate the Lillian Buskirk and Kenneth Loemker Student Loan Fund, Dr. Neumann wrote, "I shall in the coming weeks start writing to some of my classmates who might wish to join me in honoring these two wonderful people who did so much for so many students."

Mrs. Buskirk, who received her A.B. degree from Marshall in 1928, served on the Marshall staff from 1937 until her retirement, June 30, 1970. During most of those 33 years, she was dean of women.

Dr. Loemker joined the Marshall faculty in 1930 and remained until his retirement May 31, 1971, with the exception of a period of military leave, 1944-46.

Dr. Neumann, a refugee from Nazi Germany, came to the United States in 1937 and entered Marshall that summer. He received his A.B. degree in 1940. He was awarded an honorary Doctor of Laws degree by Marshall in 1964.

Administrative change is announced

Operation of the Marshall University Registrar's Office is being placed under the administrative supervision of the Office of Student Affairs. The operation formerly was supervised by the Office of Academic Affairs.

Announcement of the administrative realignment was made Thursday by Dr. William K. Easley, vice president for academic affairs, and by Dr. Richard G. Mund, vice president for student affairs.

Factors cited for the administrative change include establishment of a unified student data base, improvement in internal transmission of information between offices by centralizing the sources, and simplification of the records-

Following is a summary of the Jan. 24 meeting of the Academic Planning and Standards Committee, as reported by Dr. Robert P. Alexander, chairman. Committee actions are submitted to the president as recommendations.

At the Academic Planning and Standards meeting on January 24, 1974, the committee approved Stage One of the Sub-Committee Report on Computer Science Education. Stage One recommended certain basic computer science courses.

The committee also approved certain catalog changes in the College of Arts & Sciences relating to minor fields of study and utilization of Science 109-110 to meet certain basic science requirements.

PF&P Committee actions reported

Following is a summary of the Jan. 24 meeting of the Physical Facilities and Planning Committee, as reported by Dr. Sara E. Anderson, secretary. Committee actions are submitted to the president as recommendations.

A letter from President Barker concerning the need for guidelines for evaluating proposals and location of statuary, class gifts and memorials of various types was read. The committee agreed that a subcommittee should be appointed to make recommendations to the committee for further consideration. Chairman Howard Mills appointed the following subcommittee to report at the next meeting of the committee: Mr. Soto, chairman, and Dr. Blankenship and Mr. Bruni.

Letters from Dr. Hicks and Dr. Railey requesting the space formerly occupied by the Health Center in Gullickson Hall were read and discussed. A motion was approved asking Dr. Hicks and Dr. Railey to attend the next meeting of the committee (Feb. 5 at 11 a.m.) and to present requests for the space in terms of the total long-term needs of the Physical Education program. Other requests for this space formerly assigned to the Health Center may be sent to Secretary Sara E. Anderson before Feb. 4.

"This will bring under one umbrella the closely-allied functions of admissions, record-keeping and financial aid," Mund commented. The Admissions Office and the Financial Aid Office are administered by the Office of Student Affairs.

"The improved data base which can result through this operation will provide the academic sector with more useful data for planning and for advising students," Easley said. He added that his assistant, Ernest W. Cole, will continue to serve as liaison for academic functions with the Registrar's Office.

The change will not require additional personnel and it may eventually result in a reduction of costs, Easley and Mund said.
