\$50,000 KICKS OFF CAMPAIGN

Ashland Oil, Inc., Tuesday announced a gift of \$50,000 to Marshall University, kicking off a \$495,000 "Forward Marshall" fund-raising campaign.

Announcement of the gift was made by Orin E. Atkins, chairman of the board and chief executive officer of Ashland Oil, who also has accepted the chairmanship of the "Forward Marshall" campaign. Mr. Atkins, a Marshall alumnus, also is chairman of the Marshall Advisory Board.

The campaign kick-off was announced during a luncheon in Marshall's Memorial Student Center, attended by community leaders, campaign volunteers, representatives of the news media and university officials.

Noting that a \$50,000 gift from Heck's, Inc., announced July 11, also was part of the "Forward Marshall" campaign, Mr. Atkins said that 20 per cent of the goal of the three-year campaign already had been achieved.

Marshall President John G. Barker, who announced Monday that the North Central Association of Colleges and Secondary Schools had removed Marshall from private probation and renewed the institution's full accreditation, said the "Forward Marshall" campaign will enable the university to add greater quality to its improving services.

The campaign has been structured in three divisions, Mr. Atkins said:

-The Business Division is headed by Col. William G. Powers, president of Huntington Trust and Savings Bank.

--The Alumni Division has as its chairman James O. Porter, Huntington attorney.

-The Marshall Foundation and Friends Division is headed

Accreditation reaffirmed

Marshall University has been removed from private probation by the North Central Association of Colleges and Secondary Schools and its full accreditation has been reaffirmed.

The announcement was made Monday by Marshall President John G. Barker following a telephone conversation with North Central Association headquarters in Chicago, notifying him of Marshall's status.

Marshall is accredited to offer programs through the Masters Degree level.

The institution was placed on private probation in 1969.

Dr. Barker, Chancellor Prince B. Woodard of the Board of Regents and Marshall Vice President for Academic Affairs W. K. Easley met in Chicago last Tuesday with a review committee of the North Central Association's Commission on Institutions of Higher Education.

Marshall will have its next evaluation in three years, Dr. Barker said.

All three division chairmen have served on the Marshall Alumni Association Board of Directors and Mr. Porter is a former president of the Alumni Association.

President Barker also is taking an active role in the campaign and will contact a number of potential major contributors. In noting that the drive could give Marshall the initial "edge" needed in its efforts toward further improvement of programs and facilities, Dr. Barker quoted President Howard R. Bowen of the University of Iowa: "Those public institutions that have achieved greatness have done so with the help and encouragement of private resources and private leadership."

"Marshall is emerging as a strong urban-oriented university that will make ever-increasing contributions-both through its own facilities and its growing alumni body-to the life and development of our region," Dr. Barker said. "The future is bright; we look forward to significant progress in the mid-1970's, particularly with the added impetus of a successful 'Forward Marshall' campaign."

"Perhaps of greatest significance, it seems to me, is that many of us who have lived much of our lives in the Tri-State Area and have seen Marshall's contribution to our day to day patterns of life may well want to make this the moment when they will stand up and be counted for Marshall University," Chairman Atkins said.

Of the \$495,000 to be raised in the campaign, \$207,000 is earmarked for improvements in the program in the College of Business and Applied Sciences, envisioned as one of Marshall's principal areas of potential growth. The other \$288,000 will go toward university-wide needs.

New dean appointed

Dr. Richard G. Fisher, 32, of Iowa City, Iowa, has been appointed dean of students at Marshall University. He assumed his new duties last week.

The announcement was made by Dr. Richard G. Mund, vice president for student affairs. Fisher succeeds Dr. Charles R. Quillin, who has been reassigned as assistant to Vice President Mund.

Fisher, who completed work on his doctorate at the University of Iowa this summer, has been serving as counselor and program assistant in career planning and placement there. He is married and the father of two children.

A native of Jesup, Iowa, he earned his A.B. degree in history from the University of Dubuque (Iowa) and his Master of Arts degree in counseling and guidance from the University of Iowa.

Fisher served as a teacher-coach in Waverly, Iowa, in 1963-64. From 1965 to 1967 he was assistant dean of men at Elmhurst (III.) College, and from 1967 to 1970 he was financial aid and foreign students counselor at Stanislaus State College in Turlock, Calif.

Music chairman named

Dr. Wendell C. Kumlien, 46, of Milwaukee, Wis., has accepted an offer to become chairman of the Marshall University Music Department, effective Aug. 27.

The announcement was made by Dr. William K. Easley, Marshall's vice president for academic affairs, and Dr. Robert B. Hayes, dean of the College of Education.

Dr. Kumlien will succeed Dr. Lawrence Kingsbury, who retired last spring.

Dr. Hayes said Dr. Kumlien was recommended for the appointment by a screening committee made up of members of the Music Department faculty. The committee identified, evaluated and made recommendations on applicants for the position.

A native of Brookings, S.D., Kumlien received his B.A. degree in music theory from Hamline University, St. Paul, Minn., in 1950, his M.A. degree in music theory from the University of Minnesota in 1956, and his Doctor of Musical Arts degree from the University of Illinois in 1969.

He presently is visiting professor of music and university artist at the University of Wisconsin in Milwaukee and serves as director of two university choral organizations.

Dr. Kumlien was chairman of the Music Department at Southern State University in Springfield, S.D., from 1951 to 1954. From 1955 to 1959 he was a member of the music faculty at Northern State University in Aberdeen, S.D., and from 1959 to 1971 he was professor of music at Indiana State University where he was head of the Vocal-Choral Division.

Marshall University will be host to a group of French women, all of whom are teachers, beginning Saturday.

The teachers are participating in the Experiment in International Living program, according to Dr. Robert P. Alexander, campus coordinator of the program and associate professor of management.

While visiting the Huntington area, the group will live on campus, hear lectures at the university, tour the city and travel to Beckley and Grandview State Park, where they will see the historical drama, "Honey in the Rock."

The Experiment in International Living is a non-profit organization which seeks to promote a better understanding among people of the world. Sanctioned by the U.S. State Department, the experiment has exchanged programs for high school and college students, as well as teachers. According to Dr. Alexander, this is the ninth year Marshall University has participated in the program.

Vice President for Business Affairs Joseph Peters will officially welcome the teachers to Marshall University on Monday. While on campus, the teachers will have the opportunity to audit summer classes in their fields of interest in order to observe the American system of higher education.

Special lectures will be presented by Dr. O. Norman Simpkins, chairman of Marshall's sociology and anthropology department, and Dr. A. Mervin Tyson, professor of English.

The women will be leaving Huntington on Friday, Aug. 3.
