

#### • COLLEGE OF SCIENCE

COURSE ADDITIONS

GLY 320L Geology Lab Techniques 2 hours Techniques of collection, preparation and analysis of mineral, rock and water samples, and the use of different instruments for obtaining quality data. Will also cover tools used for data interpretation. Co-requisites(s)/Prerequisites(s): None (Science/Eng. Major).

#### GLY 420 Geochemistry

3 hours

Application of chemical principles to geology. Topics include cosmochemistry; distribution of elements in minerals and rocks; aqueous solutions and water-rock interaction; radiometric age dating; and stable isotope geology. Co-requisites(s)/Prerequisites(s): GLY 314; CHM 211.

COURSE DELETION

GLY 425 Geochemistry 4 hours Rationale: The class is being replaced by GLY 420 (Principles of Geochemistry; 3 credit units), and GLY 320 (Lab techniques in Geology and Environmental Science; 2 credit units).
