CURRICULUM COMMITTEE RECOMMENDATION

SR-07-08-(42) 73 CC

Recommends approval of the listed REQUEST FOR UNDERGRADUATE ADDITION, DELETION, OR CHANGE OF A MAJOR from the following colleges and/or schools:

COLLEGE OF EDUCATION & HUMAN SERVICES

Action Requested: Addition of a major, Hospitality Management

Rationale: To meet the requirement for the dual degree arrangement for students that possess an Associate Degree in Hospitality management from accredited community and technical colleges, and plan to pursue a B.A. in Family & Consumer Sciences degree program at MU. Currently an agreement has been reached for graduates with an Associate Degree in Hospitality Management from MCTC to be admitted into the B.A. in FCS, hence the proposed new addition of major.

Curriculum: Students will complete the general education requirements and then complete one of the following areas of emphasis: Hotel/Lodging, Food Service Management, or Culinary Arts.

COLLEGE OF SCIENCE

Action Requested: Addition of a major, B.S. in Environmental Chemistry Rationale: A variety of industries from resource extraction to tourism have an impact on the environment. In addition "Center for Environmental Research, Assessment and Policy" is a signature initiative with MU's Strategic Vision. This major will help train Bachelor's level chemists to serve within the growing field of environmental science.

<u>Curriculum</u>: Science 72-80 hours; General Humanities and Social Science Requirements 42-54 hours; General Electives from any college 10-22 hours.

• LEWIS COLLEGE OF BUSINESS

Action Requested: Addition of a major, International Business

<u>Rationale</u>: Many of our current and former students have requested that the LCOB offer an International Business (IB) major. The undergraduate IB major is designed to provide students with a broad knowledge of international business activities and to prepare them for careers in the increasing interdependent global market place. IB majors will learn global perspectives in multinational business analysis.

<u>Curriculum</u>: Required courses 15 hours; Elective courses 6 hours; Experiential Education Requirement 3 hours; and foreign language requirement 0-9 hours.
