O'Hanlon appointed to dual liberal arts post

Daniel P. O'Hanlon, Legal Assistant Program director for the Community College, has accepted a dual assignment in the College of Liberal Arts as acting chairman of the Criminal Justice Department and director of a Legal Studies Task Force.

The announcement of the appointment, effective with the start of the second semester, was made by College of Liberal Arts Dean Alan B. Gould.

As acting chairman, O'Hanlon fills a vacancy created by the resignation of Dr. Hilary Harper Jr., associate professor, who will continue to teach full-time, according to Dr. Gould.

"In addition to directing the reorganization of the

Criminal Justice Department, Assistant Professor O'Hanlon will supervise a task force responsible for developing a 'two-plus-two' degree in legal studies," Gould said. "The task force also will be responsible for the preparation of a suggested curriculum for pre-law majors," he added.

"Dan O'Hanlon has been one of our strongest program coordinators and we regret our loss, but realize that this is an excellent opportunity for his professional development," said Dr. Paul Hines, vice president for the Community College. Hines added that he and Community College Assistant Dean Glenn Smith would act as directors for the Legal Assistants Program this semester.

ML Department chairman to change on May 15

Effective May 15, Dr. Harold T. Murphy, professor, will succeed Dr. Emory W. Carr, associate professor, as chairman of Marshall University's Modern Languages Department, MU College of Liberal Arts Dean Alan B. Gould announced today.

"Dr. Carr requested that he be allowed to relinquish his administrative duties at the end of second semester. He plans to return to full-time teaching," Dr. Gould said.

"Since he assumed the chairmanship in 1977, Dr. Carr has met a number of challenges in his efforts to strengthen program offerings and faculty. I regret that he is stepping down, but am pleased that he will continue on the faculty," the dean said.

"Dr. Murphy, a member of Marshall's faculty since 1960, is equally capable and, no doubt, will be able to build further on his predecessor's work," Gould added.

New parking rules announced for ball games on class nights

Slightly tighter restrictions have been announced for those parking on Marshall University lots for Thundering Herd Basketball games in Henderson Center.

The change affects public parking only on those nights when evening classes are scheduled at the same time as basketball games, according to Parking Director Bonnie J. Lytle. On those nights, public parking will not be permitted on university lots until 7 p.m., following the start of most evening classes.

Previously, it had been announced that the public could use the lots after 6:45 p.m. on class nights. Only three dates are involved during the remainder of the current basketball season. These are Jan. 18 and Feb. 8 and 15.

Sam Gilliam art exhibition to open Jan. 21 with reception

An exhibit by Washington, D.C., artist Sam Gilliam will open Thursday, Jan. 21, at Marshall University's Birke Art Gallery with an informal public reception for the artist at 7:30 p.m.

The exhibit, which will continue through Feb. 19, is part of the 1981-82 Birke Fine Arts Symposium which has been partially supported by the West Virginia Department of Culture and History's Arts and Humanities Division.

Gilliam, who will hang the exhibit, also will meet informally on Friday, Jan. 22, with MU art students. Gilliam's work has been exhibited in one-man shows and group exhibitions in major galleries in this country and abroad, including the Corcoran Gallery of Art and the Kennedy Center in Washington and the Museum of Modern Art in New York.

Former state legislator, Roy Douglas, claimed by death

Services were held Jan. 2 in Elizabeth for Roy I. Douglas, 83, who died Dec. 31. The Ritchie County native was the father of Martha Deel, a secretary in the Accounting Department, Financial Affairs Office, and father-in-law of Associate Provost William Deel.

A former member of the West Virginia House of Delegates from Wirt County in the 1940s, Douglas was a deputy tax assessor, a teacher and a retired farmer. In addition to his daughter, survivors include his wife, Mildred C. Douglas, and another daughter, Sarah Douglas of Point Pleasant.

In addition, his review of Gosnell's "Truman Crises" appeared in a recent issue of the Register of the Kentucky Historical Society. An essay, "John Sherman Cooper and the Vietnam War," will appear in a forthcoming book on Outstanding Kentuckians to be published by the Kentucky Historical Society.
