Dr. Harold W. Brown, professor emeritus of Columbia University's College of Physicians and Surgeons, will deliver the class' "Last Lecture" at 8 p.m. Tuesday, May 4, at the Huntington Galleries. "Medical Serendipity" will be his topic.

Dr. Milton Rosenbaum, MU distinguished visiting professor of psychiatry, will deliver the main address at the Doctoral Investiture Program which will be held at 8

## Nursing grads to hear Sharon P. Rockefeller

Sharon Rockefeller will be the speaker for the Marshall University School of Nursing's pinning and awards ceremony at 7:30 p.m. Friday, May 7, in Smith Recital Hall, Dr. Phyllis Higley, school dean, announced today.

Mrs. Rockefeller, wife of West Virginia Governor John D. Rockefeller IV, is a member of the West Virginia Women's Commission, co-chairman fo ERAmerica and chairman of the board of directors for the Corporation for Public Broadcasting.

During the ceremony, nursing achievement pins will be awarded to students who have completed the Associate in Science in Nursing degree and Bachelor of Science in Nursing degree programs. Fifty-three students in the A.S.N. program and 18 in the B.S.N. program will receive pins. Special awards, including those for academic excellence, will be presented by Dr. Higley and Ruth Pearson, acting director of the B.S.N. degree program.

Pins will be presented to A.S.N. degree students by the dean and Assistant Professors Giovanna Morton and Kathryn Parsons. Graduates of the B.S.N. degree program will receive their pins from Ms. Pearson and Assistant Professor Elizabeth Barker.

Also participating in the program will be MU Provost Olen E. Jones Jr., who will extend greetings from the university; Paula DeBord, A.S.N. program graduate, who will give the invocation, and Jane Hannum, B.S.N. program graduate, who will give the benediction.

### Staff Council election set

Ballots for the election of members to the Staff Council will be enclosed with the April 30 paychecks, according to Ray Welty, Council chairman.

Voting will take place Thursday and Friday, May 6-7. Ballot boxes will be located at the Security Office in the basement of Old Main, at the James E. Morrow Library circulation desk, at the Memorial Student Center information desk, Buildings and Grounds Office in the Sorrell Building, and Dean's Office, School of Medicine, DMB 506. p.m. Friday, May 7, in Memorial Student Center.

Dr. Rosenbaum's topic will be "On Becoming a Doctor-A Personal Reminiscence." He will administer the Oath of Hippocrates to the 23 graduating seniors as well.

Class awards and faculty awards will be presented at the Investiture Program by the class president and Associate Dean for Academic Affairs David K. Heydinger, respectively.

Senior Class President James M. Bennett of Charleston will preside at both programs and a reception will follow each event.

"The 'Last Lecture' and the Doctoral Investiture Program are open to everyone," MU School of Medicine Dean Robert W. Coon said. "We really would like to see campus-wide participation in these special events," he added.

An internationally recognized parasitologist, Dr. Harold Brown is the former director of the School of Public Health at Columbia, where he taught from 1943 until retiring in 1970. Prior to joining the staff at Columbia University, he was dean of the University of North Carolina's School of Public Health and also was professor of preventive medicine and parasitology at Duke University.

Dr. Rosenbaum joined Marshall's School of Medicine faculty in 1978, having previously taught at the University of Cincinnati and at the Albert Einstein College of Medicine. A former National Institute of Mental Health Distinguished Visiting Scientist, Dr. Rosenbaum has served as visiting professor of psychiatry at several major medical schools here and abroad, including University of Puerto Rico, Georgetown University, Hebrew University-Hadassah Medical School of Jerusalem, and the Australian and new Zealand College of Psychiatrists.

# Ballots to be received May 3 for constitutional amendment

An amendment has been proposed to the Faculty Constitution in Article IX-8-B (erroneously shown as Article XI in the Greenbook.) Athletic Committee Membership. # Academic Planning/Standards reports

Academic Planning and Standards met April 13, 1982 and approved the following items of business:

- The February 16, 1982, minutes were approved with 1 the following corrections:
  - Discussion #2: 1.
  - Item 1. The title should read The Marshall University Advisory Committee's Booklet. Item 2. Change Dec. 2, 1981 to Dec. 3, 1981.
  - 2 Discussion #3: Item 3. Change ANT 475, 476, 477, 478, 479 to ART 475, 476, 477, 478, 479 Correct spelling of PMC 635

    - Correct spelling of ANT 444/544
- 2. President Hayes presented a written request to APSC asking for assistance in setting up a task force to examine health related programs. The charges from the president are:

1. Identify areas of concern in each program.

- 2. Identify areas which appear to overlap.
- 3. Identify physical needs, staffing needs and credential problems.

4. Make recommendations in a report by fall, 1982.

5. The composition will be limited to 5-7.

The possibility of this task force becoming a permanent sub-committee of APSC was asked to be considered. The suggested framework for task force membership includes:

- 1. Each Dean appoint a representative (may appoint themselves)
- 2. One representative from outside the academic community.

APSC appointed Professor Giovanna Morton to be the APSC liaison to this task force.

The Criminal Justice Department presented a proposal to modify their graduate curriculum with the hours required remaining the same. Included in the modification were the following additions:

The Academic Policy and Subcommittee presented 4. a report on CLEP and its use at Marshall University. The question of how the students credit is counted from the general examination when a comparable subject exam or the equivalent courses has been taken was tabled until the April 29, 1982 meeting.

The following changes were approved:

 Questions have been raised as to whether CLEP can be used to remove a D or F grade. On page 55 of the current catalog under "Quality Points Requird for Graduation", the rule specifies only by repeating the course may the D or F be removed. The following phrase was approved to be added to the current paragraph on page 55: (including CLEP examination)

"If a student earns a grade of "D" or "F" on any course taken no later than the semester or summer term during which he attempts the sixtieth semester hours, and if he repeats this course prior to the receipt of a baccalaureate degree, the original grade shall be disregarded and the grade or grades earned when the course is repeated shall be used in determining his (sec) grade point average. Only by repeating this course and by no other means (including CLEP examination) can the original grade be disregarded. The original grade shall not be deleted from the student's record."

It was the concensus of the subcommittee that 2. the statement concerning the use of CLEP in granting CR/NC on page 64 (shown below) of the current catalog should also appear on page 19 under CLEP information. The underlined sentence was added to the statement on page 64. This change was approved.

#### **CREDIT/NON-CREDIT OPTION**

A student may elect to present a maximum of 18 semester hours of credit on a credit/noncredit basis toward fulfillment of requirements of a baccalaureate degree. Credit completed through the College Level Examination Program (CLEP) does not count as a part of the 18-hour limit under the CR/NC option. The decision to take a course on a credit/non-credit basis must be made during registration and may not be changed after the end of the registration period. Courses taken on this basis must be in areas other than the student's major area or teaching specialization.

The appointment of Dr. Bradley, who has been with the medical school since 1975, was effective earlier this month, the dean said. Bradley was serving as acting department chairman. He succeeds Dr. George J. Hill who served as chairman from May, 1976 through June, 1981.

"A native of West Virginia, Dr. Bradley is well known and respected by his colleagues. He has performed effectively and enthusiastically in any role the school has assigned him and we are pleased he has accepted this new challenge," Coon said.

Prior to joining the MU medical faculty, Dr. Bradley was chief of staff for education and acting chief of the surgical service at the Lexington (Ky.) VA Medical Center. He also served as chief of the surgical service at the Huntington VA Medical Center from 1951 to 1970.

A graduate of West Virginia University, he received his M.D. degree from Northwestern University and a Ph.D. degree in anatomy later from the University of Kentucky.

If a student decided to change his major after taking a course Credit/Non-Credit, and that course then becomes a part of his major, the letter grade turned in by the instructor will be inserted in the transcript and will be included in the computation of the grade point average.

Course work taken on a credit/non-credit grade, recorded as CR or NC, will not be counted in computing the student's gradepoint ratio. A course that has been taken on a credit/non-credit basis in which the grade of NC was awarded may be repeated either on a credit/non-credit basis or on a regular grade basis.
