Election set for Staff Council members

Permanent members of the Marshall University Staff Council will be elected Oct. 8 and 9 by staff members, said Marvin Billups, who chairs the ad hoc council which drew up the constitution and set up the election.

Council nominations were made in meetings held Wednesday and Thursday by four employee groups.

Ballots will be distributed by campus mail and must be placed in ballot boxes on the dates of the election. Ballot boxes will be in five locations: the Memorial Student Center main desk, the Buildings and Grounds office in the Sorrell Maintenance Building; the Doctors' Memorial Building lobby, the circulation desk at the James E. Morrow Library and the Security Office in Old Main. Except for the one in the Security Office, the ballot boxes will not be available after 4:30 p.m.

"The 20 members of the Staff Council have worked very hard to draw up the constitution which was distributed recently, and to put together this election of permanent members. I would like to take this opportunity to thank them, and to encourage all staff members to participate in this important election," Billups said.

Gov. Jay Rockefeller to speak at building dedication Oct. 4

Marshall University's new classroom building, Corbly Hall, will be dedicated in ceremonies Saturday, Oct. 4, beginning at 9:30 a.m., MU President Robert B. Hayes announced. Building tours will be conducted after the ceremonies, he said, adding that the event is open to the public.

The \$6 million structure, completed during the summer, was opened to students this fall. It houses the College of Business, the English and Home Economics departments, and several Community College classes.

Hayes said Governor John D. Rockefeller IV has accepted an invitation to be the dedication speaker. Hayes will serve as master of ceremonies. Dr. Howard Mills, professor of biological sciences and chairman of the university's Physical Facilities and Planning Committee, will deliver a brief tribute to Lawrence J. Corbly, for whom the building was named.

Other participants include Edward H. Greene of Huntington, member of the West Virginia Board of Regents, who will formally present the building to the university on behalf of the regents and unveil the plaque; Dr. Sam Clagg, chairman of University Council, who will accept on behalf of the Marshall faculty, and Mrs. Carol J. Valentine assistant professor of English, who will give the invocation.

The ceremonies will be conducted on the east side of the building, between Corbly Hall and Memorial Student Center.

Hayes said a number of special guests have been invited, including Miss Mamie Spangler of Richmond, Va. Miss Spangler, now 88, began a campaign in 1969 to have Marshall recognize the contributions of former President Corbly.

"Miss Spangler was persistent," Hayes said, "and we owe her a debt of gratitude. She brought to our attention an important era in Marshall's history and reminded us

of a brilliant man who deserves to stand in the forefront as we recognize Marshall's traditions. We're looking forward to being able to introduce her during the ceremonies."

Miss Spangler earned her high school diploma from Marshall College in 1908 and her normal school (teaching) diploma in 1910. Later, while teaching in Huntington schools, she attended summer and Saturday sessions, receiving her A.B. degree in 1924.

A native West Virginian, Corbly came to Marshall as "principal" in 1896. The small normal school grew phenomenally under his leadership and he became Marshall's first president in a 1907 reorganization, serving in that capacity until 1915 when he resigned to enter private business.

Groundbreaking for Corbly Hall, which contains 93,000 square feet, was conducted Nov. 12, 1977. Architect for the project was the Huntington firm, Dean, Dean and Kieffer. Edward L. Nezelek, Inc., of Johnson City, N.Y., was general contractor.
