Rationale: To more appropriately reflect current course objectives and content.

Change it title to: Family and Chronic Illness

MTH 300 Introduction to Higher Mathematics

Change in credit hours: FROM: 3 TO: 4

<u>Rationale</u>: This represents a shift of one credit hour from deleted course MTH 301. There was a consensus that the number of hours required for the mathematics major should not change. It was felt that this course could use the extra hour so that more examples in logic and proof technique could be covered.

MTH 330 Linear Algebra

Change in course number to: MTH 331,

Rationale: The current course, MTH 330, is required for two incompatible groups of students. There will be a new, more elementary version of MTH 330, to be called MTH 329 (a Request for Undergraduate Course Addition form is being submitted) and the renamed MTH 331. These two courses will serve these two groups of students. This number change will help to alleviate confusion

between the old course and its successors.

-AND-

<u>Change in catalog co-requisite/prerequisite:</u> **FROM:** PR—At least one course above MTH 121 or at least 28 on Mathematics ACT. TO: CR—MTH 300.

<u>Rationale:</u> The old PR was set artificially low to accommodate Mathematics Education 5-9 majors who will no longer be required to take this course (they will be required to take MTH 329 instead). After much discussion in the departmental Curriculum Committee, the new co-requisite was recommended; it was approved without dissent by the departmental faculty.

MTH 415 Applied Mathematics – Boundary Value Problems

Change in title to: Partial Differential Eqs

Rationale: The full title is Partial Differential Equations. The new title better represents the course content as expressed in the catalog description.

JMC 304 Indepth Reporting

Change in title to: Computer-Assisted Reporting

Rationale: New course name better reflects the content of the course.

JMC 382 Advertising Strategies and Execution

Change in course number: FROM: JMC 382 TO: JMC 415

Rationale: JMC 382 used to be a copywriting course with an introduction to advertising strategy. Earlier curriculum revisions established JMC 221 for basic copy and continuity writing, leaving 382 to concentrate on development of strategic communications plans. They content of 382 has become a more in-depth, complex and advanced study of strategic communication that merits a corresponding advanced numeric designation.
