## CURRICULUM COMMITTEE RECOMMENDATION

### SR-02-03-(33) 63 CC

Recommends approval of the listed **COURSE CHANGES** in the following colleges and/or schools:

- **COLLEGE OF LIBERAL ARTS:**

CJ 280-283 Special Topics

Change in catalog description: **FROM:** None. **TO:** Lower level specialized courses of contemporary interest.

Rationale: Existing courses provided no catalog description, so one has been added.

FRN 405-406

Change in course number: **FROM:** 405-406 **TO:** 335-336

Rationale: It reflects the level at which the course is taught.

GEO 429 Cartography

Change in title: **FROM:** Cartography **TO:** Fundamentals of Geographic Information Systems (GIS)

Rationale: The new title reflects the change in course emphasis and technology employed.

**-AND-**

Change in catalog description: **FROM:** Understanding principles and developing skills in the use of cartographic drafting equipment and in map making. **TO:** Basic geodesy and application of cartographic principles to automated mapping and GIS.

Rationale: The new description reflects the course emphasis on using digital technology.

GEO 430 Cartography and Geographic Information Systems

Change in title: **FROM:** Cartography and Geographic Information Systems **TO:** Intermediate Geographic Information Systems (GIS)

Rationale: The new title reflects the change in course emphasis/technology and also indicates that the course's content follows the introductory material in GEO 429.

**-AND-**

Change in catalog description: **FROM:** Introduction to computer use in mapping and geographic information systems. **TO:** Data collection and input from readily available sources, creation of custom data using GPS, and advanced spatial analysis using GIS (PR: GEO 429 or permission of instructor)

Rationale: The new description provides more detail and reflects the change in course emphasis/technology.

- **COLLEGE OF NURSING & HEALTH PROFESSIONS**

CLS 466 Diagnostic Physiology

Change in content: **FROM:** Emphasis on advanced issues in biochemical and transfusion service laboratory testing and integration of laboratory test data in patient pathophysiology. **TO:** Emphasis on integration of all laboratory test data in patient pathophysiology.

Rationale: Advanced clinical chemistry and blood banking/transfusion courses in the revised CLS curriculum will include content removed from this course.

**-AND-**

Change in credit hours: **FROM:** 3 hours **TO:** 2 hours

Rationale: The content removed reduces the instructional time needed to cover the pathophysiology content.

MGT 350 Health Care Organizations & Management

Change in title: **FROM:** Health Care Organizations & Management **TO:** Health Care Management

Rationale: The course has been broadened to reflect the changes in the health care industry and to modernize course.

**-AND-**

Change in catalog description: **FROM:** A study of the structure and function of several components of Health Care organizations and their interrelationships. **TO:** An introduction to the management of health care organizations.

Rationale: To modernize and more correctly describe the way the course is taught.

MGT 354 Health Care Services and Facilities Management

Change in title: **FROM:** Health Care Services and Facilities Management **TO:** Health Care Delivery Systems.

Rationale: The course has been broadened to reflect the changes in the health care industry and to modernize course.

**-AND-**

Change in catalog description: **FROM:** A study of planning and organizing of medical services and support departments and buildings, facilities and equipment management. **TO:** An examination of the various private and public sector health care delivery systems currently operating within the United States. PR: MGT 350, ACC 216, MGT 281, MTH 203.

Rationale: To modernize and more correctly describe the way the course is taught.

MGT 360 Introduction to Small Business Mgt.

Change in title: **FROM:** Introduction to Small Business Mgt. **TO:** Introduction to Entrepreneurship

Rationale: Current title is passé and not in line with current terminology and will better reflect the way these issues are discussed in the literature.

MGT 461 Management of Small Business


Change in title: **FROM:** Management of Small Business **TO:** New Venture Dynamics
