CURRICULUM COMMITTEE RECOMMENDATION

SR-02-03-(45) 75 CC

Recommends approval of the listed COURSE DELETION and COURSE CHANGES for the COLLEGE OF LIBERAL ARTS:

DELETION:

GEO 315 Geography of Africa

<u>Rationale</u>: The subject matter of this course will be included in the new course indicated below. GEO 407 Geography of Sub-Saharan Africa.

COURSE CHANGES:

CJ 211 Introduction to Law Enforcement

<u>Change in catalog description:</u> **FROM:** Basic course dealing with agencies involved in administration of justice; history and organization of local, state, and federal agencies; courts, trial, jails, and prison; probation and parole. **TO:** Designed to examine the philosophical and historical background of law enforcement in the United States. Addresses constitutional limitations on law enforcement, objectives of law enforcement, and processes of law enforcement.

Rationale: Existing catalog description is overly broad and not descriptive of course content.

CJ 425 Juvenile Justice Administration

Change in title to: Juvenile Justice

Rationale: New title is more descriptive of course content.

AND

Change in course number: FROM: CJ 425 TO: CJ 325

Rationale: The new number is more consistent with academic rigor of the course.

AND

Change in catalog description: Change would delete prerequisite.

CJ 431 Criminal Rehabilitation

Change in title to: Correctional Rehab

Rationale: New title is more consistent with current research in the field.

AND

Change in course number: FROM: CJ 431 TO: CJ 332

Rationale: The new number is more consistent with academic rigor of the course.

AND

<u>Change in catalog description:</u> **FROM:** The historical, legal, and philosophical foundations of criminal rehabilitation; contemporary approaches to intervention, professional roles, and interpersonal skill development. (PR: CJ 231) **TO:** Examines the theories, treatment strategies, and the role of the correctional counselor. Special emphasis is given to the topics of classification, development of treatment plans, and principles of effective intervention.

<u>Rationale:</u> Existing course description is somewhat outdated. New description correlates to research in the field.
