BY-LAWS COMMITTEE  
Recommendation

**SR-91-92-62(BL) (REVISED)**

That Article VI, Section 3 and Section 5C of the **Constitution of the Marshall University Faculty** be changed to the following in order to allow the use of procedures outlined in **Robert's Rules of Order** for the removal of Standing Committee and Senate officers for dereliction of duty:

**Article VI, Section 3 concerning officers of Standing Committees:**

**FROM:** The terms of office shall be one (1) year, and may be renewed up to a maximum of four (4) successive terms (i.e., four years).

**TO:** The terms of office shall be one (1) year, and may be renewed up to a maximum of four (4) successive terms (i.e. four years). The Committee may remove an officer by a "motion to rescind the election." The successor of an officer removed in this manner shall serve until the next regularly scheduled election for that office.

**Article VI, Section 5C concerning officers of the Executive Committee:**

**FROM:** Terms of office shall be two (2) years.

**TO:** Terms of office shall be two (2) years. The Senate may remove an officer by a "motion to rescind the election." The successor of an officer removed in this manner shall serve until the next regularly scheduled election for that office.
