INDIVIDUAL SENATOR Recommendation

SR-90-91-(83)235(IS) (submitted by Senator Dallas Brozik)

To approve the following parking policy.

On days when classes are not in session (weekends, holidays, and intersession periods), any person may park in any University parking lot (including metered parking).

Exceptions to this would include:

- 1) Handicapped parking spaces.
- 2) Athletic parking areas on game days.
- 3) During regular registration periods, open parking would be discontinued due to the heavy demand for parking spaces.

RATIONALE: On days when classes are not in session, there are typically many unused parking spaces in lots near academic buildings. Those faculty and staff members who must or choose to work on these days should be able to use these slots on a first-come, first-served basis.

Exceptions are provided for handicapped individuals and for specified parking areas during periods of congestion.

NOTE: This policy is currently in effect informally.
