GRADUATE COMMITTEE Recommendation

SR-89-90-89 (GR)

That the following changes be made in the Graduate Catalog:

1. On Page 30, delete under "I" the sentence, "An I grade (Incomplete) is given to students who do not complete course requirements because of illness or for some other valid reason" and replace it with "The instructor may grant an I grade (Incomplete) when a student's illness or some other valid reason makes it impossible to complete course requirements. It is the instructor's decision as to whether an I is to be granted based on such considerations as the amount of course work completed, the student's demonstrated potential to successfully complete the work, and the appropriateness and feasibility of granting an I based on the design of the course and the reason for failure to complete the course.

On Page 30 under "I" delete the sentence "The student has the responsibility of completing the work satisfactorily, and if this is done the final grade may be any on of the four passing marks" and replace it with "The student has the responsibility of completing the work satisfactorily, and if this is done the final grade shall be converted into the earned letter grade."

- 2. On Page 37, VI. B. 1. Faculty Members, change the first sentence to read "The Graduate Dean shall appoint three (3) faculty members from each college and school having a graduate program to serve on the Board."
- On Page 37, VI. B. 2. Student Members change the first sentence to read "The President of the Graduate Student Council shall appoint one (1) graduate student from each college and school having a graduate program to serve on the Board."
- On Page 37, VI. C. Selection of Members for an Individual Hearing, omit "randomly" from the second sentence.
- 3. On Page 38, Item VII. G., change the last sentence to read "In the event a student is excluded under the terms of this provision, a representative shall be appointed by the Hearing Officer to participate in the student's behalf during the continuation of the proceedings."
