

Dr. Johnson is responsible for circulation, interlibrary

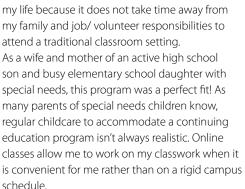

#### Lynda Campus available

Marshall University Information Technology provides access to Lynda Campus for ALL students, faculty and staff. This service provides the university, and the members of its community, with easy online access to in-depth training demos on a wide variety of topics underlining important technical and life skills. To access these videos and more, visit Lynda.marshall. edu and sign in using your MUNet Account username and password. Access is available both on and off-campus. Lynda.com is also available in the app store for smart devices.

#### Benefits to using lynda.com:

- Unlimited access to courses on a wide variety of technologies and disciplines
- Up-to-date content to keep skills current and to learn new skills
- New courses added every week
- Tutorials taught by recognized industry experts
- Access to instructors' exercise files to follow along as you learn
- Closed captioning and searchable, time-coded transcripts
- Beginner to advanced courses
- The option to watch complete courses or bitesize videos as you need them

#### **Examity**

In addition to your regular classes, you are enrolled in **Distance Student Orientation**, which is completely free. One required activity must be completed right away to comply with federal law: **Identity Verification** (see more below). The rest of the course is entirely self-paced and not graded. The course is design to give you an introduction to

Marshall University, including where to find assistance and services you may need.

#### **Identity Verification**

If you were enrolled in classes on campus, we'd invite you to visit the ID office and have your picture taken for a Marshall Student ID. Because your "campus" is virtual, your photo will be taken in Blackboard via webcam.

In the **Distance Student Orientation** course you will find detailed directions for scheduling your brief photo ID session with Examity. Examity's online test-proctoring capability is used to provide identity verification services. Note that the verification process is referred to as an "exam," and the video goes on to describe taking an exam, but the identity verification process does not involve an actual exam. Watch the Introduction to Examity video (https://youtu.be/98OStU71I7A) for a quick overview. You may also want to see the Identity Verification Quick Guide for Students (www.examity.com/docs/Blackboard Student Quick Guide.pdf) and the Examity Privacy Policy (https://examity.com/privacy-2/).

After completing the identity verification process, please log in to the Distance Education Student Orientation course again and click "Acknowledge Completion of Identity Verification" to answer a single Yes/No question to confirm that you finished the identity verification process.

#### Note:

Examity helps ensure that Marshall University is in compliance with the Higher Education Opportunity Act (HEOA) by providing processes "through which the institution establishes that the student who registers in a distance education or correspondence education course or program is the same student who participates in and completes the course or program and receives the academic credit" (34 CFR 602.17(g)).

Active duty military personnel who may not be permitted to share government issued IDs or utilize webcams in the field must contact the Office of Online Learning (dena.laton@marshall.edu or 304-696-3141) upon receiving an ID request from the system to postpone your ID verification.
