Because of the number of questions we must consider and answer in this study, consensus will be reached on the first 4 questions in the meetings Feb. 17 and 18, and on the last 4 questions on Mar. 3 and 4.

- 1. How should legislative salaries be determined?
  - a. by constitutional provision?
  - b. by legislative determination?
- 2. Should legislative per diem expenses in addition to salaries be permitted?
- 3. If answer to #2 is "yes"
  - a. for regular session expenses?
  - b. for interim session expenses?
  - c. for special sessions?
  - d. should expenses be constitutionally limited?
- 1. How should length of session be determined?
  - a. by legislative action?
  - b. by Constitution?
- 5. Should the annual sessions be of unlimited length, or should restricted budget sessions be retained?
- 6. Should any persons be ineligible for service in the legislature?
  - a. public officials or employees?
  - b... private individuals?
  - please list any you feel should be ineligible.
- 7. By what vote should a gubernatorial veto be overridden?
- 8. In considering the proposed legislative amendment
  - a. Is there any provision you consider so important that you would support the amendment, even if you disapproved of most of the other provisions? State.
  - b. Is there any provision you consider so undesirable that you would not support the amendment, even if you approved of most of the other provisions? State.

#### Votes For Women by G. Allen Foster

"Militancy" and "protest demonstrations" were tools used first by women, 70 years ago, in the long 90 year campaign for votes for women. In 1836, Mary Lyon began a college for women because American colleges did not admit women. Lucy Stone, distressed by the lack of legal and property rights of women, began a life of speaking and writing for womens' rights.

Exciting stories of women's work and adventure during the Civil War helped show the value of women in life outside the home. Names we've heard, Susan Anthony, Lucretia Mott, Clara Barton, Elizabeth Starton, worked endlessly, each in a different and effective way toward the goal. Liquor and slavery figure largely in the early struggle.

Two groups were formed in the United States, one to exert pressure on state legislatures to grant womens suffrage, the other to work at the federal level toward a constitutional amendment for womens rights. All this refined speechmaking and letterwriting began to take the form of 'real action' in the beginning of the 20th Century, with parades, sit-ins, sign carrying rallys, and loud firm voices. Our own Carrie Chapman Catt had assumed leadership, combined the two groups, and fired them into effective action. And here we are Now! Read it!
