

**Lynda.com training:** Lynda Campus available Marshall University Information Technology provides access to Lynda Campus for ALL students, faculty and staff. This service provides the university, and the members of its community, with easy online access to in-depth training demos on a wide variety of topics underlining important technical and life skills. To access these videos and more, visit <a href="Lynda.marshall.edu">Lynda.marshall.edu</a> and sign in using your MUNet Account username and password. Access is available both on and offcampus. Lynda.com is also available in the app store for smart devices.

### **Examity Identity Verification**

If you've already completed the Distance Student Orientation, thank you! If not, please do so at your earliest convenience. We will have a drawing at the end of October from the pool of students who have completed this process.

You are enrolled in Distance Student Orientation, which is completely free but has one required activity to be completed right away to comply with federal law: Identity Verification. The rest of the course is entirely self-paced and not graded. The course is designed to give you an introduction to Marshall University, including where to find assistance and services you may need.

In the Distance Student Orientation course you will find detailed directions for scheduling your brief photo ID session with Examity. This uses Examity's online test-proctoring capability to provide identity verification services. Note that the verification process is referred to as an "exam," and the video goes on to describe taking an exam, but the identity verification process does not involve an actual exam.

After completing the identity verification process with Examity, please log in to the Distance Education Student Orientation course again and click "Acknowledge Completion of Identity Verification" to confirm that you finished the identity verification process.

#### Note:

Examity helps ensure that Marshall University is in compliance with the Higher Education Opportunity Act (HEOA) by providing processes "through which the institution establishes that the student who registers in a distance education or correspondence education course or program is the same student who participates in and completes the course or program and receives the academic credit" (34 CFR 602.17(q)).

Active duty military personnel who may not be permitted to share government issued IDs or utilize webcams in the field must contact the Office of Online Learning (dena.laton@marshall.edu or 304-696-3141) upon receiving an ID request from the system to postpone your ID verification.

# RBA students, learn how YOU can participate in WVROCKS!

In an effort to make college more accessible to all West Virginians, the Higher Education Policy Commission (HEPC), with assistance from WVNET, developed a web portal, the West Virginia Remote Online Collaborative Knowledge System (WVROCKS). WVROCKS is designed to be a collaborative effort between all West Virginia higher education institutions who offer the Regents Bachelor of Arts and Board of Governors degree. The majority of the courses are 100% online. A handful of courses blend both limited face-to-face meetings with asynchronous (online) activities. All courses are offered in an eight-week time frame. With five starts dates a year, it is possible for students taking classes on the portal to complete fifteen hours of course credit per year by taking one course at a time.
