#### SOME QUESTIONS AND ANSWERS:

- Ques. "How about meetings?" Ans. Our constitution, Art. VII, Sec. I says: "There shall be at least three meetings of the membership each year. Time and place shall be determined by the Board of Directors. Sec. 2 - An Annual Meeting shall be held between March 1st and April 1st, the exact date to be determined by the Board of Directors". The first of the three meetings was held in September in the Council Chamber of the City Hall. The second meeting will be held in January, 1953.
- Ques. "Are there no other meetings?" Ans. Yes; "program" meetings such as the luncheon meeting at the Woman's Club last June to hear the reports of delegates to the state and national conventions. Another luncheon meeting was held October 30th at the Frederick Hotel to hear an address by the National Organization Chairman, Miss Katherine Gurnett,
- Ques. "What are the Unit Meetings"? Ans. Members and women interested in LWW work, are to meet in neighborhood groups approximately twice each month, (place, date, and hour, to be determined by each group). Mrs. David Baker, ('phone 44751) is Chairman of the Unit Organization Committee.
- Ques "What are LWV dues?" Ans. The annual dues are \$3.00 payable April 1st.
- Ques. "Are receipts from dues sufficient to meet the annual budget?" Ans. - No. The budget committee recommended contributions from members be received. This year's budget is based on \$200.00 additional contributions from members.
- Ques. "Have there been contributions from non-members?" Ans. Yes. A few business and professional men have contributed a total of \$153.00.
