Harper Grimm was elected President of the Student Body after a marked career of service to the students and the college. He has served as President of his class in its Junior year; as a member of the Inter-Fraternity Council for three years and as its President for one year; and as President of the Alpha Kappa Pi Fraternity for two years. He is a member of the Harlequin Club and of the Y. M. C. A.

Throughout the pages of this handbook are briefly explained the various organizations and activities of Marshall College. At the top or centralizing point of the various organizations, so far as the students are concerned, is a student government represented by a Student President, a Student Council, and a Student Court. Through your efforts in matriculating at Marshall you have expressed your willingness to become a member of this student association and therefore must assume your responsibilities and duties as such.

It is to your greatest advantage to become thoroughly acquainted with the newly adopted Constitution of the Student Body. Your own participation in collegiate affairs will depend entirely upon the extent to which you become acquainted with the functions of the Student Body, together with your sincerity of purpose in doing well that which should be done for the benefit of all.

It is the Freshman Class that brings from year to year the new influences that find further development on Marshall's campus. It is this class that in 1935 will find intrusted to them the guardianship of all that which we hold good for Marshall Colege. It is for this reason that you are experiencing a period of orientation, that you may more ably enter into the life of the college with credit both to yourself and to your Alma Mater.

The Freshman Class will submit to the Election Board on or before September 23, 9 o'clock A.M., the various nominees for three class officers and two Student Council representatives. The names of the nominees for class president and Student Council representatives must be submitted in

petition form accompanied by the signatures of at least ten per cent of the total membership of the class. The nominees for the other class officers, vice president and secretary-treasurer, are not selected by this procedure, it being only necessary to file announcement of candidacy with the Election Board, Under no circumstances will a student be permitted to sign more petitions than there are representatives to be elected from his class. Briefly, a student may sign but two petitions for representatives to the Student Council, and but one for the class president, comprising a total of three petitions. On September 30, from 10 A.M. to 12 M. the election shall be held by secret ballot in a specially designated voting place. Start now! Organize your class! See that your best men fill these important positions

Freshmen, in conclusion, I trust that you will consider it a privilege to observe the rules and regulations as adopted by the Student Council and enforced by a duly selected committee. You will find this enforcing group willing to aid you in whatever way possible and at all times courteous, honorable, and gentlemanly in their actions.

# CONSTITUTION of the STUDENT BODY of MARSHALL COLLEGE

#### PREAMBLE

We, the regularly enrolled students of Marshall College, comprising the Student Body of Marshall College, in order to encourage active cooperation in the work of student government, to uphold the highest standards of honor and integrity in all matters of personnal conduct, to strengthen cordial relations between faculty and students, to enact and enforce laws according to the grant of powers, to provide for the formation of an official body known as the Student Council, to give adequate and effective expression to the opinion of the Student Body in matters of general college interest, do hereby ordain and establish this constitution for student government of Marshall College.

#### ARTICLE I—LEGISLATIVE

Section 1. All executive and legislative powers herein granted shall be under the direction of the President of the Student Body and the several members of the Student Council, elected as hereinafter provided.

Section 2. The several members of the Student Council shall be:

(a) Two representatives from the Freshman class, elected for a term of one year by and from the class.

(b) Three representatives, one to serve for a term of two years and two for a term of one year, elected by the Sophomore class from its membership.

- (c) Two representatives (each to serve for a term of two years) from the Junior class, elected by the class, thus making a total of three with the hold-over member.
- (d) Two representatives, each to serve for a term of one year, elected by and from the Senior class, thus making a total of four with the two hold-over members.

(e) The President of the Student

House Government Association.

(f) The editor-in-chief of the official college year book, The Mirabilia, and the Council editor of the official college newspaper, The Parthenon, as ex-officio, nonvoting members.

Section 3. Representatives to the Student Council shall be elected as follows:

- (a) Candidates shall be nominated by a petition of ten per cent of the membership of the class. These petitions shall be presented to the Election Board by 9:00 A. M., on the third Wednesday after the first Monday of the fall term of school. No student may sign more petitions than there are representatives to be elected from his class.
- (b) The Election Board shall consist of the President of the Student Body, the hold-over members of the Student Council, and one of the regularly appointed faculty class advisers who shall be designated by the President of the College for each of the four classes.
- (c) The Election Board shall announce all nominess at once, and shall appoint five persons for each class to supervise the election.
- (d) The election shall be held by secret ballot from 10:00 A. M. to 12:00 M., one week after the final date for presentation of petitions, each class having a separate voting place. Nominees shall be listed in the order in which their petitions are presented. Each candidate shall be entitled

to a challenger within the voting room. In elections to choose representatives for terms of varying lengths, candidates receiving the largest number of votes shall receive the longer terms.

(e) The Election Board shall count the votes immediately after election. All protests shall be filed with the President of the Student Body within one week after the election and shall be considered by the Student Council.

(f) When vacancies occur in the representation, such vacancies shall be filled by the body represented as heretofore provided.

(g) Any member of the Student Council or officers of the Student Body with the exception of the Student President may be removed from office upon a three-fourths vote of the Student Council. Charges shall be preferred by any member of the Student Body. The charges shall have been brought two weeks prior to the date of the vote, and each member of the Council shall be notified of the nature of the meeting at least one week prior to the date of the meeting.

Section 4. The first regular meeting of the Student Council shall be held the day following the election of Council members. At this meeting the Council shall designate the time of its meetings. The Student Council shall meet regularly every two weeks following the initial meeting, except during vacations. Nine regular members present at any meeting shall constitute a quorum.

Section 5. The Student Council shall have the following powers and duties:

(a) To conduct during the college year four assemblies, which may or may not include such assemblies as may be necessary for the election of the President of the Student Body.

- (b) To elect the editor-in-chief and business manager of The Mirabilia upon recommendation of the retiring editor and business manager.
- (c) To arrange for the publication and circulation of a yearly handbook containing the constitution of student government, traditions and laws of Marshall College, and such other material as may seem advisable. The publication of this handbook may be delegated from year to year to college organizations at the discretion of the Council.
- (d) To present awards in the name of the Student Body.
- (e) To make and control freshman rules provided that enforcing authority may be delegated to an organization composed of students who indicate their desire to participate in enforcement by presenting their names to the President of the Student Body. Only students whose scholastic average the previous year at Marshall College has been C or better shall be eligible for membership in this enforcement organization.
- (f) At its discretion, the Council may draft a point system for student offices.
  (g) To approve the appointment of a Council editor of The Parthenon, who shall be an ex-officio non-voting member of the Council and a regular member of The Parthenon staff.
- (h) The Council may at any time ask an explanation of policies of college pubcations if the said policies seem contrary to college interests, and may recommend the removal of staff members.
- (i) The Student Council, as representative of the Student Body, shall have the power, subject to the approval of the Administration and the State Board of Education, to enact rules and regulations in all matters of student activity not strictly academic, and shall have the further pow-

er to enact rules as may be necessary to carry out the provisions of this constitution.

#### ARTICLE II-EXECUTIVE

Section 1. Nominations for the office of President of the Student Body of Marshall College shall be made at the first regular meeting of the Student Body in May of each year. There shall be at least two nominees for the office of President. all nominees being academic Juniors. The President of the Student Body, upon the assumption of his office, shall be an academic Senior. A secret ballot shall be taken one week from the date of nominations and in case no candidate receives a majority, another ballot shall be taken one week later on the two candidates having the highest number of votes. A majority shall be necessary for election. The election for Student President shall be conducted by an Election Board appointed by the President of the Student Body, provided that each candidate shall be entitled to a representative on the Board. Each candidate shall also be entitled to two challengers within the voting place. If the President be ineligible at the time of his assumption of office, the vacancy shall be filled by a regular election as provided for above, to be held the third week of the fall term of school.

Section 2. To remove the President of the Student Body, a petition signed by twenty-five per cent of the Student Body shall be submitted to the Student Court, at the discretion of said Student Court, a new election may be called at which the President may stand for re-election. If the Student Court does not consider that there are grounds for calling a new election, any further action to remove the President shall require a petition signed by fifty per cent of the Student Body. This petition will automatically call a new election.

Section 3. The President of the Student Body shall have the following powers and duties:

- (a) Preside over all Student Council meetings, and call special meetings when he deems it necessary. He shall vote in th Council only in case of a tie.
  - (b) Appoint all special committees.

(c) Appoint two members of the Student Body on the college Athletic Board, two on the college Social Activities Committee, and three on the college Assembly Committee. Each of these appointments shall be confirmed by the Student Council.

(d) The Student President shall act for and represent the Student Body on all

official occasions.

Section 4. The Student Council at its first meeting shall choose from its membership a vice president who shall have the same qualifications as the President, a Secretary, a Treasurer, and any other officers deemed necessary.

Section 5. The powers of these Council

officers shall be as follows:

(a) The Vice President of the Student Body shall assume the powers and duties of the President in the absence of, or at the request of, the President of the Student Body

(b) The Secretary of the Student Body shall write and preserve records of all Student Council meetings. At the end of the Secretary's tenure of office, he shall deliver to the President-elect his records, which shall in turn be entrusted to the new

duly elected Secretary.

(c) The Treasurer of the Student Body shall be in general charge of all collections and disbursements of the finances of the Student Body; said collections and disbursements to be authorized by the Student Council. Two weeks before the end of his tenure of office, the Treasurer shall present his records to the College Auditing Committee.

Section 6. Elections for all class officers shall be held by secret ballot at the same time and under the same supervision that Student Council representatives are elected. Presidents of classes shall be nominated by petitions of ten per cent of the membership of their respective classes. class shall also elect a vice president and a secretary-treasurer, candidates for which shall be nominated by filing an announcement of candidacy with the Election Board. All class officers must be academic members of that class, and petitions for president and announcements for other officers shall be presented to the Election Board not later than the final date for Student Council petitions as set forth in Article I, Sec-

ARTICLE III-STUDENT COURT

Section 1. There shall be a Student Court composed of three faculty members appointed by the President of the College and four students appointed by the President of the Student Body and confirmed by a two-thirds majority of the total membership of the Student Council. Of these student members, all of whom shall be academic Juniors or Seniors, one shall be a fraternity man, one a sorority woman, one a non-fraternity man, and one a non-sorority woman. The Court shall meet within a week after the organization of the Student Council and shall elect its own officers. At this first meeting the Court shall designate the time of its meetings.

Section 2. The powers and duties of the

Student Court shall be:

(a) To consider cases of dishonesty, breaches of social etiquette, infringements of college traditions, and all matters contrary to the best interests of the college.

(b) The Court shall have final judgment as to the constitutionality of acts of the Student Council and as to the interpretation of this constitution.

(c) To render decisions and pass sentences concerning all matters before it. Section 3. All college organizations shall submit a report of any social function, through the highest ranking official of the organization present, to the Chairman of the Student Court within four days after the function. Regulation forms shall be provided for this purpose, and any organization failing to make a report shall be held responsible as well as such individuals as may have been delinquent.

Section 4. All students and faculty members shall be privileged to prefer charges or submit reports to the Student Court concerning any matter within its jurisdiction.

Section 5. The Court shall, as individuals.

take the juror's oath of secrecy. No records except final decisions of the Student Court shall be recorded and preserved. Final appeal in all matters may be taken to the President of the College.

#### ARTICLE IV—AMENDMENTS AND BY-LAWS

Section I. Amendments to this constitution may be proposed either by the Student Council or by a petition signed by ten per cent of the members of the Student Body.

Section 2. Amendments to this constitution shall become valid and integral parts of the constitution through ratification by a two-thirds majority of the members of the Student Body at a meeting called for that purpose, or by a two-thirds vote of the ballot upon the proposed amendment. The method of voting shall be decided upon by the Student Council.

Section 3. An amendment must be proposed at least two weeks before action can be taken upon it. The proposed amendment shall be given public notice on the college bulletin board or advertised in the college newspaper at least ten days before a vote can be taken.

Section 4. By-lays and rules of the Council may be adopted or amended by a majority vote of the Council, provided that the matter shall have been submitted in writing at a previous meeting. By-laws or rules may be passed by unanimous consent without having been previously submitted.

#### ARTICLE V-DATE OF EFFECT

This constitution shall become effective upon its ratification by a two-thirds majority of the Student Body voting, provided that previously elected members of the Student Council, President, Vice President, Secretary, and Treasurer of the Student Body, and class officers shall serve out their full terms.

# A BRIEF HISTORY OF THE COLLEGE

"Marshall Academy" was established in 1837, shorty after the death of Chief Justice John Marshall, of the Supreme Court of the United States, in whose honor the school was named. It was organized as a private institution. In 1856 the work of the Academy was enlarged and reorganized, and the name changed to Marshall College.

But little information concerning the early days of the institution is now at hand. None of the records of the school during the time it was an academy are preserved. From the year 1867 to the present time, however, we have a fairly satisfactory

record.

At the close of the Civil War a number of the leading citizens in the southwestern part of the new State of West Virginia succeeded in having the legislature take it over as a "State Normal School." Though "Normal" in name, it was wholly academic in its work, and such it remained, with varying fortunes, save a little teaching of pedagogy, school management, and the like, until 1897,

when a practice school of one grade was organized. This the State refused support; and, accordingly, it was abandoned after two years of unappreciated effort, and the school went on again wholly as an academic institution.

In January, 1902, the Department of Education was organized, and a practice school for teachers was opened. In February, 1920, by action of the State Board of Education, the institution became a State Teachers College, conferring its first degrees in June, 1921.

Under authority of the State Board of Education, a further expansion of the institution was effected in June, 1924. At that time the College of Arts and Sciences was formally organized. With the College of Arts and Sciences are affiliated the two-year course in engineering, and the pre-medical and the pre-law courses.

#### PAN HELLENIC ASSOCIATION

Sorority activities at Marshall College are governed by the Pan Hellenic Association, composed of representatives from each sorority on the campus. Pledging and rushing are governed by the following rules:

- 1. No girl shall be initiated into a Pan Hellenic sorority until she has been a student at Marshall College for at least one semester, and during that time maintained an average of C or more in at least 12 hours of college work.
- 2. Rush week is the fourth week in each semester beginning Monday at 8:00 A. M., and ending Saturday night at 12:00 o'clock. After three weeks of silence from the day of pledging, there shall be open bidding. (That is, a sorority may bid a person at its will, but no parties are to be given.)
- 3. Invitations to rush parties must not be given before the Wednesday preceding rush week.
- 4. Rushees shall designate their preference of sororities to a designated member of the faculty who will notify the sorority of the acceptance.
- 5. Individual rushing prior to rush season is forbidden.

- 6. Any pledge of a sorority dropping a course within a month prior to examinations taking place just before initiation time will be considered as failing the course dropped.
- 7. A mass meeting of possible rushees will be called by the Dean of Women just before rush season opens. All rushees must attend this meeting.
- 8. Silence shall be maintained between rushees and sorority members from Saturday at midnight at the close of rush week until the following Monday at 3:00 o'clock in the afternoon.

The Pan Hellenic Constitution is being revised, and representatives from the sororities are unavailable at press time.

2. Bids shall be extended between the hours of 7:00 and 11:30 P. M., Saturday evening of the third week.

- 3. A strict period must be observed by all fraternities from 12:00 A. M., of the third Sunday until 7:00 P. M., of the following Monday. During this time there shall be no communication between the fraternities and any Matriculate.
- 4. At the close of the silent period the Matriculate shall accept the bid of the fraternity he chooses by going, by his own free will, to the house of the fraternity.
- 5. A pledge to any fraternity must be a qualified student of Marshall College and carrying at least 12 hours of college work at the time of pledging.
- 6. Any Matriculate renouncing his fraternity pledge shall not be extended a bid by any other fraternity until the following rush season. Any pledge being officially dropped shall be free to be pledged by any other fraternity.

7. In case of infraction of any rule or law stipulated by this council, the offender shall be tried by the council, and in case of a trial a faculty member shall act as judge, leaving to the council the power to give penalty.

#### CONSTITUTION OF THE INTER-FRATERNITY COUNCIL

#### PREAMBLE

In order to effect an organization which shall assist in the creation and maintenance of higher college spirit and a higher standard of social and business activities among the fraternities of Marshall College, we the undersigned fraternities and such fraternities as may hereafter be admitted to this agreement do pledge ourselves to keep the provisions of this Constitution.

ARTICLE I-NAME

Section 1 .- The name of the association of fraternities under this Constitution shall be the Inter-Fraternity Council of Marshall College.

ARTICLE II-POWERS The Council shall have power:

Section 1. To make and amend by-laws. Section 2. To levy special assessments on fraternities, as a group, for Council purposes; such assessments must be passed by a unanimous vote of member fraterni-

Section 3. To adopt resolutions governing policies of inter-fraternal interests of

the member chapters.

Section 4. To enforce its laws and regulations by the infliction of penalties as provided in the by-laws.

ARTICLE III-MEMBERSHIP

Section I. All social fraternities of Marshall College which have been duly recognized by the proper College authorities and which have been approved by a unanimous vote of the Council, may become members of this organization by subscription to this Constitution and by-laws.

Section 2. The members of this group shall consist of three representatives from each fraternity having membership in the

Council.

Section 3. Each fraternity shall be entitled to one vote in Council meeting.

Section 4. Each fraternity shall have the right to call in any of their members at any time for advice on any matter of discussion.

ARTICLE IV-EX-OFFICIO MEMBERS

Section I. The Dean of Men shall be ex-officio member of the Council.

Section 2. The duties of the Dean of Men shall be to attend all meetings as adviser

ARTICLE V-OFFICERS

Section 1. The officers of this Council shall be. President, Vice President, and Secretary-Treasurer.

Section 2. The term of officers shall be for one school year.

Section 3. These officers shall be from the regular membership of the Council and shall be elected the last meeting of each year. Roberts Rules of Order shall govern the form of proceedings.

Section 4. A simple majority vote of all members of the Council shall elect the offi-

cers of the Council.

Section 5. The President shall preside at all meetings of this Council, appoint all committees subject to the approval of the Council, and perform the usual duties pertaining to that office. He shall notify all members of the time and place of meetings. He is empowered to call special meetings at his own discretion or as in Article VI, Section 2, providing that he gives all members twenty-four (24) hours notice of such meetings.

Section 6. The Vice-President shall assume the duties of the President in the

absence of that officer.

Section 7. The Secretary-Treasurer shall keep all records of the proceedings of the Council, and shall take charge of all dues and assessments levied by the Council. He shall keep an intelligible set of books -open to inspection at any time by any member of this Council.

#### ARTICLE VI-MEETINGS

Section 1. Meetings shall be on the second Thursday in each month of the school vear.

Section 2. Special meetings shall be held at the petition of three member fraternities. Section 3. Representatives from a majori-

ty of the member fraternities shall consti-

tute a quorum.

Section 4. A majority vote of members present is necessary in order to decide any question, except amendments to the Constitution when a unanimous vote of member fraternities is necessary.

#### ARTICLE VII-AMENDMENTS

Section 1. (a) Amendments to the Constitution shall be presented to the Council at a regular meeting by the petition signed by at least three members of the Council. They shall then be presented, in writing, to the various organizations for ratification, which ratification or rejection must take place within the time before the next regular meeting after presentation.

(b) Amendments to the Constitution shall become effective upon unanimous ratification of the member organizations. Section 2. By-laws may be made or amended by the Council at the same

meeting they are presented by a unani-

mous vote of members present.

#### ARTICLE VIII

This Constitution shall become effective upon the ratification by the following organizations:

Alpha Kappa Pi, Alpha Theta Chi, Kappa Alpha, Phi Kappa Nu, and Phi Tau Alpha.




