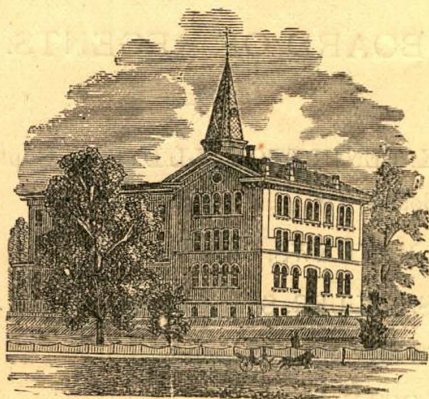

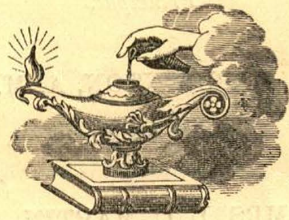

GENERAL REMARKS.

Reports.

Monthly "Reports" will be addressed by the Principal, to the parent or guardian of each student, in which are stated his attention in class, supposed industry, proficiency in each of his studies, absences from lectures and recitations, and his general deportment, with such other information as may be necessary to communicate.

Buildings.

Our building consist of a main building, 40x70, and one wing, 30x110, both three stories high, all fitted up and furnished in the best manner.

Apparatus.

The School is now furnished with a good selection of Philosophical and Chemical Apparatus; a Geographical Clock; Terrestrial and Celestial Globes; Harper's Primary School Charts; Warren's Geographical Charts; McGuffey's Reading Cards and Mitchel's Outline Maps.

Library.

The purchase of fine hundred additional volumes within the last year, has given us a Library that cannot but be valuable to Students. It contains many works of reference—Biography,

History, Travels, Fiction, with a Cyclopædia of forty-seven volumes.

Text Book.

All Text Books and Stationery needed in the School can be procured here at the lowest retail prices. Students should bring with them any books which they may possess; but are advised not to purchase any new ones till they arrive at the School.

Moral and Religious.

This institution being designed to serve the interest of all classes in the State, is, and always must be, unsectarian. All forms of private religious convictions will be respected. But while the sectarian part of religion is held in abeyance, sound morality and those great principles of revealed religion, on which all sects are substantially agreed, will receive due attention. The highest type of character is the intelligent Christian; to this all students will be urged to aspire. A Student who does not possess and maintain a good moral character will not be allowed to remain in connection with the Institution.

Nine separate Church Organizations in the city of Huntington give each pupil the opportunity of worshipping in conformity with the peculiar tenets of the church in which he was reared.

Physical Culture.

A good *Gymnasium* has been erected to secure healthful daily exercise and recreation for all male students, and it is proposed to so extend this department, as to include training in the use of the vocal organs, and in the movement and manners as connected with oratory.

Ample Croquet Grounds and daily walks, under the supervision of Lady Teachers, furnish opportunities for the exercise and recreation of female pupils.

Students' room are furnished with stove, bedstead, mattress, wash-stand, table, two chairs, washbowl, pitcher, pail, looking-glass, lamp, and window blinds. *Bed clothes and all other articles of room furniture, other than those mentioned above, must be furnished by the Student.*

Board may be procured in private families in the vicinity. at from \$3 50 to \$5 00 per week. Board bill payable one-half at the beginning, the other half at the middle of the term.

A large room has been fitted up as a Mess-hall, and those desiring it will be permitted to organize a Mess, which will materially reduce the cost of board. The cost of board to the Mess of the present year has been \$1 25 per week, for each member.

Location.

The School Buildings are situated about one mile from the business portion of the young and rapidly growing city of Huntington, in the centre of a butifully elevated plat, containing about fifteen acres, almost surrounded by primitive forest trees. Accessible by of means Ohio River Steamers and Chesapeake and Ohio Railroad.

Students will examine carefully, the subjoined Regulations, as conformity to their letter and spirit, is a condition upon which students are retained in the School. All students are expected :

1. To be present and prompt at every required exercise.
2. To be orderly and quiet in and around the buildings.
3. During recitation, to confine attention to the lesson.
4. To make an honest effort to learn every lesson.
5. To keep rooms neat and clean.
6. Not to smoke in and around the building.
7. To dring no intoxication liquor, while in attendance upon the School.
8. To put out lights within twenty minutes after the retiring bell rings.
9. In case absence becomes necessary, to obtain leave before the absence occurs.

10. Not to visit rooms of other Students during study hours, without express permission.
11. Students boarding in the hall are not to visit families in the neighborhood without permission.
12. To throw nothing from the widows or balconies
13. To use the school furniture with care and pay for all broken.
14. Gentlemen not to visit ladies' rooms, or ladies the rooms of gentlemen, for any purpose whatever.
15. Ladies and gentlemen not to walk or ride out together, without special permission.

RULES AND REGULATIONS

OF THE

State Normal School

AND ITS BRANCHES.

The Board of Regents of the State Normal School make and ordain for the government of the same, the following Rules and Regulations, in accordance with section 88 of the School Law :

RULE 1st. The Teachers of each Normal School shall consist of a Principal and as many Assistants as may be necessary to conduct the several department established therein.

2d. The Principal and Assistants shall be appointed by the Regents at their annual meeting in June, and shall continue one year, unless for cause removed.

3d. Seventy Normal Scholars shall be appointed to each school, but no school shall be required to maintain an average of more than fifty-eight.

4th. The number of Students which each County in the State shall be entitled to appoint to the Normal Department in the State Normal Schools, free of charge for tuition, shall be as follows :

5th. Applications for appointment to the Normal Department of the State Normal Schools shall be made to the Superintendent of Free Schools of the County in which the applicant resides; and said Superintendent shall select such number as may be entitled to the privileges of the Normal Schools in his County in the foregoing apportionment.

6th. When any County shall have failed to make application on or before the first day of any yearly session of the State Normal School, or any branch thereof, for the full *quota* of pupils assigned to it, in the last apportionment of the Board of Regents, the Principal of any of the said Schools, may then, or at any time during the year while said failure continues, fill up the deficiency by admitting any duly certified Applicant from the Judicial Circuit at large, to which the County belongs, with the privilege of attending during the School Year in which they have been admitted.

7th. As far as practicable, males and females shall be selected in equal proportion. Male pupils must not be less than fourteen, and the females not less than thirteen years of age.

8th. Every certificate of appointment to the Normal Schools of this State shall be directed to the School which the applicant may desire to attend. The County Superintendent making such appointment shall at once notify the Principal of said School of such appointment. The Executive Committee of said School shall, subject to appeal to the Board of Regents, have power to

vacate any appointment or certificate, for non-attendance, inaptitude to learn, immorality, or other good cause. In case of a certificate being thus vacated, the Executive Committee shall notify the Superintendent, who issued the certificate, of such vacation: whereupon, if no appeal is taken to the Board of Regents within twenty days after the action of the Executive Committee, he may make an appointment to fill the vacancy thus created. Every County Superintendent shall keep a record in his office of all the appointments made by him.

9th. No applicant for appointment shall be appointed by a County Superintendent, unless he, or she, be of good moral character, and shall sustain a good examination in reading, spelling, elementary arithmetic, geography, and elementary English grammar. Said examination may be made either by the County Superintendent, or the Principal of the School, which the applicant desires to attend.

10th. The County Superintendent shall require of each applicant appointed, to subscribe the following declaration:

"I, _____, do declare that it is my purpose to become a teacher in the Free Schools of West Virginia, and do solemnly promise, if admitted to the Normal School of said State, I will on completion of the prescribed course of studies, and within two years thereafter, spend one year in teaching in the Free Schools of this State, at the usual rates of compensation paid in the Schools, where my services may be rendered."

This declaration shall be indorsed by the father, guardian, or some responsible person for the applicant, as follows: "I agree, in case of the failure of _____, the within named applicant, to comply with the provisions of this declaration, so far as it requires him, or her, to spend one year in teaching in the Free Schools of this State, to cause to be paid to the Treasurer of the Executive Committee of the School which he, or she, may attend, tuition at the regular rate, for such time as said applicant shall have been in attendance at said School.

"Given under my hands this — day of — 18—.

"A _____ B _____."

Thereupon he shall give such applicant the following certificate:

"The bearer, _____, having been duly examined, has sustained a good examination, and being of good moral character, is hereby appointed to receive instruction in the Normal School of this State, from _____ County, West Virginia."

11th. Each appointee shall deliver his, or her, certificate and declaration, to the Principal of the Normal School, he, or she, attends, who shall file the same with the archives and records of the school, and enter the name of such person on the register of normal pupils.

12th. Whenever the accommodations thereof will admit of the same, so many paying students as can be accommodated therein from this State, or any other State, may be admitted to the Normal School, giving preference to citizens of this State, whether they desire to become teachers or not.

13th. State students in any Normal School, may, upon request, be transferred to another, procuring a certificate of good deportment from the Principal of the School he is attending, or by permission of the Board of Regents, but not otherwise, and the time he has so attended, shall be credited to him in the course, by the Principal of the School to which he is transferred. *Provided*, he brings with him his certificate of appointment with time of attendance endorsed upon it by the Principal of the School whence he comes.

14th. The Normal Course shall consist of three years, and shall embrace the three classes: Junior, Middle and Senior.

Orthography—Webster's Prim. Dictionary, Westlake, or Hinkle's Test Speller.

Reading—McGuffy's Sixth Reader, or Kidd's Rhetorical Reader

Writing—The Eclectic, or Spencerian System.

Arithmetic—Beginning with Fractions and completed. Ray's or Brooks'.

Geography—Maury's, or the Eclectic, or Mitchell's (W. Va Ed.)

Language Lesson and Elementary English Grammar—Reed and Kellog's, or Swinton's.

History of the United States—Ridpath's, or Venable's.

Regular Exercises in Composition and Declamation.

THE MIDDLE YEAR shall embrace:

Orthography—By Written Exercises.

Reading—With special attention to Tone and Utterance.

Sentence Analysis and Prose Composition—Hart's, or Pinneo's.

15th. The Board of Regents will confer upon those who complete the Senior Year, and pass an examination upon the studies of the same, equal to seventy-five per cent of the questions asked, a Normal Diploma, with the title of Normal Graduate.

16th. If for any cause, save incapacity, a pupil may not be able to complete the course in the time prescribed, said pupil

RULES FOR THE GOVERNMENT OF PUPILS.

1st. Each scholar shall attend the daily sessions of the School and said session shall not be less than six hours.

2d. The daily sessions shall be opened with such devotional and other exercises, as the Faculty may establish.

3d. No student shall leave the school room, without the instructor's permission.

4th. Whispering, unnecessary moving about the room, and laughing, talking or disturbing noises are prohibited.

5th. All defacement of the walls, seats, desks or other property of the Schools, is prohibited.

6th. Care of clothing, books and person is enjoined on students.

7th. Polite and-respectful deportment, is required of all, both in and out of School.

8th. Students shall not be permitted to leave the School grounds during school hours, without giving satisfactory reasons.

9th. When studies have once been assigned a pupil, they will stand until changed or modified by the Principal. Each student shall have at least three studies.

10th. Students will have access to the School building, only in School hours, without the Principal's permission, and will always be held responsible for damage done.

11th. All damage, destruction or waste, committed by a student shall be repaired at the expense of the perpetrator.

12th. Students shall attend all recitations and examinations, and no pupil shall go on with his class, until he has passed said examination.

13th. Students are forbidden to visit all places where intoxicating drinks are sold as a beverage, under the penalty of suspension or dismissal, as the Faculty may direct, with the approval of the Executive Committee.

14th. Pupils shall not visit or receive company during the nights of school days, after the hour appointed by the Faculty for study, except by the written permission of their parents or guardians, or by special permission of some member of the Faculty, who must make a note of the same and report to the Principal.

15th. The carrying of fire-arms or any deadly weapon is strictly forbidden. The violation of this rule, shall subject the offender to the severest penalty of the School. The playing of cards, or the bringing of them on the School grounds, is prohibited, and any violation of this rule will be punished by suspension or expulsion, at the discretion of the Executive Committee.

16th. Students absenting themselves without proper permission, will be required to explain their absence. It shall be the duty of each student to render his or her excuse for absence, as early as possible, to the proper officer, *and without being called upon*. If any student shall neglect to do this, and shall suffer three days to pass without rendering said excuse, it shall not be received without a special vote of the Faculty.

17th. Pupils who are absent from recitation without excuse, shall be required to recite said recitations upon their return to class.

18th. In all cases, where a student attending a recitation, is not prepared to recite. it is his, or her, duty to make it known before the commencement of the exercise, to the Teacher who conducts it. Should he or she fail to do so, he cannot afterwards be excused on the lesson.

19th. Such excuses as the following are deemed inadmissible, viz: Not hearing the bell; not being able to prepare the lesson; being out late the preceding evening; writing letters, or preparing School or Society exercises; mislaying books or articles of apparel; interruption by students or other visitors. If any of these excuses are ever admitted, it must be beforehand, and from some peculiarity in the circumstances of the case: *and in general an excuse is not to be received after an absence, when the student might have applied beforehand for leave of absence, even though the excuse in itself be sufficient.*

DISCIPLINE.

The methods of discipline shall be:—

- 1st. Private admonition by the Principal.
- 2d. Admonition by the Faculty.
- 3d. Admonition before the whole school.
- 4th. Suspension.
- 5th. Dismission from School.

The scale for demerits shall be for each offense, as follows:

Absence from roll call without excuse.....	1

Ten demerits in any one month, to receive admonition from the Principal; twenty, from the Faculty; thirty to be admonished before the School; and forty to be reported to the Executive Committee for their action.

Striking in anger, any pupil, except in self-defense, or in resenting a gross insult, shall be punished by suspension or expulsion, at the discretion of the Executive Committee. Striking a Teacher, or conviction of felony, shall be punished by expulsion.

The commission of any misdemeanor against the law of the State, shall be punished by suspension or expulsion, as the Executive Committee may direct.

In all cases of expulsion, an appeal to the Board of Regents may be taken.

THE FACULTY AND THEIR DUTIES.

1st. The Principal and his assistants shall be known as the Faculty, who shall meet at the call of the Principal.

2d. The Principal, in addition to his duties as Professor, shall be the Executive officer of the School, and shall sign all reports and other official papers. He shall have general supervision over the school, and shall assign to the assistant teachers, the classes and studies which they are to teach, and to the pupils, the studies they are to pursue, and shall determine what tests shall be required to complete said studies. He shall fix the order and methods of all examinations, and shall require of his assistants, that they so manage their classes, that the pupils may have an opportunity of completing the course in the time prescribed. He shall fix the scale of grading to be used in the School, and how often reports of Scholarship and attendance shall be made, and shall make all required reports to the proper officers.

3d. The Assistant Teachers shall form the "Advisory Board" of the Principal, and their opinions shall, at all times, be treated with respect. In the absence of the Principal, the first Assistant shall act as Principal.

4th. Each Professor and Teacher shall be held responsible for the conduct and progress of the pupils under his immediate instruction, and shall require strict obedience to the Rules and Regulations at all times.

5th. The Faculty shall have the care, government and instruction of the pupils, under the Rules and Regulations; they shall devote their time to their duties, and engage in no business that

will impair their faithful performance thereof; but the Principal or any Teacher shall collect tuition fees, when required to do so by the Treasurer and Executive Committee.

6th. The Principal shall as soon as practicable after the beginning of the School Year, make out a classification of the Pupils, according to their respective studies, and in due season, publish the same in a catalogue, with such other general information and announcements pertaining to the School, as may be of public interest. He shall also furnish to the Regents, a list of the candidates for graduation, designating the paying from the non-paying Pupils, and giving the age and grade of standing of each candidate, with the names of the studies in which they have been examined.

7th. The Principal of each Normal School shall have full power to regulate the social intercourse between the young ladies and gentlemen of the School in such a way as he shall deem best for the interest of the School and the parties concerned.

DUTIES OF EXECUTIVE COMMITTEE.

1st. It shall be the duty of the Executive Committee to exercise proper care over the buildings, grounds and property of the School; keep them in good repair, prevent all damages, and demand indemnity for the same; see that school-rooms are properly warmed, ventilated, and kept clean and comfortable.

2d. They shall audit all accounts against the School, determine all matters of expenditure not provided for by law or otherwise, and, in all emergencies, exercise such executive authority in the absence of the Regents as the law permits, and order the payment of expenditures as they occur, from moneys received from the State or on account of tuition, and incidental fees.

3d. They shall elect from their own body a Secretary and Treasurer.

4th. The Secretary shall keep a record of the proceedings of the Committee; shall enter therein all moneys received by the

Treasurer or Executive Committee, and at all times subject his record for examination by the Faculty, the Executive Committee, or the Board of Regents.

5th. The Treasurer shall receive all money drawn by the Executive Committee from the State or derived from tuition and incidental fees, pay it out by order of the Executive Committee, and report to the Board of Regents at the close of the School Year; he may, with the approval of the Executive Committee, designate the Principal or other Teachers, as Collector of the tuition and incidental fees, but such Collector shall pay the same over to the Treasurer as received, and take his receipt therefor.

6th. The Executive Committee shall visit the School from time to time, note the progress of Pupils, their conduct, the modes of instruction, and inspect the buildings, furniture and fittings.

7th. The Executive Committee shall prepare and present to the Board of Regents at their annual visit, a Report, showing in detail the amount received from all sources and the amount disbursed for all purposes by them during the year, with such other information as will show the operations, condition and wants of the School.
