This spring's state Election Laws study has moved into Administration and Enforcement, looking toward a good workshop on Election Laws in September. We have had useful meetings with the County Court Clerk, the County Attorney, and the County Court, with others yet to come.

Subjects stressed by officials to date are: difficulty in staffing precincts with fully trained officers, problems of improper registration under present law, weakness in absentee ballot procedures, and general lack of citizen knowledge on how to influence election processes.

An impromptu study of the response came up with some interesting facts on which groups were most likely to sign. Most well-dressed business men signed readily, as did older women. Does that last statement suggest to you that we may not be reaching that group as well as we should? Bears thinking about, doesn't it?

WATER RIGHTS

One of the agenda items contained in Governor Moore's call to the 1970 session of the Legislature was an item pertaining to a comprehensive water use act. The bill was passed by the Legislature and then vetoed by the Governor. It is reasonable to expect that the bill will be introduced again in the next session. Under the national position on water resources the League of West Virginia may take action on the matter of water use. To guide the State Board in the kinds of action they may take the State Water Chairman would like to have the thinking of the members of this League on rights to water use.
