NATIONAL CONVENTION REPORT

From May 4 to 8, the National Convention of the League of Women Voters of the U.S. convened in Washington, D.C. Nancy Matthews, State Board, and Helen Gibbins, Local Board, attended.

Some of the important national by-laws changes were:

1. voting members of the League shall be at least 18 years of age.

2. the program shall include "action to protect the right to vote of every citizen", (thus permitting Leagues to support Voting Rights laws in states.)

The national program adopted for study for the next two years includes:

- 1. Evaluation of measures to achieve and maintain a physical environment beneficial to life with emphasis on relationship of population growth and distribution. (Air pollution will be the first area for consensus.)
- 2. Evaluation of further measures to combat poverty and discrimination (consensus to be taken first on income maintenance.)
- 3. Evaluation of Congressional structures, procedures and practices and their effect on responsive legislative processes.

We also kept our support positions on water, equal opportunities in education, employment and housing, foreign policy (trade, aid, China and the U.N.) and representative government (Electoral College reform, self-government for Washington, D.C. and apportionment in legislatures.)

Other actions outside of the regular business agenda included;

1. The Convention recessed to allow those League members who so desired to attend a peace vigil at the Capitol. (Those who attended did not wear tags identifying themselves with the League.)

2. The Convention held a rally in support of Congressional representation for Washington, D.C. Afterwards the West Virginia delegation held an interview with Senator Randolph and presented him with the petitions for Congressional Representation for D.C.

There were then governmental briefings -- I attended one on the new Environmental Council, water pollution and air pollution, and Nancy attended one on Revenue Sharing.

Many League members, including Nancy and me, visited our Congressmen. On Thursday the League proposed that a letter be sent to President Nixon stating its concern about the national crisis.

After business sessions at night there were caucuses on issues and small meetings concerned with Human Resources, membership, etc. The high-light of the "extras" was the Bookstall, which included publications from Leagues all over the U.S. and some marvelous slide programs produced by local Leagues.
