Rationale: 1. The class was initially created with doctoral candidates in mind and had reasonable enrollments when both CI and LS doc candidates had an area of emphasis/ specialization in their plans of study. LS candidates no longer have an option to take this course. 2. The last few times the course was offered it included about as many MA students in the Instructional Technology emphasis as CI doctoral students. A 600 level number would be more appropriate for MA candidates and wouldn't hurt doctoral candidates as an area of emphasis course.

Catalog Desc: This course offers participants the opportunity to explore strategies and issues related to the development and delivery of online courses.
