CONSTITUTIONAL REVISION

The concluding sentence of an editorial deploring the discrepancies between salaries paid judges and fees collected by some Justices of the Peace in a recent Herald Dispatch gives a perfect lead in for our units on study of the Constitution of West Virginia and proposed revisions "which provide effective government responsive to the needs of the people of West Virginia." It reads, "No pillar of democracy is more vital than the judiciary and it is everybody's job to see that it remains strong and immune to pressures of every kind."

So though we may be inclined to leave the courts to the lawyers it behooves us to inform ourselves about our court system and the selection of judges and what changes the Constitutional Reyision Commission has recommended in its progress report to the 1961 legislature.

Local leagues have been asked to reach concensus by the first part of November on the questions listed in the last State Voter. If hearings are held on the Judiciary Article during the 1962 session, the League will then be able to express an informed opinion.

PROGRAM IN THE LAKING

Since we have been asked by the State League to reach concensus regarding the Judiciary Article, perhaps we should review what it means for the L.W. It is not decided through a poll or vote of the membership; instead it is an interpreta- ... tive process of group opinion. In League parlance it means agreement among a substantial number of a representative group of members (not just a simple majority) reached after sustained study and group discussion. Concensus if a prerequisite to our taking any position on national, state or local governmental issues. It determines what action, if any, is to be taken on the item under consideration, It begins with program making where members either at annual meetings or through their delagates at state and national conventions select a program which they believe warrants League study and action.

Local and State Presidents: "The 25th convention of the League of Women Voters will be held in Minneapolis from April 30 to May 4, 1962. The Convention : shall consider and adopt a program, elect officers and directors, adopt a budget, and

transact such other business as may be pre-

sented.

The question is sometimes raised regarding whether concensus exists if only 50% or less of the members participate in reaching agreement. If all members were given the opportunity to participate, if the item was presented adequately from the aspects of content (varying points of view) and procedure, the answer is yes. The absent cannot hold back the active in the League any more than those who stay home on Election Day can expect to control the wishes of those who go to the polls.

Between now and November 30th, the deadline for first round national program suggestions, every member has a distinct responsibility.

October's general meeting and the units following afford the individual member another opportunity to participate in formulating concensus on one aspect of Constitutional Revision. The member can come to the unit prepared for discussion after hearing a report by Roberta Emerson and after reading the State League publication prepared by Dot Wehrle and her committee. Then if the membership is informed, its thinking crystallized and its impulse to action ripe, legislative action may follow.

For each of the 132,000 members the responsibility is to think through and then voice her best judgement for a national program on which she wishes to work during 1962-64.

the membership of the League of Women Voters then by its reflective examination, study, discussion and evaluation of its program has reached that cherished position of concensus which is its discipline

we must work together in the months to come to find the best way in which the LWV can function in our complex society. At this particular time in world history the signifigance of free choice can not be over-emphasized. Here is the place wherebach of us, as members of a democratic organization, operating in a democratic society, can make a contribution by choosing for 1962-64 a program that will be the best possible vehicle through which to accomplish the purposes of the LWV in the next two years.
