The luncheon will cost \$2.50, and your 1971-72 dues of \$7.50 may be paid at the meeting. The members will be voting on the budget, officers, by-laws changes, and selection of program. Reports on all these items are in this bulletin.

#### SPEAKER FOR ANNUAL MEETING

Mr. Joseph Kowalski, a city planner, will be the speaker for our annual meeting. Two years ago Mr. Kowalski presented a program to the League concerning the problems of our area due to poor or lack of planning. At the meeting this year, Mr. Kowalski will discuss planning and how it relates to the Huntington area. In general, there is a lack of public understanding of the total scope of planning. Mr. Kowalski's talk will be directed to helping the League understand various areas for reform.

#### BOARD RECOMMENDED BY-LAWS CHANGES

Article III, Sec. 2. From "Voting members shall be women citizens of voting age"
To "Voting members shall be women citizens at least 18 years of age."

Article IX, <u>Program</u>, <u>From</u> "Sec. 2. <u>Program</u>. The Program of the League of Women Voters of the Huntington Area shall consist of those local governmental issues chosen for concerted study and action.

Sec. 3. Current Agenda and Continuing Responsibilities. These catagories of Program are defined as follows: (a) The Current Agenda shall consist of those local governmental issues as the membership shall choose for sustained attention and concerted action. (b) The Continuing Responsibilities shall consist of positions on local governmental issues to which the League of Women Voters of the Huntington area has given sustained attention and on which it may continue to act."

To "Sec. 2. Program. The Program of the League of Women Voters of the Huntington area shall consist of (a) action to protect the right to vote of every citizen, and (b) those governmental issues chosen for concerted study and action."

BOARD RECOMMENDED PROGRAM FOR 1971-72

Since there has been a proposed change in the present by-laws which would affect the local program by eliminating the present categories of Current Agenda and Continuing Responsibilities and converting to a so-called single list, we are submitting to the membership one recommended program retaining the present distinction of CA'S and CR'S and another which uses the single list.

Continuing Responsibilities: Support of Council-Manager Government
Support of Redistricting of Precincts
and improved election procedures
Support of improvement of Juvenile Court

#### HUMAN RESCURCES

The national Spotmaster carried an announcement of the new welfare consensus over the weekend of January 29. The essential substance of the position is as follows:

Based on intensive study by league members, it calls for a federal income assistance program which adequately meets the basic needs for food, clothing and shelter.

The League will not urge mandatory work requirements but rather will emphasize realistic financial incentives and counseling opportunities to help individuals get employment.

# HUMAN REBOURCES (continued)

The League will stress that programs and services should be as close to the people as possible. It also strongly supports simplified eligibility processes and procedures which preserve the privacy and rights of each recipient.

The League will wage a concentrated campaign in this Congress and in states and communities across the country to achieve its goals.

A call was put in to the national office and we have been told that until federal legislation is passed to meet these goals, state leagues can work to get state programs that meet basic needs.
