CONSENSUS REACHED

Consensus on the two United Nations issues was reached and sent to National. It was the feeling of the Huntington League that the present method of voting should remain one-nation-one-vote. This appears to us to be the most democratic way and would give the smaller nations a needed sense of importance. Our League also felt that the United Nations must continue negotiations for measures to reduce the risk of war. There must be control of the weapons the world possesses, but general disarmament will have to be gradual as it will certainly have an adverse effect on world economy.
