



HISTORY

"YOUR COLLEGE"

Past, Present, Future

Marshall College occupies twenty-five beautifully shaded acres near the center of Huntington, West Virginia's largest city.

Founded in 1837, it was first known as Marshall Academy, in honor of Chief Justice John Marshall. In 1858 the school became Marshall College and has been statesupported since 1867.

Today, Marshall College is a \$9,910,000 institution with seventeen buildings for classroom and dormitory use and sixty-two temporary units available for veterans' housing. Outdoor sports events are held in Fairfield Stadium and indoor sports take place in the Huntington Memorial Field House. Intramural events are played on the campus.

Three divisions are now maintained, each under a dean—the College of Arts and Sciences, the Teachers College, and the Graduate School-plus an Evening Program and a director of Field Services in charge of the college extension program and the off-campus workshops.

Marshall is accredited by the North Central Association of Colleges and Secondary Schools and the Association of Colleges for Teacher Education. The college is approved by the American Association of University Women. It is a member of the Association of American Colleges and the American Council on Education.

Thirty-one major fields are offered including three curricula for teaching and ten preprofessional programs. During the 1955-56 term, there were, in round numbers, 3,230 resident students from 46 counties, 14 states, and 5 foreign countries.

Looking to the future, Marshall is in the tenth year of an expansion program designed to accommodate 4,000 students. Two buildings, a science building and a women's dormitory, have been completed and plans for five additional structures needed for better service to the state are scheduled. The two oldest of the present buildings, Old Main and Northcott Hall, have been modernized. The Student Union has been doubled in size. Additional land is being acquired A Physical Education and Health Building are under construction. Other buildings included in the expansion plans are a combination auditorium and gymnasium for the Laboratory School, a men's dormitory, a fine arts building and auditorium, and a garage and service building. The present physical education building will be remodeled for women students, and some remodeling is scheduled to improve library service in the Morrow Library. A campaion is underway to raise \$30,000 for a college chapel.

FRESHMAN RULES

The following rules governing Freshman activities have been enacted by the Freshman activities Committee and the Freshman Court and are subject to change.

1. Freshman rules will go into effect Monday, September 9, 1957.



STUDENT HANDBOOK SPECIFIC GRADUATION REQUIREMENTS

Teachers College

1. 128 hours and at least 256 quality points.

2. 45 hours in 300-499 courses. 3. Two teaching fields with a 2.0 average

in each field.

4. 2.0 average in courses in education. 5. 2.0 average in Student Teaching. College of Arts and Sciences

1. 128 hours and at least 256 quality points.

2. 48 hours in the 300-499 courses.

3. 26 hours in a major subject with a 2.0 average.

4. 12 hours in a minor subject.

CLASSIFICATION OF STUDENTS

Students are classified according to the number of semester hours of college work which they have completed.

SENIORS-Students with 90 hours or more. JUNIORS—Students who have completed 58 hours and less than 90 hours.

SOPHOMORES-Students who have completed 26 hours and less than 58 hours.

FRESHMEN-Students who have completed the high school or secondary course and less than 26 hours.

NUMBERING OF COURSES

1-99, sub-college courses and do not carry credits.

100-199, primarily for freshmen, but open to sophomores, unless otherwise specified.

200-299, primarily for sophomores, but open to juniors and seniors unless otherwise specified.

300-499, for juniors and seniors unless otherwise specified and are open to sophomores only upon special permission.

500-599, graduate students only.

ASSIGNMENTS AND CREDITS

1. DEFINITION OF A SEMESTER LOAD-Sixteen (16) semester hours constitutes a normal semester schedule. However, additional hours may be taken with permission of the academic dean.

2. CHANGE OF SCHEDULE-i, e., adding courses, dropping courses, changing class hours or days, changing instructors, etc. These and similar changes will not be permitted after the student has registered for the semester except by permission of

an academic dean.
FULL TIME STUDENT DEFINED—A student carrying at least twelve (12) semester hours.

THE DEAN'S LIST

Those students who are registered for twelve or more hours and who at the end of the semester receive grades averaging B or above are considered honor students and a list of such students constitutes what is known as the Dean's List.

SEMESTER HOURS

A semester hour is the credit received for taking a subject one hour per week for one semester of 18 weeks.

GRADING SYSTEM

A, Honor (given only to students of superior ability and performance.)

B. Good (ability and performance distinctly above the average in quality.)

C, Average (ability and performance of average quality.)





- D, Lowest passing grade (poor quality)
- F, Failure (signifies entirely unsatisfactory work. Course must be repeated if credit is to be received.)
- FIW, Failure because of irregular withdrawal.
- W. Withdrawals during the first calendar month after the date of the first class meeting in the semester.
- WP, Withdrawal Passing, Withdrawal later than the first calendar month after the date of the first class meeting in the semester. Shows the status of the student's work up to the official withdrawal date (not the last day of class attendance) unless otherwise directed by the academic
- WF, Withdrawal Failing. See explanation under WP above.

QUALITY POINTS

Marshall uses the four point system with the quality point average being computed on all work for which the student has registered, except for courses with grades of W and WP. Following are the quality point values per semester hour of credit:

A total of 256 quality points are necessary for graduation which is in effect a C average. (128 semester hours times two quality points equals 256 quality points.)

CHEATING

- 1. Definition of cheating-The giving or receiving of help during examinations.
- 2. When an instructor observes evidence of cheating on the part of a student, he shall submit the facts to the Dean of the College in which that student is enrolled. If the evidence indicates guilt on the part of the student, and if this is a first reported offense, the following procedure will be followed:
- a. The student will be given a grade of "F" in, and will be expelled from, the course in which the cheating occurred;
- b. The student will be placed on academic probation at the end of the semester during which the violation occurred;
- c. For the remainder of the semester during which the violation occurred, and for the duration of his academic probation which was the consequence of that violation, the student will be denied the privilege of participation in all social and athletic activities which are under the jurisdiction of the college;
- d. The advisor of the student will be notified of the action taken;
- e. A dated report on the offense and the actions taken will be placed in the Student's Central File folder; (It is assumed that this record will be available only to qualified persons and that it will be used in ways which might be helpful to the student, it is not intended to attach permanent stigma to the student. Such a record appears to be neces-

sary in view of the possibility of a further violation by the same student.)

- f. Provision shall be made by the Dean for such counseling as may be of benefit to the student.
- 3. In the case of a second offense on the part of a student, he will be expelled from the college.

BULLETIN BOARDS

Bulletin boards are maintained for official and semi-official notices of the administration and student organizations. The board near the auditorium is posted by the College Secretary. The long board facing the offices of the Social Deans is under the jurisdiction of the Dean of Men. Boards are posted beside the doors of the College of Arts and Sciences and the Teachers Colleges. These are usually for the listing of the honor students, or "Dean's List," for the schedule of examina-tions, and for the listing of your counselor. A board is located beside the Social Dean's door for the listing of available jobs, notices of items for sale, etc. In all cases, before information can be posted on any of these boards the office or department concerned must be notified and permission secured. It's also a good idea for you to check these boards from time to time. They may concern you.

PAYMENT OF FEES

Personal checks are accepted in the Cashier's Office for the EXACT AMOUNT of fees payable to the college. These checks should be made payable to MARSHALL COLLEGE. The college is not permitted, under regula-

tions of the State Board of Education, to cash any personal checks other than for payment of fees. If you wish to maintain a checking account for personal expenses, it is easier to have checks cashed if you establish an account with a local bank. In any case, there is a considerable amount of difficulty involved in cashing personal checks.

LOCKERS

Lockers for personal articles are available on the second floor and basement of Old Main and the Science Building. These lockers may be rented by the semester from the Office of the Comptroller, M. 103. The only charge is a small fee for the use of the key. In some instances, students have placed their own locks on lockers without permission. These locks are, of course, broken off.

FINANCIAL AID

Three forms of financial aid are available to students to assist in securing their education. Part-time jobs are open in many of the departments on campus for student assistants. A listing of part-time jobs downtown and with members of the faculty are maintained in the office of the Dean of Men. Employment cards are available in this office and if you are interested fill in a card so your name can be kept on file for possible openings. If at all possible, first semester freshmen should delay such employment until they have completed one semester.

The two other forms of financial aid are the loans and scholarship funds maintained by various organizations and individuals. Over \$8,000 is available in these funds. Application may be made to the Registrar or the Social Deans. Loans are made on a short-term basis and the student must sign a promissory note. Letters of recommendation and a co-signer are usually necessary to sceure a loan. There is a service charge of 25c on each loan.

Records are kept with the Social Deans of all debts incurred by students, both on and off campus, which have been reported as unpaid. These remain a part of your permanent personnel folder. In considering letters of recommendation for graduating seniors, these folders are referred to and note is made of such bad debts.

STUDENT INDEBTEDNESS

"A student who is indebted to the college may not preregister, be graduated, or receive a transcript of credits or a statement of good standing until the debt is paid in full".

CHANGE OF ADDRESS

Each time you find it necessary to change your local or home address, notify the Social Deans, Registrar, and College Secretary as soon as possible. You should be sure to list a phone if one is available. Many times students who are needed immediately cannot be located because they have neglected to change their addresses.

LOST AND FOUND

If you aspire to be an absent-minded professor one day and are developing the traits in school, the lost and found department may save you much time and worry. Check with them as soon as you lose anything. It usually turns up. This is another function of the Social Deans and is handled in their office.

BOOKSTORE

Marshall's Bookstore is located in the basement of Old Main with an outside entrance on the south side of the building. All necessary books and supplies can be purchased there.

POSTOFFICE

A subdivision of the downtown post office is located on Third Aveue and 20th Street, two blocks east of campus. It's the most convenient place to mail packages. Packages will be accepted in the Bookstore if they have the correct amount of postage on them.

FOOD SERVICE

If you live in one of the campus dormitories you are required to eat your meals in the College Cafeteria. Meal books are on sale in the Cashier's Office in Old Main and are used for half a semester each. You may pay the full amount for the semester or one half at time of registration and the last half on November 14. The cafeteria hours are: Weekdays—Breakfast 7-9; Lunch, 11-12. Sunday—Breakfast, 8:30-9:30; Dinner, 12:00-1:00. No supper on Sunday.

Most students who don't eat at the cafeteria find time to grab a snack at the fountain in the Student Union. It excels in good atmosphere and good food. The Student Union is open from 8:30 a.m. to 9:00 p. m. on weekdays. Saturday from 10:00 a. m. until 2:00 p. m. The Union is closed on Sunday.

ANSWERS

Since you should, by now, have loads of questions running through your head, here are some tips on where to find the answers. If it's one that strictly concerns your courses, grades, hours and instructors drop in at the office of the dean of your college—which would be either Arts and Sciences or Teachers College. You will be assigned a member of the faculty as your counselor who will assist in planning your course of instruction.

Now for the questions of a personal or social nature. That's the main job of the Dean of Women and the Dean of Men. If you're in doubt as to whether your problem or question is in their field, go see them anyhow. It isn't hard to get an appointment and most of the time you can just walk right in.

And for those general thoughts that may be still lingering in your mind about college history, regulations, programs, and any number of others, the College is the one to see. Her office is located in Old Main 107 with hours from 8:30 until 4:30. Incidentally, that's time that all the administrative offices are open.

VETERANS

For veterans attending Marshall College advisement and counseling services are available within the offices of the Registrar. This office keeps a close check on class attendance, grades, entitlement and makes all official contacts with the Veterans Administration offices located within the city.

In order to qualify for the maximlum benefit under Public Law 550 (Korean G. I. Bill) a veteran must carry a minimum of 14 semester hours of college work each semester. All Korean veterans must report to this office at least once each month to sign statement of attendance to be forwarded to the Veterans Administration or monthly subsistence payments will not be made.

All veterans are urged to keep in close touch with the Registrar's office concerning problems of subsistence payments, change of address, change of dependencies, class load and attendance in classes.

TRAFFIC REGULATIONS

Marshall College has limited parking facilities which necessitate the use of traffic regulations and parking permits. Your cooperation in complying with the following rules will enable the college to derive maximum benefits from available space.

- 1. Parking will not be allowed at any time by any person operating a motor vehicle on the campus road from the Student Union to Sixteenth Street, the circle by College Hall, service drives, drives" marked "fire lane," grassed areas, or in any restricted areas on the campus where parking is not allowed. College employed personnel and students may stop on drives (not to exceed 3 minutes) to receive or discharge passengers. Faculty may stop at Bookstore (not to exceed 3 minutes) to pick up mail.
- All persons operating vehicles on the campus, no matter what their status, are required to obey all directive signs placed on the campus drives, service and parking areas,
- Fast or reckless driving on the campus or in the parking lots will not be permitted.

- 4. At intersections where stop signs are located, all vehicles must be brought to a complete stop.
- 5. Parking in service drives is limited to service vehicles and emergency apparatus.
- 6. The parking area (ramp) south of Old Main is reserved at all times for college service vehicles, disabled faculty or staff members, and college guests.
- 7. Faculty and administration will be issued parking permits from the Office of the Business Manager in Room 103 Main Building. Permit stickers are to be displayed on the rear window of the permit holders' motor vehicles.
- 8. Permit holders may park their vehicles in any space designated for parking on the rear and east side of the Science Building except those spaces marked for special purposes. Only those cars bearing parking permits may enter the parking area. All parking on college property is at the owner's risk.
- 9. Visitors' vehicles on the campus are accorded all privileges granted under regular parking and operating permits.
- 10. The Science Building parking lot will open at 7 a. m. and close at 11 p. m. daily except Sundays and holidays. Cars without permit stickers may use this parking area between the hours of 7 p. m. and 11 p. m.
- 11. Overnight parking in any college parking lot will be by special permit issued in the Office of the Dean of Men or Building and Grounds.

- 12. No student will receive special parking privileges by virtue of any office he may hold, because of any extracurricular activity in which he may be engaged or because of any status he may enjoy as a student.
- 13. Traffic Infringements
 - a. Parking in prohibited space.
 - b. Improper parking in permissible areas.
 - c. Parking in Fire Lane.
 - d. Driving on driveways wrong way.
 - e. Parking or blocking driveway.
 - f. No parking lot permit.
 - g. Failure to observe traffic sign.
- 14. The violation ticket directs offenders to appear in the Office of the Dean of Men, 110 Main Building, within twenty-four (24) hours after issuance of a traffic violation charge between the hours of 8 a.m. and 12 noon or 1 p.m. to 4 p.m. week days; Saturday from 9 a.m. to 12 noon. Failure to report within the specified period will constitute an additional violation and may result in disciplinary action.
- 15. Penalties
 - 1st violation-Warning
 - 2nd violation-appear before the traffic Committee.
 - 3rd violation-will be referred to the Cabinet for disposition and this could result in suspension from school.
- 16. These enumerated regulations will not be regarded as exclusive. The college reserves the right to revoke any permit or to discipline any person for participation in or connivance in any form of violation of the letter or spirit of these

regulations and to take such disciplinary action in all cases as the circumstances justly warrant.

ENTERTAINMENT IN THE CITY

Local entertainment will naturally vary with the individual. Huntington can be proud of the wide range of activities that are concentrated within the tri-state area.

Fourth Avenue is the Main street of the city and the theatre area is located about seven blocks west of campus. Four theaters are in this section on Fourth Avenue. There are also several local and drive-in theaters in Huntington.

Horseback riding, golf, swimming, strolling in the park, bowling, car rentals, airplane trips, and boating are all available.

MARSHALL SPORTS

The Athletic program of Marshall College includes football, basketball, cross country, baseball, track, tennis, golf, and wrestling. All students on the campus are encouraged to participate in intercollegiate athletics. Marshall College is a member of the National Collegiate Athletic Association and the Mid-American Conference including Ohio University, Kent State, Miami, Bowling Green, Toledo, and Western Michigan.

A full schedule of competition is played with the Mid-American schools in football, basketball, and baseball. As many Conference schools as possible are also scheduled in tennis, golf, track, and wrestling. The intercollegiate program is broad enough so that any student can have the opportunity to exercise whatever athletic ability in some sport against high class opponents. Freshmen are not eligible for varsity, but freshman teams are fielded in most sports.

BASEBALL

Baseball in the Mid-American Conference is a full schedule sport and Marshall strives to rank with the best in the Conference. Ten games with Conference teams and an anticipated twenty game schedule will give student baseball fans a chance to play in or see good baseball each week. All home games are played at the International Nickel Baseball Park. Anyone who has played baseball in high school, or the equivalent, is encouraged by Coach Bill Chambers to come out and participate.

WRESTLING



I. INTRODUCTION

1. Purpose


The Student Activities Board shall for its purpose:

- a. To coordinate and assist campus student activities in keeping with the best interests of the students and the college.
- b. To make regulations to encourage wholesome group activity and discourage conduct which would be incompatible with the total education and well being of the students.
- c. To enforce regulations made by the Student Activities Board and approved by the College Council and the President of the College.
- d. To refer problems it deems advisable to appropriate place: Social Deans, Student Court, Interfraternity Council, Panhellenic, etc.

2. Personnel

The Board membership shall be composed of the Dean of Men, Dean of Women, three faculty members appointed by the President of the College, and four students selected by the President of the Student Government. The Board shall meet each week.

The Chairman shall be one of the three faculty members, the Dean of Men or Dean of Women, selected preferably for a period



3. Authority

The Student Activities Board shall be responsible only to the President of the College.

4. Scope

The Student Activities Board shall be responsible to the President of the College for the coordination and regulation of:

- a. Approved student organizations such as fraternities and sororities, interest and recognition groups.
- Student social events dances, parties, entertainments.
- c. Other student activities—bake sales, contests, benefits, solicitations, donations, skits.
- d. Screening requests for new organizations for consideration of College Council.

This Board does not supervise athletics, departmental activities, publications, dramatics, Artists' Series and Forums. The Board does require, however, that these groups in addition to sororities and fraternities and all other student groups holding social functions, must file petitions for such functions and secure advance approval for them. Each such organization will be held responsible for the conduct of its members and guests.









5. Disciplinary Cases

The Student Activities Board shall be responsible for the enforcement of regulations as they apply to organized student groups.

STUDENT HANDBOOK

The Social Deans shall be responsible for: a. The disciplining of individual students.

b. The enforcement of college regulations in dormitories, sorority and fraternity

The Student Court shall hear cases referred to it by the President of the College, the Student Activities Board, the Social Deans, any student or faculty member.

II. STUDENT ORGANIZATIONS


1. Standards

Standards which have been established for recognized student organizations of Marshall College campus are as follows:

- a. To have one or more advisors who are members of the college faculty or staff.*
- b. To submit to the Student Activities Board. Room 109, Main Building, by October 15th of each year a report consisting of:

*Exceptions made for alumni and faculty wives if approved by the College Council.

- (1) a complete list of officers and members.
- (2) a general statement of purpose.
- (3) the signature of acceptance of the adviser.
- c. To submit to the Student Activities Board before May 15th of each year a report approved by the adviser consisting of:



- (2) names of officers for the coming year.
- (3) a resume of the major activities of the group for the past year.
- d. To limit membership to students, faculty and staff of Marshall College.
- e. To limit the activities of the group, and in-so-far as possible, those of its individual members to conduct which is within the limits of city, state, federal and college regulations.
- f. To recognize the president of the group as the administrative head and spokesman. He signs petitions for social events for his group and agrees to the following regulations:
- (1) To clear the date for the event on social calendar.
- (2) To submit a petition to the Student Activities Board at least two weeks prior to the event.
- (3) To close informal Friday and Saturday parties at 12 o'clock midnight and formal dances at 1 A.M. (Any social event on week nights must close at 9:30 P.M.)
- (4) To enforce regulations concerning gambling, possession or use of intoxicants.
- (5) To assume responsibility for the conduct of the party.

Failure to meet these prescribed standards or turn in the reports listed may be penalized

a, denial of use of college facilities.











- b. denial of recognition of the group as an organization.
- c. forfeiture of right to representation in other college organizations (Interfraternity Council. Student Council. Intramurals, etc.)
 d. forfeiture of right to representation in
- Student Handbook, or other publications. e. denial of privilege of some or all social
- activities for a definite period.
- f. forfeiture of right to function as a group -including forfeiture of charter. This penalty must be approved by the President of the College.

2. Recognition of New Groups

A petition for recognition of a new group must include a list of officers and charter members, a statement of purpose, two copies of the constitution, and an acceptance by the faculty adviser. The faculty adviser and a student officer must appear before the Student Activities Board when a petition is presented to that Board. After consideration and investigation the Board will make a recommendation to the College Council.


III. SOCIAL EVENTS

1. Definition

A social function is defined as any dance, party, activity or entertainment sponsored which both men and women student are present.

2. Approval of Social Events

a. Social functions are scheduled on the social calendar by the Student Activities Board. The following procedure has been established:



(2) File a petition in the office of the Social Deans at least fourteen days prior to function. An organization will be allowed one "late" date per year. A warning will accompany the first offense. Upon second offense the petition will be denied. The petition carries the date, loca-

tion and hours of the function, budget, the agreement and signature of the President of the Organization, the Social Chairman and the two Faculty Chaperones.

One formal and two informals per semester are allowed each organization. Each chaperone must file promptly a written report of the function with the Student Activities Board.

3. Planning Social Events

a. Hours

Social functions must close at 9:30 on nights before classes, 1 A. M. for informals and 1 A.M. for formals no Friday, Saturday, or night preceeding holidays. Women students living in college dormitories, rooming houses or sorority houses are allowed one hour after the close of

an approved party to return to their residences.

The Student Activities Board reserves the right to restrict or extend closing hours as it deems necessary.

b. Location
The Board encourages student organizations to use the Student Union for social functions. It is acceptable, however, to hold any social events in any approved place in Huntington or vicinity. The Student Activities Board may disapprove a location because of distance, inadequate facilities, fire hazard, use of clubroom by members while rented to college group,

c. Budget
Each petition requires a budget.

1. Conduct

- Each organization including its faculty adviser shall assume responsibility for the conduct of its members and guests.
- (2) Neither intoxicants including beer nor gambling will be permitted in campus buildings or on the premises. Campus buildings would include in addition to all buildings on the campus proper, the houses of fraternities, sororities and similar organizations. Possession or serving of intoxicants including beer and gambling are forbidden in all dormitories, fraternities and rooming houses. The policy of Marshall College regarding the serving or possession of alcoholic beverages or gambling in public shall conform with the State Law except that beer shall likewise be forbidden. Any

function sponsored by or held in the name of a recognized student organization must abide by all regulations stated herein whether that function be held on or off campus.

- (3) In accordance with state laws, the use of physical punishment of all types for initiation and hazing is prohibited. Responsibility for infractions of this rule lies on the individual and the group alike.
- (4) Young women shall not attend parties nor visit fraternity houses unless a college approved chaperon is present.
- (5) The College Administration expects students to conduct themselves as ladies and gentlemen, to dress and to conduct social events in good taste, and reserves the right at any time to dismiss students whose conduct is deemed undesirable.

IV. OTHER STUDENT ACTIVITIES

- The following are regulated by the Student Activities Board:
- a. Solicitation, donations and other contributions of money, merchandise or service for any student and/or student group is absolutely forbidden until a written explanation of the plan has been submitted to and approved by the President of the College and by the Student Activities Board. Lotteries and raffles are probibited by municipal law.

The selling of articles on the College campus is regulated by the West Virginia Board of Education as follows:

"All solicitation and selling of products

and articles upon property under the jurisdiction of the West Virginia Board of Education is prohibited except by organization and groups directly connected with the institution and upon written approval of the respective presidents or superintendents."

- b. Any activity for which there is a charged fee must have the approval of the Student Senate before being presented to the Student Activities Board for final action. The dates, plans and justifications for these events shall be scheduled with the Student Activities Board before May 1st for the following school year. Special forms are available in Main 109.
- c. Before presenting a "swing", beauty contest, skits, or any presentation on the college campus by any students, other than departmental activities, the script and program must be approved by the Student Activities Board.
- d. Serenading

Requests and approvals for serenading must be approved by the Students Activities Board. The regulations for groups who wish to serenade are as follows:

- Request must be filed with the Student Activities Board seven days prior to the serenade.
- (2) Serenades shall be scheduled only from 9:45 P.M. to 11 P.M.
- (3) The group shall notify each group they intend to serenade.
- (4) The Student Activities Board requires that the serenades be conducted in an orderly and considerate manner.

- a. Groups must refrain from hisses, cat-calls, yells, off-color songs, etc.
- Limit musical accompaniment to string instruments.
- (5) Failure to comply with regulations shall be considered as any other disciplinary case.
- The following are not regulated by the Student Activities Board:
- Requests for the use of the Auditorium must be scheduled by Professor Clayton Page,
- Radio programs must be approved by the Radio Committee,
- c. Paid advertisements for a program or publication of an approved student organization must be cleared by the Publicity Committee.
- Much of the campus social life is spontaneous and informal and is centered in the Student Union and campus housing units.

The Student Union is open from 8:30 A.M. to 9 P.M. Monday through Friday and until 2 P.M. Saturdays. The Student Union is available for private weekend parties under specified conditions. Information is available at the Union.









OFFICIAL CONSTITUTION OF THE MARSHALL COLLEGE STUDENT GOVERNMENT

MAY 6, 1957

PREAMBLE

We, the regularly enrolled students of Marshall College, in order to preserve and to promote the activities and high standing of our institution, to maintain order, to strengthen cordial relations between faculty and students, and to achieve a lasting opportunity for responsible individual and collective action, do hereby establish this Constitution of the Marshall College Student Government.

ARTICLE I-LEGISLATIVE

Section 1. Supreme Power. Supreme legislative power of the student government shall be vested in a Student Senate.

Section 2. Enumerated Powers. The Senate shall have the power to:

- a. Recommend the amount of the Student Activity Fee and the amount each organization involved shall receive.
- b. Appropriate funds to all agencies of the student government and to such other extra-curricular activities as shall seem compatible with the general welfare of the Student Body.
- c. Ratify or reject all appointments made by the President of the Student Body by a majority vote, unless elsewhere provided otherwise, provide that the Senate may by law specify such minor offices

as it shall deem proper to which appointment shall not require ratification.

- d. Override a presidential veto by vote of two-thirds majority of the members elected.
- e. Establish such subordinate officers and committees of the Senate as it shall deem proper.
- f. Make all laws governing the conduct of student elections within the provision of this Constitution.
- g. Make recommendations to the President of the College concerning matters affecting the Student Body but not within the power of the Student Government to adjust.
- h. Require reports from all (permanent or special) student committees and from all organizations receiving appropriations from the Senate and to approve or reject such reports in whole or in part.
- i. May review any and all rules made by governing councils of all other student organizations.
- j. Present honors and awards in the name of the Student Body or Student Government.
- k. Approve or reject the Executive Budget in part or in whole.
- l. Establish by law the compensation of any officer or employee of the student government.
- m. Provide by law such freshman rules and regulations and the organization for their enforcement that may be desirable and necessary.

n. Provide by law for conducting social affairs in the name of the Student Body.

o. Approve or disapprove the charging of a fee for any program or social event given by a student organization, and establish rules and penalties for breach of regulations of any event.

p. Conduct assemblies when necessary.

q. Report to the Student Prosecutor cases of dishonesty, breaches of social etiquette, infringements of college traditions, and all other matters contrary to the best interests of the Student Body.

r. Engage in legitimate enterprise for the purpose of gaining revenue for the maintenance of student government.

s. Impeach any senator or officer elected by a class, Senate, or the entire Student Body, by 2/3 vote.

t. Make all laws necessary and proper to carry out the provisions of this Constitution and promote the general welfare of the Student Body.

u. Regulate the amount of money spent in an election campaign by a party, organization, or individual candidate.

Section 3. Restricted Powers. The Senate shall not have power to:

a. Pass any ex post facto law.

b. Make any law abridging or denying the freedom of the student press or any other freedom guaranteed by the Constitution of the United States and the Constitution of the State of West Virginia.

Section 4. Legislative Procedure. Legislation may be introduced in the Senate by a

simple motion, or by a resolution, bill, or amendment.

a. To be valid, any act must be signed by the Speaker of the Senate, attested to by the Executive Secretary, and approved by the President of the Student Body. If the President disapproves, the bill shall be returned to Senate for reconsideration, and if passed by 2/3 vote, shall become law.

b. All actions of the Student Government shall be subject to the approval of the President of the College. Such approval shall be automatic unless the President of the College shall disapprove such action within ten days in writing to the Student Senate.

Section 5. Speaker. The Vice-President of the Student Body shall serve as Speaker of the Senate.

Section 6. Membership. The members of the Student Senate shall be as follows:

a. Runner-up. The Runner-up for President of the Student Body.

b. Freshman. Four senators, by and from the first semester freshman class elected as hereinafter provided plus the class president shall make the total membership from this class five senators.

c. Sophomores. Four senators, two to serve a two-year term and two to serve a one-year term, elected by and from the outgoing Freshman Class to serve during their Sophomore year. The two candidates with the highest number of votes shall serve the two-year term and shall be termed Hold Over Senator. These senators plus the class

president shall make the total membership from this class five senators.

d. Juniors. Three senators, two to serve a two-year team and one to serve a one-year term, elected by and from the outgoing Sophomore Class to serve during their Junior year. The two candidates with the highest number of votes shall serve the two year terms. The two Hold Over Sophomore Senators, plus the junior class president shall make the total membership from this class six senators.

e. Seniors. Three senators, each to serve a one-year term, elected by and from the outgoing Junior Class to serve during their Senior year. Two Hold Over Junior Senators, plus the senior class president, and the runner-up for President of the Student Body shall make the total membership from this class seven senators.

f. Graduate Senator. The Senate shall by a two-thirds majority vote of the membership elect one regularly enrolled graduate student each year to serve on the Senate. He shall have the same rights, privileges and responsibilities as any other member.

g. Reapportionment. The Senate shall have the power to reapportion the membership of the Senate based upon increased enrollment. Such reapportionment may occur no more than once every three years in the first semester beginning September, 1957, and newly created positions shall be filled only by a regular election by the student classes represented.

h. Alternates. In each class election, the defeated candidate for Senate receiving the highest number of votes shall serve a one

year term as alternate for his class. He shall attend all Senate meetings, take part in discussion and serve only on special committees of the Senate. He shall not be entitled to vote except in the absence of one of the senators of his class either for one session or a period of time. At any time the Speaker may ask that the alternate take the permanent seat for a definite period during which time the permanent senator is engaged in other school activities.

i. Vice President of Classes. The senator receiving the highest number of votes shall be the class Vice President.

Section 7. Quorum. One more than half of the members elected shall constitute a quorum.

Section 8. Regular Sessions. The Senate shall convene for regular session at least once each week, but no regular session may be held within twenty-four hours of another regular session.

Section 9. Scholastic Requirements, Each senator shall have upon filing, when elected, and shall maintain an overall 2.0 or C average during his term of office.

Section 10. Absences. The Senate may remove any Senator by 3/4 vote of membership for excessive absence; such vacancies to be filled in the regular manner provided.

Section 11. Vacancies. A vacancy shall exist upon resignation, ineligibility, impeachment, death, or removal of any officer or member of the Senate who has been duly elected and installed in office. Any irregularity previous to installation shall be corrected by the Election

Commission. Vacancies shall be filled by 3/4 vote of members present within two weeks of their occurrence.

a. Vacancy in the office of the President shall be filled by the Vice President.

b. Vacancy in the office of the Vice President shall be filled by the Speaker-Pro Tem of the Senate until election of a permanent Vice President.

c. In event of a vacancy in both the offices of the President and the office of the Vice President of the Student Body, the President of the Senior class shall succeed to the office of President and the office of the Vice President shall be filled.

d. In event of vacancy of the office of President of any of the four classes, the Vice President of the class shall succeed and shall appoint a new senator to fill his vacancy with approval of the Senate.

e. In event of a vacancy of any senatorial or alternate position, the president of the class in which the vacancy occurs shall appoint a new senator with Senate approval.

f. A holdover senator must resign from office upon election to another office during the first year of his term. All vacancies in the Holdover position shall be filled by the Senator who received the next highest vote when elected.

Section 12. Oath of Office. The following oath of office shall be administered by the Speaker, to each Senator, upon his election or appointment to the Senate: "I do solemnly swear (or affirm) that I will support the Constitution of the Marshall College Student

Government and faithfully discharge the duties of Senator according to the best of my ability and I will not accept or receive, directly or indirectly, any money or other valuable thing, from any organization, group, or person for any vote or influence I may give or withhold, on any bill, resolution, or appropriation, or for any act I may do or perform as Senator." Any member who shall refuse to take this cath shall forfeit his seat, and any member who shall be convicted of having violated the oath shall forfeit his seat and be disqualified thereafter from the student government.

Section 13. Senate Advisor. The Senate shall elect, by a 3/4 vote, the Senate advisor who shall serve for one year only, unless re-elected. The advisor shall be a member of the college faculty or administration.

Section 14. Dormitory Elections. The several dormitory councils shall have power to authorize and conduct dormitory elections, and no elections shall be valid without this authorization.

Section 15. Inter-Fraternity Council. There shall be an Inter-Fraternity Council composed of representatives of the various social fraternities on the campus. This council shall govern matters which concern the social fraternities alone.

Section 16. Pan-Hellenic Council. There shall be a Pan-Hellenic Council composed of representatives of the various social sororities on the campus. This Council shall govern matters which concern the social sororities alone.

Section 17. Independent Students Association. There shall be an Independent Students Association composed of representatives of the various independent social organizations. This association shall govern matters which concern these organizations alone.

ARTICLE II-EXECUTIVE

Section 1. Power. The executive power shall be vested in a President of the Student Body and a Student Cabinet.

Section 2. Election. The President and Vice-President of the Student Body shall be elected by and from the Student Body at large.

Section 3. Student Cabinet. The Student Cabinet shall consist of the President of the Student Body, the Vice President of the Student Body, the Executive Secretary, Secretary of Social Affairs, Secretary of Academic Affairs, Secretary of Athletic Affairs, and Secretary of Inter-Collegiate Affairs, the Business Manager, the Student Prosecutor, Chief of the school newspaper, Chairman of the Senate Appropriations and Budget Committee, and the Senate Advisor. Each shall have a vote.

Section 4. Cabinet Authority. The Student Cabinet shall have the responsibility to:

- a. Determine and recommend to the Senate the Executive Budget.
- b. Determine policy and make recommendations to the Senate.
- c. Issue orders to the permanent and special student committees and require reports from them.

d. Enforce the decisions of the Student Court.

Section 5. Meetings. The Cabinet shall meet not less than twice each month and at other times upon call of the President of the Student Body. The President shall act as chairman of the Cabinet meeting.

Section 6. Presidential Powers. The President of the Student Body shall have power

- a. Appoint the chairman and members of all permanent and special committees not otherwise provided by law.
- b. Make all initial committee appointments, submitting them to the Senate within three weeks after the inauguration.
- e. Appoint the chairman and members of the Election Commission.
- d. Veto acts of the Senate within seven days after the passage of an act by the Senate.
- e. Serve as an ex-officio member of all permanent and special student committees.
- f. Represent the Student Body in all transactions with the students of other colleges or universities.
- g. Remove any appointive officer for incompetence, neglect of duty, or malfeasance in office unless otherwise provided. Such removal does not require Senate approval unless the appointments of such officers were appointed by the Senate.
- h. Call special sessions of the Senate during the school year when he shall deem it necessary.

i. Establish such bodies subsidiary to him as he shall deem necessary and proper to aid him in the performance of his duty, subject to the approval of a majority of the Senate.

Section 7. Qualifications. The President of the Student Body shall meet the following qualifications:

- a. Upon filing to run for office he shall:
- (1) posses an overall 2.0 or C quality point average.
- (2) have complete two semesters at Marshall College as of the end of the semester in which he runs.
- (3) be eligible for graduation the June following his election.

b. Upon inauguration as President he shall:

- (1) serve as President in no other student organization whatsoever.
- (2) be eligible for an undergraduate degree the year from the June following his election.
- (3) complete at least two academic years at Marshall College by the end of the semester in which he is elected.
- (4) have and maintain a minimum of 2.0 or C scholastic average during his term of office.

Section 8. Oath of Office. The incoming President of the Student Body shall take the oath of office, administered by the outgoing President as follows: "I do hereby swear (or affirm) that I will execute the duties of the

office of President of the Student Body of Marshall College to the best of my ability, and will protect, preserve, and uphold the Constitution of the Marshall College Student Government."

Section 9. Vice-President. The Vice-President shall have the same qualifications as the President except that he may be an officer, other than president, of one other student organization, except when he may succeed to the office of President of the Student Body.

Section 10. Other Officers. The President of the Student Body shall submit recommendations to the Senate for the offices of Executive Secretary, Business Manager, Student Prosecutor, Student Auditor, Secretary of Social Affairs, Secretary of Academic Affairs, Secretary of Athletic Affairs, and Secretary of Inter-Collegiate Affairs, The Senate shall confirm these recommendation by a two-thirds vote of the elected members. These officers can not be removed from office unless impeached or without recommendation of the President with a majority of the Senate concurring.

Section 11. Executive Secretary. He shall receive such compensation as the Senate may enact by law. He shall have authority and be required to:

a. Prepare an agenda for and keep a journal of the proceedings of the Senate upon direction by the Speaker.

 Arrange and preserve all records and papers belonging to all departments of the student government.

- c. Maintain and organize the office of the student government.
- d. Render to the President, in the dispatch of executive business, such duties as he may require.
- e. Perform all clerical duties of his office.
- f. Keep the seal of the student governernment.
- g. Act as filing officer for all candidates for office to be voted upon by the Student Body.
- h. Act as Secretary of the Student Court.
- i. Act as secretary and prepare the minutes for the Student Cabinet, which shall be called the "Cabinet Record."
- j. Perform certain duties with respect to the holding of elections, including preparation of ballot, receiving notices from candidates, sending out and receiving the same after the election, and delivering same to election commissioners.
- k. Keep an up-to-date card file on all members of the student government.
- 1. Present a copy of the proceedings of the Senate to the President of the College and the College Secretary.
- m. Administer the Student Government Petty Cash Fund.
- n. Receive money from the sale of tickets to Student Government functions and to receive candidate registration fees.

o. Keep the Senate documents and Journals up to date.

p. Act as instructor to the new secretary for a maximum period of 30 days.

Section 12. Business Manager. He shall receive such compensation as the Senate may prescribe by law. He shall have authority and be required to:

- a. Negotiate all contracts on behalf of the student government, subject to the approval thereof by the Senate.
- b. Direct all financial enterprises on behalf of the student government, subject to the orders of the Senate.
- c. In the first meeting of each month shall submit monthly financial reports to the Senate and to the student newspaper for publication.
- d. Process all requisitions and secure checks through the Office of the College Treasurer.
- e. Preserve a record of all transactions during his tenure of office.
- f. Report to the Senate upon any phase of his activities when called upon to do so by that body.
- g. Examine all claims against the student government.
- h. Arrange appointments preceeding major Senate projects requiring many requisitions according to his opportunity.

Section 13. Student Prosecutor. He shall have authority and be required to:

- a. Defend claims against the student government and prosecute claims on behalf of the student government.
- b. Represent the student government before the Student Court.
- c. Investigate all violations of the Constitution of the Marshall College Student Government, the Student Code, and rules and regulations enacted thereby and shall prosecute all violators before the Student Court.
- d. Be the legal representative of the student government.
- e. Report to the Senate at any time when requested to do so by that body.
- f. Recommend to the President the appointment of as many assistants as he shall deem necessary.

Section 14. Student Auditor. He shall have authority and be required to audit the Student Government books when called upon by the Student Senate to do so and to report their condition.

Section 15. Finances. The Student Govment shall maintain two separate systems of financial records.

a. The money collected from the Student Activity Fee shall be placed in the Student Special Account of the College. A requisition shall be submitted to the College Comptroller by the Business Manager and Senate Advisor, of the Cabinet. This money shall not be used until appropriated by the Senate.

b. Money collected from every other activity of the student government shall be placed in the College Campus Units Account. The same procedure shall apply to requisitions from this account. However, the Senate shall by law provide for a petty cash fund which shall be kept by the Executive Secretary.

Section 16. Financial Audit. All financial records of the student government shall be audited by the Office of the College Comptroller. This action shall take place during the month of July and a report shall be submitted to the President of the College, the President of the Student Body, and the Student Senate.

Section 17. Bonding. The Executive Secretary and the Business Manager shall be bonded for the amount of one thousand dollars each at the beginning of their term of office.

ARTICLE III—JUDICIAL

Section 1. Power. The judicial power of the student government shall be vested in a Student Court.

Section 2. Offenses. It shall determine offenses against the Student Body and fix maximum and specific punishments for particular kinds of offenses.

Section 3. Minor Power. Minor judicial power shall be vested in the Women's Dormitory Councils, Men's Dormitory Councils,

Section 4. Membership. The Court shall consist of nine justices. There shall be: four women students, two of whom shall be social sorority women and two independent or unaffiliated women; four men students, two of whom shall be social fraternity men and two independent or unaffiliated men; and the Chief Justice.

Section 5. Chief Justice. The Chief Justice shall be elected by the Senate by a three-fourths vote of the members present. He shall be a Senior when elected.

Section 6. Election. The justices shall be nominated by the President of the Student Body and approved by three-fourths of the elected members present of the Senate. They shall be nominated within three weeks after the inaugeration of the President of the Student Body.

Section 7. Advisor. The Student Court shall submit for approval of the Senate the advisor to the Student Court within one week following the opening session. The advisor shall be a member of the College faculty or administration, and shall serve a one-year term.

Section 8. Restrictions. No officer of any other department of the student government shall be eligible for membership on the Court. No student who is a member of any council listed in Section Three of this Article shall be a member of the Court. No student who shall not have been a student in good standing in

Marshall College for at least one academic year shall be eligible to serve on the Court.

Section 9. Other Officers. The Court shall elect its own necessary officers.

Section 10. Qualifications. The justices shall have and maintain a minimum of 2.0 or C average during their term of office.

Section 11. Term of Office. The justices shall serve for a term of one year unless they are impeached or voluntarily resign, or are removed for excessive absences. They may be re-elected to as many terms as they are in school. They shall sit with the old members of the Court until June and shall assume their office the following September.

Section 12. Absences. No justice may have more than one excused absence in any one semester. After a justice has been absent from two sessions, he shall be automatically expelled from office and shall not be eligible for reappointment during the school year in which he was originally appointed.

Section 13. Sessions. Sessions shall be called by the Chief Justice whenever he deems it necessary, provided forty-eight hours notice is given each justice. They shall be closed to the public unless a petition of fifty (50) students request it open.

Section 14. Vacancies. The President of the Student Body shall fill vacancies which occur in the Court in the manner heretofore provided. Vacancies shall be filled within two weeks.

Section 15. Oath. The Court shall, as individuals, take the juror's oath of secrecy. No records except the final decisions of the Court shall be recorded and preserved.

Section 16. Authority. The Student Court shall have.

- a. Original jurisdiction in all cases involving the constitutionality of any act of the Senate or if the constitutionality is questioned by any student at Marshall
- b. Appellate jurisdiction in all cases decided by the Councils listed in Section Three of this Article.
- c. Original jurisdiction in cases involving the constitutionality of actions of the President of the Student Body or of the Student Cabinet.
- d. Authority to hear all student organization disputes, and all cases involving student infraction of college rules and regulations which are referred to it by the College Administration or students.
- e. Power to suspend sentence and impose probation in particular cases when necessary.
- f. To report its findings and decisions in all cases to the President of the College, President of the Student Body, and to the Student Senate.
- g. Power to reconsider any previous decision of the Marshall College Student court and authority to reverse or affirm any such decision.

Section 17. Impeachment. Impeachment proceedings shall be as follows:

MARSHALL COLLEGE

- a. Charges may be brought in the Senate for nonperformance of duty or malad-ministration of office against any elected or appointed student official, or justice of the Student Court.
- b. A majority vote of the elected members of the Senate shall be necessary to bring the officer to trial.
- c. The Student Court shall try all cases other than the Student Court Justices.
- d. The Student Prosecutor shall prosecute, and the accused official may designate any member of the student body to act as counsel for the defense.
- e. Agreeing vote of 7 of 9 of the Court shall be necessary to remove the accused from office.
- f. The Senate shall try a member of the Student Court other than the Chief Justice, and a 34 vote of the members present shall be necessary to convict.

Section 18. Rules of Procedure. The Court and the Councils listed in Section Three of this Article shall make and publish their own rules of procedure, but these rules shall not deny to any accused person the presumption of innocence until proven guilty. The Court shall inform each accused student of his rights guaranteed under this section at the time he is notified of the offense charged against him. The prosecution and defense may call witnesses into the court at any time.

Section 19. Right of Appeal. Any student convicted by the Councils as listed in Section Three of this Article shall have the right of appeal to the Court, and any student sentenced to be suspended or expelled from Marshall College by the Court shall have the right to request a rehearing. The rehearing shall be held not less than three or more than six days after the original conviction.

Section 20. Final Appeal. Final appeal on all decisions of the judicial department may be made to the President of the College.

ARTICLE IV-ELECTIONS

Section 1. The Student Senate shall enact provisions for the nomination and election of Student Government officers in the second semester of each year for the positions of President of the Student Body, Vice President of the Student Body, Presidents and Senators of the Senior, Junior and Sophomore classes. The methods of nomination and election shall be provided in the Election Laws of the Student Code upon enactment by a ¾ vote of the Senate members present.

Section 2. Freshman Election. There shall be a Freshman election held in the first week of October of each school year in which the President and Senators of the Freshman Class shall be elected.

Section ?. Homecoming Election. There shall be an election previous to the official Homecoming Game of each year in which "Miss Marshall College" and her attendants shall be chosen.

Section 4. Special Elections. The Senate shall have the power to call special elections on any subject involving student interest.

Section 5. Election Commission. The Election Commission shall administer the rules and regulations enacted by law by the Student Senate on all elections authorized by this Constitution.

Section 6. Voters. All regularly enrolled, fulltime students, both undergraduate and graduate, shall be entitled to vote for the President and Vice President of the Student Body and for the President Senators of their respective classes.

Section 7. Inauguration. All Officers and Senators shall be inaugurated within two weeks after election in accordance with the procedures set forth in the Student Code.

Section 8. Oath of Office. Each Senator shall be required by law to take the oath of office to uphold, protect, and preserve this constitution and the government thereby created as set forth in Article I, Section 12 of this Constitution.

Section 9. Qualifications. The Class Presidents and Senators shall be Academic members in the class they are to represent according to the requirements set forth in the College Bulletin.

Section 10. Filing Fees. The Senate may require a fee from each student filing for a student government office.

Section 11.Ties. In event of ties in any of the above elections, the Senate shall decide the winning candidate or candidates by a 34 vote of the members present.

ARTICLE V-

PERMANENT ORGANIZATIONS

Section 1. College Club. There shall be a College Club which shall be composed of the President and Vice-President of the Student Body, and the president of every recognized student organization at Marshall College. The President and Vice President of the Student Body shall serve as Chairman and Vice-Chairman respectively. It shall be the purpose of this Club to promote interest in campus activities and to encourage a high spirit in all college and students events and contests.

Section 2. Student Cheerleaders Commission. The Student Cheerleaders Commission shall be set up and directed by the Senate. It shall supervise the selection of cheerleaders in accordance to the Student Code of the Student Senate.

Section 3. Student Scholarship Commission. The Student Scholarship Commission shall review all applications for Student Government Scholarships and shall recommend those qualified to the Senate for approval.

Section 4. Chief Justice Board. The Chief Justice Board shall have general supervision of the publication of the student yearbook.

Section 5. Student Activities Board. The Student Activities Board shall consist of four students appointed by the President of the Student Body and approved by the Senate by a two-thirds vote of the elected members, three faculty members appointed by the President of the College, and the Dean of Men and the Dean of Women. The President of the

College shall appoint the chairman. Each member shall have a vote. The board shall have general supervision over all student organizations and their social activities, with the exception of the Student Government which shall be subject only to the President of the College. The present regulations of the Board shall remain in effect until changed by the Board with the approval of the President of the College.

Section 6. Student Publications Board. The Student Publications Board shall coordinate the sale of advertising and solicitation, rates, space, etc., of all student publications and shall recommend standards for approval to the Senate. The board shall consist of a chairman and three student members appointed by the President of the Student Body with the approval of the Senate, three members of the faculty appointed annually by the President of the College and the College Secretary who shall serve as permanent secretary.

Section 7. Freshman Activities Commission. The Freshman Activities Commission shall recommend to the Senate the rules and regulations governing Freshman Week Activities and shall set up, with the approval of the Senate, the agencies and groups for applying and enforcing these rules.

Section 8. Homecoming Activities Commission. The Homecoming Activities Commission shall have general supervision over all activities held in conjunction with the annual Homecoming Football Game. It shall recommend to the Senate the date of homecoming,

the rules and regulations for participation in the parade, the dance activities, the special guests and judges, and the method of presenting "Miss Marshall College."

Section 9. Other Organizations. The Senate shall create by law such other permanent commissions, boards, or committees which shall be necessary to the proper administration of the Student Government.

Section 10. Majority Party Membership. All commissions, boards, or committees appointed by the President of the Student Body may have a majority membership of the majority party, provided, however, that minority groups shall be as well distributed as their number permits.

Section 11. College Committees. The President of the Student Body shall appoint the student members of all college committees, subject to the approval of the Senate and the rresident of the College.

ARTICLE VI-GENERAL PROVISIONS

Section 1. Members. All regularly enrolled students of Marshall College, both undergraduate and graduate, who pay a Student Activity Fee, shall be members of the Marshall College Student Government.

Section 2. Income. The expenses of the Student Government shall be met from funds allocated to the Student Government from the Student Activity Fee, proceeds from any other activity sponsored by the student government, and any donations made to and accepted by the Senate.

Section 8. Student Responsibility. It shall be the duty and responsibility of every student at Marshall College to abide by the provisions of this Constitution and subsequent laws legally enacted by the government of the students, and to further report any violations of these laws to the President of the Student Body or the Student Prosecutor.

Section 4. Supreme Law. This Constitution and all laws enacted pursuant thereto shall be the supreme student law.

Section 5. Student Participation. Although the power of government of Marshall College is vested in the West Virginia Board of Education, the President of the College, and other officials, the Student Government shall be recognized as the principal authorized agency through which participation in college government by students and student representatives shall be made effective. Consistent with the rules of the Board of Education and the regulations of the college officials, the participation of student representatives under the supervision of the Student Government shall be encouraged and extended in those aspects of college government in which students have a primary interest. The development of a sense of joint responsibility of students, faculty, and administration for the welfare of the college and its effective management to achieve its educational objectives shall be recognized as its major purpose.

Section 6. Name Restricted. The Student Body or Student Government name, or any part thereof, shall not be used by any student or group of students in connection with any public or campus performance, except as authorized by the Senate. Groups of students may not use this name unless the group is recognized as a student organization of Marshall College in good standing by the Student Activities Board.

Section 7. Oath. Every student serving as a member of any student commission, board, or committee shall take the following oath upon appointment to office: "I do solemnly swear (or affirm) that I shall uphold, defend, and protect the Constitution of the Marshall College Student Government, and that I shall execute the duties of my office to the best of my ability." The oath shall be administered by a justice of the Student Court and attested to by the Executive Secretary.

Section 8. Student Code. Provisions contained in this Constitution may be enforced, interpreted, and defined by means of a Student Code, commonly known as By-Laws, the contents of which shall be passed by ¾ vote of the Senate and approved by the President of the Student Body.

Section 9. Rules of Order. All matters not covered in this Constitution, Student Code, and Rules of the Senate shall be governed by Robert's Rules of Order, revised edition.

ARTICLE VII-AMENDMENTS

Section 1. Recall. Any constituency shall have the power to recall any officer elected by the constituency or by the Senate under this constitution. If the constituency is campus wide the petition to recall shall be handed to the Chief Justice of the Student Court, and

not be valid unless it contains the signatures of at least ten per cent of the qualified voters of that constituency. Any officer so recalled shall have the right to be a candidate for office from which he shall have been recalled in the ensuing election.

Section 2. Referendum. The Student Body shall have power to call for a ballot on any act of the Senate, providing a petition calling for the ballot and specifying in writing the act on which the referendum is to be taken shall be signed by ten per cent of the Student Body and transmitted in writing to the President of the Student Body. The President shall, if he determines the petition to be in good order with in the limitations of this Constitution, direct the Election Commissioin to conduct an election on the act in not less than six nor more than fifteen days after he shall have received the petition. Public notice of such election shall be given not less than four days before it shall take place. A majority of the votes cast at the election shall be sufficient to pass the bill.

Section 3. Initiative. The Student Body shall have power to initiate any act within the power of the Senate provided the same procedure shall be used as designated in Section Two of this Article.

Section 4. Amending Procedure. Amendments to this Constitution shall become valid under the following provisions:

a. An amendment may be introduced to the Senate by a voting member of the Senate. Printed copies of the proposed amendment shall be provided to all voting members of the Senate.

b. An amendment may be proposed at any regular session of the Senate and debated at any subsequent session.

c. A two-thirds vote of the members elected shall be necessary for Senate approval. Proposed amendments shall not require the approval of the President of the Student Body.

d. Amendments shall not be retroactive or affect the incumbents in any office.

e. Within three school weeks following Senate approval the amendment shall be submitted to the Student Body for ratifica-

f. An amendment may be introduced by presentation to the Senate of a petition signed by at least ten per cent of the Student Body.

g. The Senate shall provide for an election within three school weeks in which the amendment shall be submitted to the Student Body for ratification.

h. In either case, the amendment shall go into effect if it is approved by fifteen per cent of the Student Body voting in the election, after approval of the amendment by the President of the College.

Section 5. Conflicting Regulations. When ratified by the Student Body this Constitution shall change in toto all existing constitutions, rules, and regulations that conflict with the letter and spirit of this Constitution, All student organizations shall amend their constitutions or by-laws to comply with this Constitution.

Section 6. Effective Date. This Constitution shall take effect upon approval in the Primary election of April 17, 1957, by majority vote, after its approval by a simple majority of the Student Senate sitting as a constitutional convention, and approved by the President of the College.

Section 7. Enabling Act. The elected officers of the 1957 General Election of the Student Government shall assume the additional duties designated by this Constitution. Those Student Government members who would be held over for the next year will be retained in office, and will serve with the Senate for the following year. These holdover Student Senate members shall be deemed Senators and shall have all the rights and privileges appertaining to that office. The present members of the Student Court shall serve until the appointment of the new justices by the new President of the Student

Section 8. Original Copy. The original copy of this Constitution shall be signed by those concerned and placed in the James E. Morrow Library. Carbon copies of the original shall be signed by those concerned and given to the President of the College, the College Secretary, the Dean of Men, the Dean of Women, and the Executive Secretary of the Student Government.
