CONSTITUTIONAL REVISION MEETINGS

The history and progress of reapportionment in West Virginia, as well as the current status of the reapportionment case in the 13th Judicial Circuit Court was reviewed at our first meeting in December. In January, further study was made by two League members and discussion was had on the current status of the case. We were awaiting a decision to be handed down by the West Va. Supreme Court of Appeals.

Because of current interest and criticism of proposed city planning by rural members of the county and much newspaper publicity, it was decided to devote one meeting to a briefing of the city development plan. As a result of this meeting, it was felt that a general meeting would be advantageous to all League members. Therefore, at a General Meeting held on March 11, Mr. Ned Brooke, Planning Director of the Cabell County Planning Commission spoke on the "Proposed Plan for Cabell County."
