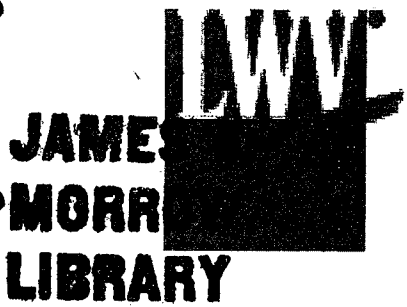

done a remarkable job in researching  
information to help Leagues become informed  
and be able to come to consensus on this  
controversial issue. The October "National

that will help in the immigration discussion.

National Voter's articles. On the first page at  
the bottom right you can click on National  
Voter, and read the two articles. Also you can  
access a February discussion of Immigration

Our Huntington Area League will meet on  
October 15 and again on November 17 at 7:00  
p.m. at the Enslow Park Presbyterian Church  
to discuss this issue. Please be thinking about:

What criteria should Federal Immigration  
laws consider?

What should be our top three priorities?

How should we treat unauthorized  
immigrants currently in the U.S.?

Should we require ID cards of all  
residents?

Read the materials and come prepared to  
join in what promises to be a lively discussion,  
led by Giovanna Deveny. We will send our  
final consensus report to the LWVUS which  
will accumulate responses from Leagues  
throughout the country. These reports will  
form the basis for a position for taking action  
on Immigration. Grassroots agreement on

positions is one of the League's greatest  
strengths.

## CALENDAR

### HUNTINGTON'S HOUSING PROGRAMS

Carole Boster provided the following information about the housing funds that the City of Huntington receives from the federal government. Community Development Grant (CDBG), Home Opportunities Made Equal (HOME), and Emergency Shelter Grant (ESG) receive funds from the U.S. Department of Housing and Urban Development (HUD). In order to receive these funds it signs numerous certifications including one to Affirmatively Further Fair Housing. Huntington meets this statutory obligation by having a Human Relations Commission and partially supporting the Commission with some funds from the CDBG program. The rest of the financial support for the Commission comes through HUD's Fair Housing Assistance Program (FHAP). To qualify for FHAP funds, the city must have a civil rights ordinance that is determined by HUD to be substantially equivalent to the Fair Housing Amendments of 1988.

Other entities in the city also receive HUD funds. The Huntington Public Housing Authority (PHA) is entirely funded by HUD. The PHA has both public housing units and tenant based Section 8 assistance. Some other housing developments in the city that are privately owned receive what is called site-based Section 8 housing Assistance through HUD's multifamily programs.

After the September League meeting's presentation by Huntington's Human Relations Commission Chair Richard Cobb, the Huntington League's board voted to support amendments to Huntington's ordinance; but the Huntington Council did not vote to send the ordinance on to a second reading. Therefore, we did not submit our statement.

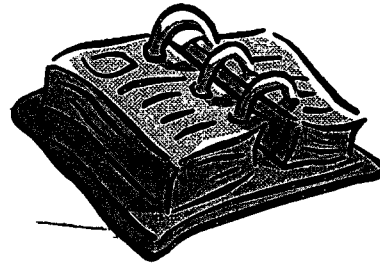

### PLASTIC BAGS.

It is estimated that the US uses 100 billion plastic bags a year, which take an estimated 12 million barrels of oil to produce. It takes up to 1000 years for plastic bags to break down in the environment. Unfortunately many plastic bags end up in the natural world both on land and waters thus threatening wildlife. Consider reusing your bags rather than throwing them away. Or take the bags to the store to reuse for carrying your purchases home but recycling them when they are no longer usable. Or better yet take a permanent reusable bag to the store. Here are some tips on recycling your bags.

YES to clean and dry grocery bags, retail bags (remove hard plastic and string handles), paper towel and toilet paper wrap, plastic newspaper bags, plastic dry cleaning bags, and all bags labeled with a #2 or #4. Recycle only clean and dry bags. Remove receipts.

NO to food or cling wrap, prepackaged food bags including frozen food bags, pre washed salad bags, no film that has been painted or has excessive glue, no bio-based or compostable plastic bags. (Information from plasticbag recycling.org).
