

Miss Frances Sattes was appointed to the board for a 1-year term. She will take charge of Continuing Responsibilities and Water Resourses.


CONSTITUTIONAL REVISION

The constitutional convention planning committee of the League met on May 5 at Jean Dickinson's to start laying plans for the election on November 9. There will be a speakers' bureau with speakers available to any organization which is interested and, of course, it's up to us to see that the other organizations which we and our husbands and friends belong to become interested. CONSTITUTIONAL CONVENTION BULLETIN

The State League is now putting out a constitutional convention campaign bulletin. The first bulletin included some of the questions people are asking and the League's answers. Here's a sampling:

- Q. WILL THE CONSTITUTIONAL CONVENTION SERVE MAINLY AS A RUBBER STAMP FOR A NEW CONSTITUTION PROPOSED BY THE GOVERNOR?
- A. At a press conference on April 9 the governor stated that he wished to make it clear that at no time did he intend to appoint a committee to prepare a draft of a revised constitution to submit to the delegates.
- Q. IS THE APPORTIONMENT OF CONVENTION DELEGATES UNCONSTITUTIONAL BECAUSE IT IS NOT BASED ON POPULATION?
- A. No formal written opinion has been given on this question. However, Attorney General C. Donald Robertson remarked informally that he sees nothing unconstitutional about the makeup of the proposed convention. "This isn't the type of situation in which complete equality is demanded. A constitutional convention doesn't demand the same prerequisite for the idea of one man, one vote as in the legislature..." All actions of a convention must be approved by the people. This is in contrast to the legislature which can pass laws without the people's consent.
- Q. IS LEAGUE SUPPORT FOR THE CONVENTION IN CONFLICT WITH THE LEAGUE'S POSITION ON APPORTIONMENT?
- A. No. The League's apportionment position is based on study of distribution of seats in the House of Delegates and applies only to apportionment of the House of Delegates. The League's position on convention membership is that it should represent the "broad and varied interests of the citizens of the state."



Joan Weisberg has been to a convention in Washington, D. C. and Evelyn Meier to one in Morgantown. Joan's report follows:

On April 28-30 I was privileged to attend the National Conference on the United States and China in Washington, D. C. as the delegate of the West Va. League of Women Voters. At this meeting I listened to professors, newspaper people, career men in the state department, businessmen, all of whom seemed very knowledgeable on the subject, discuss U. S. and Red China relations. The only conclusions agreed on by these various speakers were these:

- 1. The U. S. does not seriously possess an Asian policy. Since World War II we have just bumbled along.
- 2. The main stumbling block to any solution of the problem of U.S. relations with China is Taiwan which the U.S. has committed itself by treaty to defend at all costs and which the communists say must now come under the jurisdiction of the government of mainland China.
- 3. There are no easy solutions to the problems posed by the existence of an aggressive and arrogant communist government in China. The course ahead for American diplomacy is sure to be painful and perilous.

In the fall the League in its Foreign Policy unit will undertake a detailed study of U. S. - Chinese relations. I'm sure that many of our members will want to attend and gain some knowledge of this complex but most important subject. I can only hope that the wealth of reading material and notes with which I returned from the conference and which I will gladly share with anyone interested, will help shed some light on the complexities involved.
