APPORTIONMENT OF STATE LEGISLATURES

Last month the consensus of our League on the "Apportionment of State Legislatures" was published in this newsletter. The consensus we came to seems to be that of the majority of the Leagues all over the country and the National Board has announced to the press that

"The members of the League of Women Voters of the United States believe that both houses of State Legislatures should be apportioned substantially on population."...that this "standard is the fairest and most equitable way of assuring that each man's vote is of equal value in a democratic and representative system of government...the U. S. Constitution should not be amended hastily or without due consideration because of an 'unpopular' court decision... that the term 'substantially' used in Supreme Court decisions allows adequate leeway for districting to provide for any necessary local diversities."

Now is the time for you, as individual members of the League, to write to your representatives in Congress, telling them of your strong support of this position. The names and addresses of your representatives are listed here for you. Please take the time and effort to let these men know how you stand on this issue.
