SEEKING NEW WATER WAYS

is our task at an important meeting to reach consensus on the National Water item. This will be on Thursday, November 10, at 8:00 p.m. at the home of Joyce Levy, 699 Thirteenth Avenue.

As indicated in the last Bulletin, see your August, 1966, NATIONAL VOTER to review background. The basic question for consensus is "Should the Federal Government offer financial incentives to private industries to reduce their water pollution?" and reasons for the answer. Mary Daniel will discuss arguments favoring federal assistance and Chloe Dunfee will present thinking on private industries assuming the responsibility.

FOLLOW-UP ON DHR

On Saturday, November 19, a conference will be held as a REPORT TO THE PEOPLE ON THE COMMUNITY ACTION PROGRAM. Although primarily engineered by Cabell County Community Action, Inc., Marshall University and the Huntington Labor Council will be co-sponsors and meetings will be in the Marshall Science Arditorium.

Because the finance drive fell so far below expectations, \$300 must be cut from the budget adopted at the last Annual Meeting. The Board decided on cuts in callotments for Committees, delegates (this was cut to zero, which means if League members attend out-of-town meetings, they're on their own), operating costs (e.g. postage), community action (Voters Service and Know Your County), and Bulletin (there will be no issue in November or January).
