LWVUS CONCENSUS REACHED ON STUDY OF THE EXECUTIVE

I. PRESIDENTIAL POWERS

Presidential power should be exercised within the constitutional framework of a dynamic balance between the executive and legislative branches. Accountability and responsibility to the people require that unnecessary secrecy between the President and Congress be eliminated. Therefore, the League of Women Voters of the United States supports the following measures:

Executive Agreements: Presidential authority to negotiate international executive agreements should be preserved. Accountability to the public requires that the President report to Congress the text of all such agreements and that Congress review them periodically.

War Powers: The President should be required to seek the advice of Congress before introducing U. S. armed forces into situations where hostilities are imminent, to report promptly to Congress any action taken, and to obtain within a specified time congressional approval for continued military activity.

Emergency Powers: Presidential authority to declare a state of national emergency should be subject to periodic congressional review. The President should transmit to Congress yearly notice of all existing national emergencies and significant orders issued under each. Congress should review the emergencies every six months and should have the power to terminate them at any time by concurrent resolution. (All states of emergency new in existence should be terminated after a grace period for adjustment.)

Fiscal Powers: The President should exercise executive responsibility for sound management of public funds in a manner consistent with the programs and priorities established by Congress. This requires procedures for congressional consideration of the budget as a whole and measures for congressional disapproval of presidential impoundment of funds.

II. SUCCESSION AND TENURE

The League of Women Voters supports the succession procedures spelled out in the 25th Amendment. However, it favors a limit on the amount of time Congress may take to confirm the Vice-President.

The League of Women Voters favors retention of a two-term limitation on Presidential terms of office.

LEAGUE HAPPENINGS

Action. In a letter to Senators Byrd and Randolph and to Congressman Hechler, Betty Barrett, chairperson of the Huntington Community Development Block Grants Citizens Advisory Committee, wrote in part:

'When the Housing and Community Development Act of 1974 was passed, the intention seconed to be to allow greater local discretion in spending these federal funds, with emphasis on aiding middle and low income persons improve their housing, and providing improvements in such community-wide services as recreation, social services and public works, thereby consolidating a number of categorical grants and federal programs. Eligibility requirements at the beginning were fairly loose, with citizen participation a necessary ingredient.

As the program has continued, the Department of Housing and Urban Development has added guidelines regularly, until there are many restrictions that I believe are contrary to the intent of Congress as stated in the original Act. I believe this is unnecessary bureaucratic interference in local options, and needs to be brought to the attention of Congress. In addition, the restrictions seem to function often to eliminate eligibility of social services, to emphasize 'bricks and mortar' to the exclusion of services directly of benefit to people."

She gave several examples of "red tape":

- 1. Restrictions on the locations for programs and mo money allowance for equipment.
- 2. Restrictions on the employment of a code enforcement director.
- 3. Insistance that programs be restricted to neighborhoods even though the public requests programs that are helpful to the entire city.
- 4. 'The federal rules keep changing while the game is in progress."
- 5. The federal rules are not allowing local discretion in determining priorities.

Wingspread was fabulous!

Aside from the joys of meeting in a building designed by Frank Lloyd Wright (the Johnson Foundation's conference center, Wingspread), the LWV national conference on the New International Economic Order (NIEO) was a great learning experience.

True to all League conferences, they gave us an intensive three-day experience (Every minute was scheduled.) worthy of any graduate school seminar.

We heard twelve speakers in the first two days. Ambassador Kanakaratne (from Sri Lanka to the U. S.) was a most articulate spokesman for what the poor countries are

demanding in trade, aid and technology transfers. Several U. S. Department of State officers officed rebuttals. A Thai woman from the U. N. Population Fund spoke ardently about the role of women in development.

I picked up other incidentals:

- --Heard many Leaguers complain about the heavy costs of maintaining a state office and was glad we don't have one.
- --Delegates (from 42 states, including Hawaii and Alaska) were virtually unanimous about their problems in gaining access to newspapers and electronic media. It made me appreciate what an enviable status we have with our own local media, who often seek us out.

A task remains now to translate a fine conference into local and state action--and public understanding. I picked up some good ideas about that, too, but first I must get some rest!
