#### STUDY FOR THIS FALL

At the September units on Housing, League Members will discuss <u>Guide-Lines for Fair</u> <u>Housing Standards</u> and also discuss Huntington's problems in Fair Housing. As background material, here are the Provisions of Title VIII -- Fair Housing -- of Public Law 90-284:

When fully in effect (January 1, 1970) the bill will prohibit discrimination on the basis of race, color, religion, or national origin in the sale or rental of about 80 percent of all housing in the United States. The provisions in the bill will become effective in three stages, as follows:

- 1. Upon enactment, to federally owned or operated dwellings, to dwellings provided in whole or in part with the aid of loans, advances, grants, or contributions made by the federal government,\* to dwellings provided in whole or in part by loans insured, guaranteed or otherwise secured by the federal government,\* and to dwellings provided by the development or redevelopment of real estate purchased, rented, or otherwise obtained from a state or local public agency receiving federal financial assistance for slum clearance or urban reneval.\*\*
- After December 31, 1969, to all housing covered above and to all other dwellings, i.e., those in real estate developments except as follows:
  - A. Any single-family dwelling sold or rented by an owner, provided that the individual owner does not own or is not entitled to any part of the proceeds from the sale or rental of more than three single-family dwellings at any one time, and does not indicate any discrimination in advertising the sale or the rental of the house.
  - B. To multiple-unit housing of up to four separate living units in which the owner maintains and occupies a residence.
- 3. After December 31, 1969, to all privately owned-single-family housing sold or rented through a real estate agent or broker.

\*Applicable only to dwellings provided under agreements made after November 20, 1962<sup>1</sup> unless payment therefor has been made in full prior to the date of the inactment of this law.

<sup>1</sup>On November 20, 1962, President Kennedy, signed an executive order to become effective immediately prohibiting discrimination in housing built, purchased, or financed with federal assistance. The order covered federally owned or operated housing, public housing, and housing in urban renewal projects subsidized by the federal government; housing constructed with federal loans, such as housing for the elderly, community facilities, and college housing; housing developments and apartments insured by the Federal Housing Administration or Veterans Administration. It also covered secondary mortgaging of FHA and VA mortgages by the Federal National Mortgage Association.

How many members have seen the model of the proposed urban renewal plan that is in the lobby of City Hall? How many have any definite thoughts on it and expressed them to members of the council? Several of our members have been attending meetings but more need to go. When you are called to represent League at a Council Meeting, say "Yes". You will probably enjoy it.

#### TO LOOK FORWARD TO

There will be a special issue of the State Voter that will contain answers to questionnaires sent to all candidates for state offices and congressional candidates.
