REGISTRATION

The deadline for registrating to vote is Oct. 5. Be sure you and everyone you know is properly registered by them. Voting Nov.5 is the responsibility of every citizen, but proper registration is a pre-requisite.

SPECIAL ATTENTION

On the ballot Nov. 5, 1968, there will be a Modern Budget Amendment. One of the recommendations made in the Fifth Report of the W. Va. Commission on Constitutional Revision in 1963 was that the Governor have the sole executive responsibility for preparing the budget. This Modern Budget Amendment will do that. The features of the Amendment are:

- It vests the budget-making responsibility in the Governor, whose action will be subject to full public scrutiny, instead of in the Board of Public Works, where responsibility is more difficult to pinpoint.
- 2. Legislative power to amend the budget will be more flexible.
- 3. The Governor will be able to pass judgment on the budget as enacted by the Legislature, although the Legislature will be able to over-ride his final
- The final budget will be the product of the interaction of the Governor and the Legislature.

Now, all we have to do is see that enough people are informed about this to get it passed.

CCC NEWS

The first full scale "Constitutional Convention" in W. Va. since 1872 will be held Oct. 25-27 at the State Capitol when more than 100 High School students and consultants will meet in the House of Delegates chamber to revise and prepare their version of the 96 year old Constitution. Sponsors are League of Women Voters and The W. Va. Association of Classroom Teachers. The delegates have been chosen from the counties and delegate districts on the same basis as members of the House of Delegates.

CONSENSUS QUESTIONS ON ELECTION LAWS

- 1. Do we support more centralized control of registration at the state level? Or continue basic control at the county level?
- Should the Secretary of State be named State Superintendent of Elections with the sole responsibility for administration of election laws and procedures? Or Should the Secretary of State select such a person?
- 3. Should the State Superintendent of Elections select the single county official who would be charged with the duty of arranging and conducting all elections? He would be responsible to the State Superintendent.

Or Should the elected county clerk be given this responsibility? Should this responsibility remain with the county court?

- 4. Should the present State Election Commission have only advisory or supervisory responsibility? If so, what responsibilities?
- 5. Should the method of selection of registrars and other registration officials be changed? If so, (a) should they be employed by the county election official on a bi-partisan basis and be responsible to him? (b) other?
- 6. Do we support a permanent registration system?
- 7. What changes, if any, should be made in the methods of purging and maintaining permanent registration rolls?
 - a. make a 2 year canvass mandatory?
 - b. change to mail check?
 - c. make it mandatory to report death notices, name and address changes, etc. to the appropriate registration office?
 - d. other?
- 8. What practical suggestions for legislative action can be made concerning residence requirements? How does one test intent?
- Should the state residence requirements be reduced to 6 months and county residence to 30 days.
- 10. Should all residence requirements be waived in voting for presidential and vicepresidential candidates?
- 11. Should qualified West Virginia voters who must move from the state be allowed a specified time during which they may vote an absentee ballot in the state?
- 12. Should the age requirement for voting be reduced to 18 years of age?
- 13. What other changes, if any, in voting requirements should we support?
- 14. THERE ARE TWO OPPOSING PHILOSOPHIES CONCERNING ABSENTEE VOTING.
- A. Should absentee voting be tightened in all areas to prevent as much vote fraud as possible?
 - a. Restrict absentee voting to military personnel and dependents; those living abroad; and full-time college students and their spouses?
 b.-- Require that a voter expects to be at least 200 miles from his precinct on
 - election day?
 - c. Require a sworn affidavit stating that a voter intends to be out of the county before voting an absentee ballot?
 - d. Others?
- B. Because of the present age of mobility, should absentee voter laws assist those numerous voters who find it impossible to vote in their precincts on election day?
 - a. Keep the present absentee voter laws substantially as written and encourage more effective administration?
 - 1. Secure poll watchers? How would they be selected?
 - 2. Improve methods of selecting and training those persons handling absentee voting at the court house and at the polls?
