JUVENILE CORRECTIONS

Two important questions must be kept in mind whenever juvenile corrections are discussed: Are the children being prepared to live as good and responsible citizens in society after they have been released? Will the community be safe when the children are released? The answer to these questions may depend on the answere to other questions. What is the role of commitment? What is the role of the court? What is the role of the correction agency? What determines an effective parole and aftercare program? How shall the programs be financed? These topics are to be discussed and consensus made during the unit meetings of October.

West Virginia juvenile laws have changed since 1975 when League came to consensus on the issues of juvenile judicial rights and the status offender. Since laws have changed and since many members have joined League after the 1975 consensus, backround material will have to be discussed in order to bring League up-to-date.

IV. Intergovernmental Relations:

What should be the division of responsibilities between federal and state governments in developing and implementing energy policies? How should regional interests be balanced against each other and against the national interest?

The basic purpose of the energy consensus is to reach agreement on:

- a. the optimum mix of energy sources the United States should use;
- b. the energy growth rate targets we deem adviseable for 1985 and 2000;
- c. the policies and regulatory actions we think necessary to bring about these (above) objectives.

"HAT LUV HAS DONE IN THE PAST ABOUT ENERGY

- 1. The 1974 national convention established an Energy Task Force (ETF).
- During its two years of existence the ETF developed an understanding of the complexities and produced publications and conferences.
- 3. In May, 1975, through ETF efforts, the national board announced the following position:
 - a. Energy conservation must be a part of any national or state energy policy;
 - b. Public understanding and cooperation are essential to the success of any program of energy conservation; citizens should be involved in the difficult choices that must be made;
 - c. Implementation of energy conservation must:
 - (1) take full account of economic consequences;
 - (2) distribute costs and hardships as fairly as possible without bearing unduly upon the poor;
 - (3) give full consideration to the environment.
 - d. Wise use of energy resources will:
 - (1) buy time to decide on other long-range energy-related policies and programs
 - (2) enable Americans to act as responsible citizens of the world community.
