#### ELECTORAL COLLEGE

On Nov. 18 and 19, the Huntington League will come to consensus on Electoral College, led by Mrs. Fred Weisberg, Chairman. The League has available a Facts & Issues and the book Who Shall Elect the President? (\$1.50, to be ordered from Mrs. Charles Hagen, 525-9227) Other interesting publications are Michener's The Presidential Lottery (at the public library and League's own copies), the May Reader's Digest resume of Mr. Michener's book and the Sept. Playboy article "How Not to Elect a President" by Senator Gaylord Nelson.

If the League is interested in changing the method of electing the President of the U.S., there are several election processes possible. The most often suggested are the following:

#### State - related:

- I The automatic plan would abolish the office of elector and put the allocation of the state's electoral votes on a winner take-all basis.
- II The proportional plan would abolish the office of elector but retain the apportionment of electoral votes to the state. Each state's electoral vote would be divided proportionally to correspond with the popular vote within the state for the various presidential nominees.
- III The district plan would retain the electoral vote allocation for each state but voters would vote in a district with one electoral vote for each district.

#### Non - state - related

The Direct Popular Vote plan would abolish the Electoral College and substitute direct vote of the people on a nationwide basis. Some plans require 40% of the national popular vote to win. Possible contingent election reform plans are a run-off election or an election in one or both houses of Congress by membership.

- I Is a change needed in the method of electing the President and Vice President of the United States?
- II If a change is made in the method of election, does your League prefer that the President be chosen by:

direct election by popular vote

- III If the method of election is changed, what provisions would your League prefer for:
  - 1. the vote necessary to elect?
  - 2. contingent elections?
  - 3. retaining the office of elector?
  - 4. requiring in the Constitution that Electors vote for the candidate on whose slate they were elected?
  - 5. distributing the electoral votes among the various candidates?
- IV If provisions for electing the President and Vice President are to be altered, what changes in the method of election does your League consider most necessary?
