

LEAGUE NATIONAL CONVENTION

Cincinnati, Ohio was the place to be during the first five days in May when two thousand women and men from across the country gathered there for the LWV National Convention. The delegates were an impressive, articulate, assertive lot, and I was to be a participant.

The convention heard fairly predictable speeches from Secretary of State Cyrus Vance and HUD Secretary Patricia Harris; however, the questioning sessions that followed were lively and informative.

In the business session, the convention decided on a nine dollar per member payment to National this year and a ten dollar one next, rather than the ten and eleven dollar payments proposed by the National Board. We also reinstated the practice of rating Senators and Congressmen on League issues, even though a few officials may misinterpret this as a League endorsement. Finally, we made it possible to become a contributing member of National League only, by paying very high dues, half of which will be returned to local Leagues.

Recounting the results of the sessions really cannot describe the atmosphere of the convention. Nevertheless, I hope that I have imparted to you the pride and purpose in organization, the commitment and idea-sharing that I experienced throughout its caucuses, workshops and business sessions.

WHAT'S A LITTLE CARBON TET AMONG FRIENDS?

Do you remember the carbon tet spills that occurred just a year or so ago, or the spills of "harmless" chemicals that have plagued our rivers and streams more recently? Does the fragrant aroma of chlorine greet you at your faucet? Do you ever wonder what else is in your drinking water? Well, don't despair. The Environmental Protection Agency has proposed some new, tough regulations, which if adopted, will give you drinking water with fewer synthetic organic chemicals.

Huntington and Charleston are the only cities in West Virginia large enough to be significantly affected by the proposed regulations. Since they will have a real impact on this community, we on the LWV water committee are especially concerned and are trying to learn all that we can about them. We've toured the Huntington Water Treatment Plant and talked to the Water Quality Supervisor, Tom Holbrook, about the regulations. Because the State will have the primary responsibility of enforcing them, we also visited Charleston to obtain the views of Robert McCall, Director of West Virginia's Department of Health, on the regulations.

SAVE THE CANAAN VALLEY

The West Virginia League of Women Voters supports the protection of the Canaan Valley and its designation as a national wildlife refuge. Allegheny Power System wishes to construct a dam for a pump storage facility, the Davis Power Project, that would create a ten-mile long lake in the Canaan Valley. Both because of the tax benefits that would accrue to the area and the recreational possibilities of the lake, many of the residents of Tucker County favor construction of the Davis Power Project.

But there is also a strong interest among residents throughout the state to protect and preserve the ecological wonderland found in the Canaan Valley. According to Dr. Robert Smith, Professor of Wildlife Management at West Virginia University, "Canaan Valley is a mosaic of northern-type bogs, beaver dams, elder and meadowsweet thickets, wet meadows, open fields and stands of northern hardwoods, spruce and balsam fir. It supports a diversity of plant and animal life unique this far south in the Appalachians."

Public hearings on whether the Canaan Valley should be designated a national wildlife refuge are scheduled in various parts of the state. Those interested in making written comments on the matter have until June 24 to submit them to
