NHO SHOULD SPONSOR THE

PRESIDENTIAL DEBATES?

That was the LWV national President Nancy Neuman's response to news that the chairmen of the Democrat and Republican National Committees hope to sponsor televised debates between their parties presidential candidates in 1933.

The parties' attempt to raid the debates creates problems for American voters and for the country. Voters need information when they vote, they need to near and see the candidates expressing their beliefs, setting out their programs, and defending them when their opponents probe and test those beliefs and programs.

What the voters don't need are debate appearances only in tightly controlled situations arranged by the candidates' campaign managers. Can we be sure that if the debates are turned over to the same people who brought us 30-second spots and the disgraceful 1986 poison-pen negative ads the public interest will be served?

Furthermore how can a substantially supported third party candidate such as John Anderson in 1980 be allowed to participate in a Democrat/Republican sponsored debate?

Since its founding in 1920, the League has been the

leading independent provider of accurate, fair and balanced information about politics and government at the local, state and national levels. As the voters' advocate, the League has more experience than any other institution in the difficult business of getting candidates to agree to and participate in debates. The League, unlike the two main political parties, has no stake in the outcome of any election. Its central purpose has been to give voters the information they need to make informed political choices.

We ask you to follow the "debate about the debates." Voice your opinion to the parties and candidates. Challenge any candidate who sells out early by agreeing to party-managed "debates."



Congressional action to limit funding for the Star Wars program and to restore and maintain US adherence to the SALT II numerical sublimits is expected soon.



Even a Little Bite of the Defense Apple Would Keep Social Service Levels Where Congress Set Them

By the end of 1987, the Department of Defense will have \$50.5 billion in unobligated funds—money which is already appropriated, but which is not needed for present DoD plans. At the same time, the administration is trying to rescind \$4.7 billion in FY87 funds for low income programs. Thus, the Pentagon's leftover money will be more than ten times the amount the White House proposes to remove from Congress' FY87 social services budget.

Editorial: AN ABSENCE OF ARATHY

The Annual Meeting of the Huntington League (Radisson Hotel, March 21) demonstrated again, in the Direction session, how intensely members care about issues, international to local.

For some it was education, and the importance of the excess levy in the March '88 election. For others it was how all social services have suffered from national cutbacks as well as West Virginia's poor economic condition.

The topic of waste — be it solid, hazardous, litter or liquid — exploded in indignation and illustrations: the bogged-down Bottle Bill ... a new litter bill in committee ... action on hazardous waste ("Watch Charleston's upcoming project to recycle hazardous waste from the home!") ... concern about styrofoam's adverse effect on the ozone layer.

The information and enthusiasm on these and other topics made for an enlightening and stimulating session. At one point, a thoughtful voice reminded us all that getting out the vote is more basic to the League's purpose than having an election's outcome confirm our position. HUNTINGTON AREA
