Nancy Taylor and Helen Gibbins registered over 90 new voters at the vocational center. The event was well promoted by personnel at the center. The League provided a listing of offices and issues which will be on the ballot. The Center would like League members to return to show the voting process. Because the League owns a voting device, we can conduct a mock election. If anyone would like to help with this project, call Nancy Taylor, 522-3361.

Have you seen the new VOTE posters, produced by the state board?

Judy Dumke, Marcia Daoust, and Helen Gibbins developed questions to go along with the ORSANCO video. We loaned the video to the school system so that the video can be copied. The video shows the Chio River--its assets, uses, and problems--and is appropriate for short programs.

Helen Gibbins spoke on "how to lobby" to a support group at Family Services and to a church women's group at Crossroads United Methodist Church.

Dianne Bady appeared on WOWK's Newsmaker show along with Roy Mundy, manager of the water company. They discussed information from the League's water survey and the Huntington Water Company's programs to protect drinking water.

The League spoke at the February Board of Education meeting in support of the Uniform School Funding Amendment. Previously Susan Ray had written all of the board members asking for their support for the amendment. The Board did agree to provide factual information about the amendment for public distribution. Susan gave a speech on the amendment at the Women's Center. She developed the "one-pager" (included in this bulletin) to be available in public places. The League permits others to duplicate the "one pager" and the fuller explanation. An explanation of the amendment has been sent to several organizations and churches with the hopes that they will use it in their newsletters. Press releases have also been sent to the media concerning absentee voting for the amendment election.

Mary Robson took voter registration cards and a League produced handout on registration to the Community Services Roundtable luncheon. She promoted post card registration of employees in the agencies, when there is a notary available. The registration handout is available for duplicating by calling Helen Gibbins, 736-3287. Post cards may be obtained in the Voter Registration Office in the courthouse, Monday through Friday until 4:30.

Rose Riter, 522-4459, will be coordinating the "Summer Fun" flyer. She needs volunteers who are willing to call recreation providers who have not responded to our letter asking them if they wish to be included in the flyer. Calls will be made in May.

NEW STUDY PROPOSED FOR LOCAL LEAGUE. Legislation has been introduced in Congress to provide improvements in children's daycare across the nation. Daycare has also become an important component of reformation of welfare programs. A state daycare alliance is being formed with local alliances being the next step. There is a need for good data at the local level. Many problems are associated with day care, such as affordability, hours convenient for parents working hours, after school care, employer-based facilities, and salaries of daycare workers. The League can help in probiding needed information to the community as well as suggesting new ways to solve daycare problems.


SEPTEMBER 20 MEETING
