### AGRICULTURE IS YOUR PROBLEM

If you think that only those who live in farming communities have an interest in federal agricultural policies, you are

You are probably concerned about one or more of these issues:

- Consumers want food prices to be reasonable.
- Those interested in the poor are especially concerned that the cost of food not cause persons to be hungry.
- Inadequate agricultural policies may increase the numbers of the rural poor.
- A poor agricultural economy reduces jobs for those who manufacture or provide services for farmers.
- The agriculture segment of the federal budget is considerable, thus contributing to the large federal deficit.
- Agriculture plays a large part of the international trade and development picture.
- Those who are concerned about the environment realize that many of modern agricultural practices are endangering our

Our study/consensus meetings in April will cover questions related to federal agricultural policies. Dianne Bady, Dorothy Fisher and Helen Gibbins will present the background information at the meetings, and League members will voice their opinions on the questions. Thus we will arrive at a consensus to be sent to the national level of the League. From the opinions of League members around the country the national League will form a position on which to take action.

The January 1988 national VOTER provides excellent background information for the agriculture study.

PREVIEW OF CONSENSUS QUESTIONS

I. The goals of federal agriculture policy should be (1) to ensure adequate supplies of food and fiber (agree or disagree); (2) to provide food and fiber at reasonable prices to consumers (agree or disagree);
(3) to allow farmers a reasonable return on their investment and labor (agree or disagree).
II-A. Evaluate whether the following selected agricultural policies are appropriate or inappropriate roles for the federal government.

Developing export markets for 1. agricultural commodities.

2. Increasing reliance on the free market to determine prices.

Encouraging sustainable agri-3. culture.

4. Controlling surpluses.

Improving the viability of midsized farms.

6. Providing research, information and technical assistance to agricultural producers.

7. Ensuring farm credit at reasonable terms and conditions.

8. Protecting farm income.

9. Stabilizing prices for farm commodities.
