Is There A Solution?

The inability to provide decent, affordable housing for our fellow citizens remains a national dilemma. Local and statewide solutions to this problem will be addressed at a special meeting to be held by the Huntington Area LWV on May 21st at 7:30 p.m. at the Enslow Park Church.

Betty Barrett, Huntington City Councilwoman and President of the Cabell-Huntington Coalition for the Homeless, will speak about local housing programs, particularly low-income and homeless concerns.

Chuck Hamsher, Director for the West Virginia Coalition for the Homeless will report on the recent Governor's Housing Conference which brought together representatives from all sectors concerning housing —— builders, architects, business leaders, state agencies and social services people. Follow up activities from this conference will also be discussed.

Come and find out about the large amount of activity surrounding housing - - low-income and homeless, as well as affordable housing for all groups, and filling the special housing needs — urban and rural, local and statewide.

Ohio River Sweep Objective

Those living in counties bordering the Ohio River, from Pittsburgh to Cairo, Illinois, will have the opportunity to clean up the shoreline of the Ohio River. Saturday, June 16 is the date for this ambitious project.

The water quality in the Ohio River has been improving for many years. But a river whose shoreline is cluttered with debris has the image that the water is dirty and polluted. The time has come to undertake an annual project of a stream bank cleanup for both safety and appearance. In 1989 more than 1,000 volunteers participated in cleaning up a 150-mile stretch of the Ohio River between Ohio and Kentucky. This year and in years to come, ORSANCO, the Ohio River Valley Water Sanitation Commission, is expanding the project to include all six Ohio River states.


